RACE COMMENTS:

Race 1	TE AROHA LIQUOR HURDLE
ABSOLUTE GEM (M Cropp) – was slow away. Pulled up prior to jumping the third to last fence.	
WHO CAN TELL (G Walsh) – jumped indifferently throughout.	
ARTIFACT (S Higgins) – jumped the second fence poorly landing awkwardly. Jumped the last three fences poorly.	
GLOBAL WARRIOR (R Cole) – landed awkwardly after jumping the fifth fence. Trainer advised Stewards that there was a small amount of blood present in the gelding's left nostril post-race. After undergoing a veterinary examination, including endoscopy, the gelding was found not to have bled.	
EYESLUCKY (C Studd) – had to steady entering the final straight when awkwardly placed on the heels of HONEY QUEEN which lay out.	
OLD COUNTESS (A Kuru) – lay out when placed under pressure in the final straight, with rider A Kuru becoming unbalanced prior to jumping the last fence.	
Race 2	CRV AMBREED LTD HURDLE
LE BON FIN (R Cole) – rider R Cole was granted permission by the Stewards to ride LE BON FIN 1.25 kg over-weight as there was no other available rider. R Cole was issued a Minor Infringement Notice and fined \$200 for failing to make the carded	

weight. Slow away.

SHARE THE BLAME (S Karnicnik) – was slow away. Fell after misjudging the second to last fence. Both horse and rider were uninjured.

YIPSON (S Fannin) – raced keenly in the early stages, and jumped the second fence poorly.

CANDIDLY (S Higgins) – jumped indifferently throughout.

PUDDLE ALLEY (M Cropp) – was retired from the event prior to jumping the third last fence.

BEVERLEY BECK (E Goodinson) - was pulled up prior to jumping the second last fence.

Race 3 | **TE AROHA STALLION PLACEMENT SCHEME 1000**

FERRANDO (R Elliot) – began awkwardly shifting in making firm contact with SHESALLRAAJ.

DOUGIE (T Thornton) – began awkwardly.

LEGSTODIEFOR (M Du Plessis) – began awkwardly, and then raced greenly through the early stages.

STEVIE'S SURPRISE (Z Nor Azman) – lay out under pressure in the final straight finishing wide on the track.

Race 4 | **NZ FARMERS LIVESTOCK LTD 1000**

SALLY LUNN (R Elliot) – became fractious making contact with the front of the starting stall, and after undergoing a veterinary inspection was found to have suffer a laceration to the inside of the left nostril. SALLY LUNN was declared a late scratching at 2:05 pm.

SOWNIN (V Gatu) – was slow away.

Race 5 | **KAISER AG LTD STEEPLECHASE**

RED MOSS (S Fannin) – landed awkwardly after jumping the first fence hampering KINA WIN. Blundered badly on landing after jumping the fourth fence with rider S Fannin becoming unbalanced. Hampered as a result was WEST END.

KINA WIN (A Kuru) – hampered after jumping the first fence.

CANTDOWITHOUTIT (R Cole) – jumped indifferently throughout, was not persevered with after jumping the fence near the 1000 metres.

LUCKY CHARM (M Cropp) – steadied when placed in restricted room to the inside of KINGS KITE (G Walsh) which shifted in approaching the 500 metres. G Walsh was issued with a warning. Stumbled badly after jumping the final fence.

KINGS KITE (G Walsh) – landed awkwardly after jumping the second to last fence. Ran down the last fence.

MR BROWN (S Karnicnik) – knuckled on landing after jumping the second to last fence and fell – both horse and rider were uninjured.

Race 6 | **KAISER NZ OPEN STEEPLECHASE**

RANGATIRA (W Gordon) – dipped badly on landing after jumping the first fence. Jumped the second and third fences poorly. Landed awkwardly after jumping the final fence.

GOOSEBUMPS (M Gillies) – lost the left hind plate during the running.

NELLS BELLE (E Goodinson) – put in a poor jump at the third to last fence when well back, and was not persevered with for the remainder of the race. When questioned regarding the performance rider E Goodinson advised Stewards that the mare had felt indifferent in its action, and had never travelled comfortably throughout. A post-race veterinary examination of the mare revealed an upper leg muscle injury to the right hind leg. Connections were advised that a veterinary clearance would be required prior to racing next.

TWENTYTHIRTYFOUR (S Fannin) – faltered passing the 900 metres, and was pulled up by its rider. After being attended to

by the veterinarian the gelding was found to have sustained a fracture to the near hind leg and was humanely euthanased.

Race 7 | **NICHOLSON UNITED AUTOS 1400**

CAMBERS (S Collett) – began awkwardly.

PALACIO (C Grylls) – stumbled on jumping away.

SOUTHERN PRINCESS (R Elliot) – raced keenly when being restrained approaching the 1000 metres. Lay out when placed under pressure in the final straight.

GOOD VIBES (A Collett) – lay out when placed under pressure in the final straight.

IRINA (M Du Plessis) – when questioned regarding the performance rider M Du Plessis advised Stewards that the mare had not been entirely suited by today's track conditions, and would benefit from a step-up in distance.

Race 8 | **TE AROHA SUPPORTERS CLUB 1600**

PRESIDENT TOMADO (C Grylls)- Rider C Grylls was unable to make the carded weight for **PRESIDENT TOMADO** and was fined \$100. C Grylls was replaced by K McCulloch. Attempted to get out under the front of its starting stall. The gelding was removed and underwent a veterinary inspection and was declared a late scratching at 4.17 pm. The connections were advised that the gelding must trial to the satisfaction of Stewards prior to racing next.

DELUXE EDITION (C Lammas) – crowded on jumping away, losing ground.

CLASSIC WARRIOR (L Magorrian) – raced ungenerously in the early stages.

EMBRACEABLE YOU (A Collett) – lay out under pressure in the final straight.
