RACE COMMENTS:

Race 1 LOWE SCHOLLUM & JONES 2100

RHIANNON (S Weatherley) – held up and bumped with GERONIMO near the 800 metres when mounting a run.

FINAL ROSE (E Farr) – tightened at start when runners either side shifted ground.

Gave ground near 800 metres and was eased out of the event in the home straight and pulled up. A post-race veterinary inspection revealed lameness in the left foreleg.

IFF SO HAPPENS (D Hirini) - hung throughout placing the rider at a disadvantage. Trainer advised the mare must trial before next racing.

SALVINIA (N Teeluck) – raced greenly throughout. Lost near hind plate during the running.

Race 2 PURPLE HAZE LAVENDER CAFÉ 1600

TRACK STAR (T Johnson) – slow away. Hampered near 250m then had to be steadied away from the heels of the tiring MOWITZA.

TRISHA LEA (D Bradley) -squeezed shortly after the start and settled back. Held up near 200m prior to being angled inward to improve.

MOWITZA (D Turner) – hung throughout. Connections advised gelding must trial before next racing. Co-trainer G Lowry advised MOWITZA will no longer be a racing proposition from his stable.

STAGE DIVING (S Weatherley) – raced ungenerously passing the 1400 when wide and without cover. Continued to race wide without cover throughout.

ALFIE DEE (N Teeluck) – ducked out abruptly near the 100 metres.

PATHFINDER (Te Baker) – momentarily held up near the 250 metres.

BERTRAM (H Tinsley) – rider could offer no excuses for the disappointing performance.

Race 3 THE MEAT COMPANY DANNEVIRKE 1600

AMORATA (M Tanaka) – vet clearance at start after contacting the running rail during preliminary. Checked at start when MIZ OLDFIELDS ROAD angled in sharply.

EM KAY POPS (E Farr) – stood in gates at start and lost ground (7 lengths).

LUCQUIDE (H Andrew) – rolled in under pressure inside the final 100 metres.

AVASTIN (J Parkes) – attempted to buck shortly after the start and then commenced to over-race until near the 1200 metres. Trainer advised that a warning would be placed on the mare's racing manners.

WALNUT (H Tinsley) - checked at start when MIZ OLDFIELDS ROAD angled in sharply.

MIZ OLDFIELDS ROAD (C Waddell) – angled in sharply shortly after the start. Commenced to over-race shortly after shifting ground outward as a result.

C Waddell (MIZ OLDFIELDS ROAD) admitted a charge of careless riding under Rule 638 (1) (d) after she angled her mount in shortly after the start and caused a check to both WALNUT and AMORATA both of which were racing to the inside. After considering all evidence the JCA suspended Ms Waddell's licence to ride in races from the close of racing on Thursday 27 October 2016 up to and including racing on Thursday 10 November 2016 (3 days)

Race 4 ROLY ELLIS 1400

BATTLE CREEK (C Waddell) – ducked in sharply near the 600 metres when struck with the whip.

LIPSTICK (H Andrew) - checked when angled off the heels of BATTLE CREEK near the 600 metres which rolled in.

GLORY DAYS (J Parkes) – checked off the heels of LIPSTICK near the 600 metres when that runner was checked by BATTLE CREEK.

C Waddell (BATTLE CREEK) was spoken to in the presence of her employer Mr G Haigh after her mount shifted in sharply when struck with the whip near the 600 metres and advised that she is expected to maintain greater care when using the whip in similar circumstances.

FUSION (D Hirini) – raced four wide throughout

Race 5 PGG WRIGHTSON 1400

TERRAPLANE (M Tanaka) – tightened at the start and settled back

MISS NORWAY (R Myers) – slow away

GLORIOS (D Turner) – over-raced in the early stages.

SUPERVELOCE (H Tinsley) - raced wide throughout

MANIC MONDAY (T Johnson) – raced erratically and hung outwards throughout. Near the 500 metres, restrained off the heels of a runner ahead and in doing so shifted out abruptly into the line of SNEAKING SUSPICION C Waddell which clipped heels and fell. Investigations by Stewards revealed that the erratic racing pattern of MANIC MONDAY in shifting out abruptly was the cause of the fall and were of the view that the riding of T Johnson could not be held solely responsible. T Johnson confirmed his mount hung badly throughout and shifted out further than he intended when restrained off heels. Trainer A Fieldes was advised the gelding must trial before next starting. He in turn advised that its future as a racing proposition would now be re-considered.

SNEAKING SUSPICION (C Waddell) – fell near the 300 metres after clipping the heels of MANIC MONDAY which had shifted out into its line of running. C Waddell was attended to by paramedics and was uninjured. SNEAKING SUSPICION suffered minor lacerations to the left foreleg and was treated by a veterinary surgeon at the course.

Race 6 TONY SEWART MAX TARR 1200

HANDFULL (M Tanaka)- ambled out of the barrier and refused to gallop competitively for the duration of the event. Trainer S Brown advised that the gelding had not shown such tendencies at trials or jumpouts prior to this raceday start and offered that today being the first time in blinkers may have attributed to the behavior. He was advised that a warning would be placed on the racing manners of HANDFULL and the gelding would now be required to trial prior to next racing.

LAIRD OF DELGATIE (J Parkes) – When questioned into the run of the gelding which finished off the race disappointingly after racing in a forward position throughout, J Parkes advised the gelding may have a respiratory issue. A post race veterinary inspection was clear.

BEKAN (L Hemi) – proved difficult to load. Trainer was advised that a warning would be placed regarding the barrier manners of BEKAN. Trainer S Brown advised that the gelding was unlikely to be persevered with as a racing proposition.

MAGIC INCANTO (N Teeluck) – over raced in the middle stages and steadied off heels near the 400 metres.

PROSECCO (D Hirini) was held up for some distance passing the home turn.

R Goldsbury (PINSONELLA) - admitted a charge of unnecessary use of the whip on a horse out of contention under Rule 638 (3) (b) (i) and was suspended from race riding from the close of racing on Thursday 27 October 2016 until the close of racing on Tuesday 1 November 2016. (2 days)

Race 7 NEW CENTRAL MOTOR INN 1200

SHARED SECRETS (T Johnson) – raced greenly throughout. When rider T Johnson was questioned he considered the filly would appreciate a further distance than the 1200 of today's event.

LAST SAMURAI (N Teeluck) – slow away.

SASERELLO (D Turner) – raced wide throughout.

Race 8 LLOYD DODSON & PRINGLE 1100

DR WATSON (D Hirini) tightened at the start and was slow away as a consequence.

TIGGER TAHNEE (D Turner) – over-raced in the middle stages when wide without cover then finished some distance adrift of the field after being eased down prior to the winning post. D Turner did not persevere with riding the gelding out as he had concerns with its action. A post-race veterinary examination revealed no abnormality.

Race 9 ALL DIAMONDS ZEDACE SYNDICATE 2100

RODS LINCOLN (D Bradley) - Slow away. D Bradley was issued with a warning for unnecessary use of the whip on a horse out of contention.

MAITRE DU JEU (R Hannam) – raced wide without cover throughout.

BELLA'S DELIGHT (M Singh) – shifted out under hard riding near the 250 metres severely crowding RED MAFIA which was dictated outward into the line of ANTONIO which was checked. BELLA'S DELIGHT continued to shift out further dictating RED MAFIA wider on the track over the final stages. Stewards lodged a protest against the winner BELLA'S DELIGHT alleging interference to the second placed RED MAFIA. The JCA upheld the protest and relegated BELLA'S DELIGHT to second placing, promoting RED MAFIA to first placing. Placings now read 3-7-13-6.

M Singh admitted a charge of breaching Rule 638 (1) (d) and had his licence suspended from the close of racing on Saturday 29 October 2016 until the close of racing on Friday 25 November 2016 (7 CD days).

RED MAFIA (E Farr) – dictated out in the final straight. Struck with the whip on two occasions in the final straight.

SKYBIRD (J Parkes) – hampered in the home straight when BELLA'S DELIGHT shifted out.

Race 10 TOI FLAT 1600

LOVETOKEEPHIM (D Turner) was slow away after being tightened by runners on either side and then raced wide. D Turner reported that after being slow away and caught wide in the back straight the gelding had little in reserve when placed under pressure in the final straight.

JUMP FOR JOY (H Andrew) – had to steady into the first turn when on the heels of **TRONIC ROSE** (T Johnson) which shifted ground.

A RED PRINCE (J Parkes) – wide throughout and disappointed. Trainer advised that the gelding will be retired

BROWN GIRL (R Myers) – raced poorly. Rider could offer no excuses for a disappointing performance.
