Race 4 SEALES WINSLOW HANDICAP (1200 metres)

Trainer T Bambry advised Stewards that he was satisfied with the recovery of ENCHANTING SECRET following its performance in this race, adding that it is his intention to continue on with its current preparation.

Race 7 NUFARM HANDICAP (1400 metres)

Trainer K Gray advised Stewards that ALL IN LUCK has been sent for a brief spell following its performance in this race.

Racing Tauranga -12 November 2016

Race 5 DOMINATOR GARAGE DOORS TAURANGA 1200

Trainer T Pike advised Stewards that in the days following its performance in this race ABADDON underwent a veterinary examination which did not reveal any abnormality, adding that he would be looking to start the gelding next on a firmer track.

Race 6 PRESTON ROWE PATERSON PROPERTY VALUERS TAURANGA STAKES

Trainer A Forsman advised Stewards that MIME underwent a veterinary examination in the days following its performance in this race which did not reveal any abnormality. Mr Forsman added that it was their intention to continue on with the mare's current preparation.

Race 7 VERTICAL HORIZONZ GROUP 1600

Trainer J Millar advised Stewards that she was satisfied with the recovery of TE HANA following its performance in this race and it is her intention to continue on with the mare's current preparation.

RACE COMMENTS:

Race 1 Avondale Maiden (2200 metres)

LONE WARRIOR (S Spratt) – Began awkwardly losing ground. Commenced to hang out badly when being restrained in the early stages, shifting out passing the 1800 metres and hampering TAMA AKARANA and CARTRIDGE which were both forced wider on the track. Becoming tailed off passing the 500 metres and was not persevered with in the final straight. When questioned rider was unable to offer any reason for the gelding's performance.

TAMA AKARANA (Z Nor Azman) – Hampered 1800 metres.

CARTRIDGE (M Vance) - Hampered 1800 metres.

RAY'S LEGACY (M McNab) - Began awkwardly.

LAEKEEPER (L Satherley) – Had to be firmly restrained when becoming awkwardly placed on the heels of ACEDECEE which shifted in passing the 1800 metres with LAEKEEPER having to shift out taking AMAZING LADY wider on the track.

RIVERLEA (L Innes) – Crowded and hampered to the inside of BELLA ROCCIA (A Collett) which shifted in near the 1700 metres. Rider A Collett was advised to exercise care.

WHOPPER'S (S Collett) - Raced wide for the majority of the race. Lay out under pressure in the final straight.

BELLA ROCCIA (A Collett) – Had to be firmly restrained when crowded to the outside of RAY'S LEGACY which shifted out to obtain clear running passing the 400 metres. Rider M McNab admitted a breach of careless riding under Rule 638(1)(d) and was suspended from the conclusion of racing on Saturday 19 November 2016 until the conclusion of racing on Saturday 26 November 2016, 5 riding days. BELLA ROCCIA had to be checked near the 200 metres when crowded to the inside of TAMA AKARANA (Z Nor Azman) which shifted to the inside of RIVERLEA to obtain clear running which was shifting in under pressure. Apprentice Rider Z Nor Azman was issued with a warning.

Race 2 AJC Members Maiden (1200 metres)

EXHIBITION (M McNab) – Began awkwardly after being restless in its barrier. Inconvenienced 900 metres.

NOTHINGLEFTTOLOSE (D Johnson) – Began awkwardly losing ground.

THE KRAKEN (M Du Plessis) – Raced in restricted room shortly after leaving the barriers.

KHORABELLA (K McCulloch) – Raced ungenerously when being restrained in the early stages making the bend awkwardly near the 900 metres inconveniencing EXHIBITION. Had some difficulty obtaining clear running early in the final straight.

NAKYAMA (S Spratt) – Raced ungenerously when being restrained in the early stages.

IRISH MISSILE (A Collett) – Raced wide without cover throughout.

BRUCE ARTHUR (S Collett) – Raced ungenerously when being steadied passing the 1000 metres. Shifted out to obtain clear running approaching the 200 metres crowding NAKYAMA which raced in restricted room and had to be briefly steadied. Contributing was slight inward movement from IRISH MISSILE. S Collett was advised to exercise care when shifting ground.

Race 3 Avondale JC On Facebook Maiden (1200 metres)

FLAVOURING (R Elliot) – Became fractious in its barrier stall and was removed to undergo a veterinary examination and was late scratched at 1.22pm.

KIWI KASHBAO (S Collett) – Late scratched at 1.24pm after refusing to enter the barrier stalls. Co-trainer C Gibbs was advised that the colt would be required to trial to the satisfaction of Stewards prior to racing again.

FENDALTON (A Jones) – Crowded shortly after leaving the barriers. Lost the right hind plate during the running.

FORTIUS (S McKay) – Raced ungenerously when being restrained in the early stages. Held up entering the final straight.

SHARP PROPOSITION (M Coleman) - Raced wide without cover throughout.

ESSENCE OF COOL (M Hills) – Had some difficulty obtaining clear running early in the final straight when racing in restricted room.

SWISSTA (A Collett) – Made brief contact with MAESTRO MAX passing the 50 metres.

Race 4 AJC.CO.NZ Maiden

MOLLY POND (C Grylls) – Began awkwardly losing ground.

UABASSO (S McKay) – Began awkwardly losing ground. Badly hampered 900 metres. Raced wide for the majority of the event.

SERAPHIM (D Johnson) - Hampered when leaving the barriers by PRINCESS DILLON which shifted out.

HAUTE COUTURE (M McNab) – Raced ungenerously when being restrained in the early stages.

PRINCESS DILLON (V Colgan) – Commenced to race ungenerously passing the 900 metres getting its head up and shifting out making the bend awkwardly despite the efforts of its rider hampering FASTNET FIRE when becoming awkwardly placed on the heels of MANDILARIA which had to be firmly restrained. PRINCESS DILLON continued to shift out over that runner's heels badly hampering UABASSO. Rider V Colgan advised that the mare had hung badly throughout and could not be persevered with over the final 400 metres.

FASTNET FIRE (M Cameron) – Hampered 950 metres. Lay in early in the final straight having difficulty obtaining clear running until passing the 300 metres.

MANDILARIA (B R Jones) – Firmly restrained 950 metres.

THE REBEL KNIGHT (T Thornton) – Raced in restricted room until passing the 300 metres.

Race 5 IRT Maiden (1400 metres)

HEZAROCK (M Hills) – Began awkwardly losing ground.

CHARLES ROAD (C Grylls) - Slow to begin (2L).

EQUILIBRIUM (A Collett) – Commenced to race ungenerously when being steadied in the early stages making the bend awkwardly passing the 800 metres shifting back on to TIME TO CELEBRATE which was hampered, shifting back on to COMIN'THROUGH and YAMAGEE.

TIME TO CELEBRATE (M McNab) - Hampered 800 metres.

COMIN'THROUGH (S Collett) – Hampered 800 metres.

YAMAGEE (K McCulloch) - Hampered 800 metres.

THE MELLO WAY (S Spratt) – Raced wide without cover throughout. Briefly crowded passing the 200 metres.

CHARLES ROAD (C Grylls) – Lay in entering the final straight becoming awkwardly placed on the heels of SAVE THE DATE and continued to lay in for the remainder of the race.

Race 6 Waterview Maiden (1400 metres)

NOVA INCANTO (S Collett) – Underwent a veterinary examination following the race which revealed the horse to have suffered cardiac arrhythmia with a veterinary clearance required prior to racing again.

Race 7 Next Meeting @ Avondale 25 January 2100

SON TAARI (A Collett) – Began awkwardly losing ground.

FORT STREET DANCER (L Satherley) – Began awkwardly losing ground. Raced keenly when being steadied in the early stages.

CHATEAU FIONN (M Hills) – Knuckled when leaving the barriers losing ground.

DANIECE (T Thornton) – Required veterinary attention following the race as it was in a distressed condition.

Race 8 West Brook Winery 2100

SOUTHERN DANCER (S Collett) – Late scratched at 8.01am due to communication issues.

ROUGH CUT (S Spratt) – Removed from the barriers after becoming fractious and was cleared fit to race.

MIDNIGHT MISTRESS (M Hills) – Began awkwardly losing ground.

BATTLEFIELD (Z Nor Azman) – Began awkwardly losing ground.

MANDALAY (T Thornton) – Raced in restricted room shortly after leaving the barriers. Had to shift ground inwards when becoming awkwardly placed on the heels of VARRO which shifted out approaching the 200 metres. As a result STREET SMART shifted away from MANDALAY inconveniencing CRITICS CHOICE.

CRITICS CHOICE (C Dell) – Inconvenienced 200 metres.

STREET SMART (M Cameron) – Raced in restricted room passing the 1700 metres getting its head up for a short distance. Underwent a post race veterinary examination which revealed no apparent abnormalities. When questioned, the rider advised that the gelding was not happy in the existing track conditions.

Race 9 Magness The Mighty Steam Train 1200

SUGGESTIVE HEIGHTS (L Satherley) – Dislodged its rider during the preliminary and after being recaptured SUGGESTIVE HEIGHTS was declared a late scratching on veterinary advice at 4.15pm.

BELIAL (D Prastiyou) - Inconvenienced passing the 400 metres by SABER which shifted out.

Race 10 Goodwin Property Management Maiden (1600 metres)

HEAD OFFICE (D Prastiyou) – Became fractious in the barriers and was removed to undergo a veterinary examination and was passed fit to race. Over-raced passing the 1200 metres.

DUKE OF OZ (S Collett) – Slow away.

EL FORTUNA (C Lammas) – Raced keenly when in restricted room passing the 1000 metres.

NIPABRANDY (L Satherley) – Shifted out passing the 300 metres inconveniencing QUEENSTOWN. **L Satherley** admitted a breach of Rule 638(3)(b)(ii) for excessive use of the whip prior to the 200 metres and was suspended from the conclusion of racing today 15 November 2016 up to and including Sunday 20 November 2016, 3 riding days.

QUEENSTOWN (BR Jones) – Inconvenienced 300 metres.
