Race 7 TOM ANDREWS CONTRACTING/THE BOLD ONE @ GW STUD (1200 metres)
A CHAN (ROCK NOIR) – was charged under Rule 638 (3) (b) (ii) in that he used his whip excessively on his mount ROCK NOIR prior to the 200 metres. After hearing submissions and viewing video footage the Judicial Committee dismissed the charge against Mr Chan.

RACE COMMENTS:

Race 1	GIRLS GO RACING MDN (1100 metres)
<p>CORROSIVE (J Parkes) – slow to begin.</p> <p>LECTIO DIVINIA (R Hannam) – slow to begin.</p> <p>DELTA DE LAGO (C Grylls) – Stewards granted Trainer A Scott permission to race the mare without the notified blinkers due to an office error. Lost the left front plate during the running.</p>	

ALAMCFERSON (M McNab) – raced keenly when restrained passing the 800 metres. Came together for a distance with **CHESTER CARLSON** near the 250 metres.

CHESTER CARLSON (R Myers) – Stewards granted Trainer P Shailer permission to race the gelding without the declared side winkers. Came together with **ALAMCFERSON** for some distance near the 250 metres.

Race 2	ANTON MORA & SONS PAINTERS 3YO (1100 metres)

FASCINO LASS (R Hannam) – jumped away awkwardly making firm contact with **SUMMERFLY** becoming unbalanced.

SUMMERFLY (T Johnson) – jumped away awkwardly making firm contact with **FASCINO LASS** becoming unbalanced. Made the bend near the 800 metres awkwardly shifting out forcing **MIALIGN** wider.

MADAM BULLBARS (R Elliot) – knuckled badly on jumping away dislodging apprentice rider R Elliot, hampered as a result was **LADY JASMINE** and **CRAFTY JESS**. Underwent a post race veterinary examination which revealed the mare to have a small abrasion on the left hip. Apprentice R Elliot was uninjured.

LADY JASMINE (M Cameron) – hampered shortly after the start.

CRAFTY JESS (C Grylls) – hampered shortly after the start.

MIALIGN (A Chan) – got its head up and raced ungenerously in the early stages. Forced wider 800 metres. Raced greenly when placed under pressure in the final straight.

FIFTYSHADESOF PINK (J Parkes) – slow to begin.

Race 3	STELLA ARTOIS (1400 metres)

LAY OFF (A Chan) – jumped away awkwardly making firm contact with **REGAL HARMONY**, losing ground. Had to be steadied when awkwardly placed on heels near the 600 metres.

REGAL HARMONY (J Parkes) – jumped away awkwardly making firm contact with **LAY OFF** leaving the barrier losing ground

SHE'S A ROCK (R Goldsbury) – slow to begin.

CHILLI MILLI (J Fawcett) – raced wide without cover throughout. When questioned regarding the performance of the mare rider apprentice J Fawcett advised Stewards that the mare had lay out badly during the running placing her at a disadvantage.

BEAR GRYLS (L Hemi) – Had some difficulty obtaining clear running in the final straight before shifting ground outwards passing the 100 metres.

Race 4	WAIKATO EQUINE VETERINARY CENTRE 3YO (1400 metres)

JIMMY VITAL (M McNab) – jumped away awkwardly shifting out abruptly.

ALMO STREET (S Weatherley) – slow to begin. Had to be firmly restrained when improving on to heels passing the 1200 metres.

SPONDULIX (J Parkes) – commenced to over race passing the 1200 metres before improving forward to lead.

PRIMROSE (M Cameron) – when questioned regarding the performance of PRIMROSE rider M Cameron stated that the mare had felt indifferent in its action throughout. Lost the left front plate during the running. A post race veterinary examination did not reveal any abnormality.

IMRAN (E Farr) – raced three wide without cover throughout. Lay in when placed under pressure in the final straight making slight contact with PINCANTO passing the 100 metres which shifted out slightly.

PINCANTO (C Grylls) – held up rounding the bend before shifting outwards to obtain clear running in the final straight.

Race 5	R J EAGAR FURNISHING MDN (1400 metres)

I'M BRONSON (A Jones) – raced in restricted room shortly after the start. Got its head up over racing when the pace steadied shifting out making contact with KEEPERINMIND, and continued to over race through the early and middle stages.

KEEPHERINMIND (S Weatherley) – I'M BRONSON shifted out abruptly when being restrained making firm contact with KEEPERINMIND near the 1200 metres. Lay in when struck with the whip passing the 300 metres.

VICTORIAS LEGACY (A Chan) – a post race veterinary examination did not reveal any abnormality.

Race 6	LA NUOVA APPARELMASTER 1800

ZAMBEZI WARRIOR (M Cameron) – got its head up passing the 1200 metres when being firmly restrained off heels when the pace steadied.

NOTABADROOSTER (E Farr) – was inclined to layout throughout the running and passing the 800 metres ran wide forcing NITRO TED outwards. NOTABADROOSTER must trial left handed to the satisfaction of Stewards prior to racing left handed again.

NITRO TED (T Johnson) – forced wider by NOTABADROOSTER which was laying out rounding the final bend.

Race 7	THE WATERFRONT HOTEL (1800 metres)

ALARMIST (R Myers) – was crowded shortly after the start having to be steadied.

CHONNEY (L Hemi) – raced keenly in the middle stages.

M McNab (LEDBURY) – admitted a breach of careless riding under Rule 638(1)(d) in that he allowed his mount to shift inwards when not sufficiently clear of JOLT (J Riddell) which was checked passing the 50 metres. After submissions Jockey M McNab had his licence to ride suspended from the close of racing on 26-11-16 to the close of racing on 4-12-16 (5 days).

JOLT (J Riddell) – checked when placed in restricted room near the 50 metres. Payment was with-held until connections of the 5th place JOLT had viewed the video footage in relation to lodging an objection against the 3rd place LEDBURY before electing not to proceed.

QUEENSLAND (M CAMERON) – Steadied when placed in restricted room by LEDBURY which shifted out when being corrected near the 50 metres.

<p>GYPSY VERSE (M McNab) – slow to begin.</p> <p>BROTHER ONE (D Bradley) – was crowded shortly after the start having to be steadied. Steadied when awkwardly placed on heels near the 1600 metres.</p> <p>ROCFIVE (D Turner) – raced keenly when being restrained passing the 1600 metres.</p> <p>BAYMAX (Z Azman) – lay out rounding the first bend.</p> <p>JIGSAW JANE (S Weatherley) – lay in when placed under pressure in the final straight.</p> <p>SHOCK HORROR (C Grylls) – Required post race veterinary attention to a laceration to the left hind leg.</p>
