#### RACE COMMENTS:

Race 1 OTAGO DAILY TIMES / HARBOUR FISH / SPEIGHTS BM R65 1975m

HARDY'S REVENGE (P Shaikh) - Made the first bend awkwardly.

**PRECIOUS PERCY** (C Johnson) – Keen early stages. When spoken to regarding the performance of favourite rider C Johnson advised that the gelding had failed to respond when put under pressure and had been disappointing.

KARAYAH (G Jogoo) – Made the crossing by the 1400 metres awkwardly and had to be steadied off heels at this point.

THE ENERGIZER (K Kalychurun) – Raced wide from the 1200 metres

LADY LINDAUER (K Mudhoo) - Raced wide from the 800 metres.

## Race 2 HOPE & SONS FUNERAL DIRECTORS / RICHARD TEMPLETON BM R65 1250m

ALOTTATOW (C Barnes) - Raced wide throughout.

FLYTIME (R Cuneen) - Raced wide throughout.

**JOHNNY JONES** (G Jogoo) – Held up momentarily rounding the final bend.

**EL BEE DARCI** (K Mudhoo) – Lay in early in the run home having to be straightened at the 350 metres.

#### Race 3 CARGILL CONTRACTING / BLUESKIN NURSERIES / PURE SERVICES MDN 1250m

Trainers J and J Gordon were fined \$50 after they were allowed to remove the blinkers that were declared for LEILA EVE.

There was a delay to the start of this event when LEILA EVE proved very difficult to load. The connections were advised LEILA EVE was placed on a barrier manners warning.

**SLAMMER** (J Lowry) – Slow to begin. Brushed rail and became awkward in its action momentarily passing the 450 metres.

GALISINI (C Barnes) – Began awkwardly shifting out forcing AUGUSTACE outwards onto JANEFIELD JEWEL who lost ground.

**MINUE** (L Callaway) – Crowded at the start losing ground.

**AUGUSTACE** (T Moseley) – Raced keenly early stages and had to be steadied off heels of SENSEI (S Wynne) who shifted in at this point. Rider S Wynne was advised to exercise care.

**HEE'S OUR SECRET** (K Kalychurun) – Raced keenly for several strides passing the 900 metres and had to be steadied at this point and raced wide for the majority of the event. Lay out rounding the final bend taking HIGHER AUTHORITY wider on the track. Lay inwards across heels passing the 350 metres and had to be steadied then raced in restricted room until inside the final 100 metres.

**BRUNELLO** (C Johnson) – When spoken to regarding the disappointing performance rider C Johnson could offer no tangible excuses.

## Race 4 EAST OTAGO TRANSPORT / COOKE HOWLISON HYUNDAI BM R75 1975m

**VERNA AUDREY** (G Jogoo) – Shifted outwards at the start crowding outside runner. Crowded passing 1700 metres when CONSOLIDATE (T Moseley) shifted in. Rider T Moseley was advised to exercise greater care. Then began to race fiercely through the early stages and became awkwardly placed on the heels of PATRICK ERIN passing the 1600 metres. Continued to race keenly through the early and middle stages and wide for the majority of the event.

**LUKANDER** (P Shaikh) – Crowded at the start losing ground. Taken forward to lead passing 1000 metres. Shifted inwards passing the 125 metres crowding and checking GALLANT DEFENDER. Rider P Shaikh admitted a breach of Rule 638(1)(d). After viewing the films and hearing submissions the JCA imposed a suspension from the end of racing on 5<sup>th</sup> January 2017 up to and including 11<sup>th</sup> January 2017.

**GALLANT DEFENDER** (S Muniandy) – Crowded and checked passing 125 metres.

**KEEP THE COURAGE** (S Wahab) – Had to be steadied passing the 1200 metres when improving quickly onto the heels of CONSOLIDATE.

**QUARTET** (C Barnes) – Gave ground from the 800 metres finishing a distant last. A post-race veterinary examination revealed no abnormalities. The connections advised they will be considering its racing future.

PATRICK ERIN (J Lowry) – Lay in passing the 150 metres and had to be straightened.

### Race 5 FOUR SQUARE PALMERSTON / SKEVINGTONS MAIDEN 1975m

MISTY TRELLA (S Wynne) – Began awkwardly. Crowded and had to steady at 650 metres and again at 550 metres when ALLAQUILA shifted in.

**SILVER SPIER** (S Muniandy) – Began awkwardly. Crowded and checked when POROTENE RIPPA was dictated inwards by MISTY TRELLA (S Wynne) which shifted in passing the 1500 metres. S Wynne admitted a breach of Rule 638(1)(d) careless riding. After viewing the films and hearing submissions the JCA imposed a suspension of Miss Wynne's licence from the 4<sup>th</sup> of January 2017 up to and including the 12<sup>th</sup> of January 2017 (4 Days) and in addition was fined \$600. Shifted in abruptly passing the 300 metres and had to be straightened. Held up through the middle part of the run home gaining clear racing room inside the final 150 metres.

**POROTENE RIPPA** (R Firdhaus) – Crowded and forced inwards at 1500 metres.

HOLY MACKEREL (L Callaway) – Raced wide throughout. Also crowded momentarily at 100 metres having to steady.

**ALLAQUILA** (P Shaikh) – Dipped shortly after the start losing ground. Improved wide from the 1200 metres. Shifted in passing 650 metres crowding and checking LIN which had to check outwards taking PENNY PERFECT and VELVET ROSE wider on the track. Continued to shift inwards hampering MISTY TRELLA who had to steady. P Shaikh admitted a breach of Rule 638(1)(d) careless riding. After viewing the films and hearing submissions the JCA imposed a suspension from 12<sup>th</sup> January 2017 up to and including 21<sup>st</sup> of January 2017 (2 Days).

**VELVET ROSE** (T Moseley) – Forced wider on track at 650 metres.

**LIN** (G Jogoo) – Crowded and checked at 650 metres when ALLAQUILA shifted in when not sufficiently clear. Also crowded at this point was MISTY TRELLA. Also crowded at 100 metres when PENNY PERFECT who was laying in shifted in.

**PENNY PERFECT** (R Cuneen) – Forced wider on trach at 650 metres. Lay in passing 100 metres and had to be straightened.

MISTER DENNIS (S Wahab) – Dislodged rider after winning post. Neither horse nor rider was injured in this incident.

#### Race 6 COOLMORE AUSTRALIA WAIKOUAITI CUP 1975m

**REVELATOR** (K Mudhoo) – Momentarily crowded at 200 metres when ZHANIM (K Williams) lay inwards. K Williams was advised to exercise care.

**PRINCESS BROOK** (C Barnes) – When spoken to regarding performance rider C Barnes advised in her opinion the mare had not backed up from its race last Monday.

**SOUTHERN SAV** (S Wynne) – Rider reported may have been sore on returning to the Birdcage. A post-race veterinary inspection revealed no abnormalities.

**KAHARAU** (T Moseley) – Treated for colic post-race.

## Race 7 PGG WRIGHTSON / BRENT LUCAS BUILDERS BM R85 1250m

**FASTFOOT** (T Moseley) – Slow to begin.

**ALL SPICE** (K Kalychurun) – Began awkwardly losing ground. Awkwardly placed on heels at the 300 metres having to shift ground outwards to find clear racing room and again at the 150 metres had to shift wider.

#### Race 8 NZB INSURANCE PEARL SERIES RACE 1250m

**CARMENIZE** (P Shaikh) – Bounded at the start losing ground. Raced keenly early stages and had to be steadied off heels passing the 800 metres.

**PASSITO** (C Johnson) – Raced very keenly through the early stages with the saddle moving forward passing the 1000 metres placing rider C Johnson in difficulty for some distance. Shifted outwards passing 700 metres crowding outside runners. Saddle repositioned on final bend.

**POPP 'N' LINDAUER** (J Lowry) – Wide for the majority of the race. Buffeted by inside runners passing the 700 metres.

**SUNFLOWER** (K Mudhoo) – Buffeted by inside runners passing the 700 metres.

MIA MAMMA (G Jogoo) – Lay in throughout the run home.

**PRINCESS ATHENA** (R Yatim) – Had to be shifted outwards across heels passing the 250 metres to find clear racing room.

**FADE TO GREY** (S Wynne) – A post-race veterinary inspection revealed an injury to the right hind fetlock.
