Farr) shifted in. E Farr was advised to exercise care.

ST MALO (L Callaway) – Crowded passing 500 metres when FLORENCE IVY lay inwards momentarily. Had to steady at 300 metres when held up by the tiring HAY CHIC. Again had to steady at 200 metres when THREE SHOTS shifted inwards, then raced in restricted room over the concluding stages.

THREE SHOTS (R Yatim) – Over raced in the early stages. Shifted in when struck with the whip at the 200 metres inconveniencing ST MALO. R Yatim was issued with a warning under Rule 638(1)(d) Careless Riding.

SHOWYOUHOW (K Kalychurun) – Rider reported favoured runner had failed to handle today's heavy track.

Race 2 GREYMOUTH STAR RATING 65 1500M

HOVER (S MacNab) - Was very fractious in its stall and reared as the start was made hitting its head on the top of the starting gates, losing several lengths. The connections were advised that the gelding was placed on a barriers manner warning. Stewards ordered a post-race veterinary inspection which revealed a minor abrasion in the head region. Rider S MacNab reported that the horse had failed to handle the heavy nature of today's track.

YOURLIPS AR MOVIN (G Jogoo) – Slow to begin.

PERFECT SECRET (K Mudhoo) - Slow to begin.

COTTA PIN (K Kalychurun) – Began awkwardly.

ARAPITO (L Callaway) - Raced wide throughout.

SAROOKH (R Firdhaus) – Raced in restricted room momentarily passing 1200 metres.

FLICKA OF GOLD (T Wenn) – Improved wide from 600 metres.

Race 3 JACK CURRAGH MEMORIAL RATING 85 1500M

WEISSMULLER (K Mudhoo) – Began awkwardly and shifted out abruptly, momentarily unbalancing rider K Mudhoo.

LORD BENTLEY (T Wenn) – When questioned regarding the improved performance, trainer P Rudkin advised the gelding had appreciated the wetter track conditions today.

Race 4 GREG DAIL REAL ESTATE MAIDEN 1100M

KINGTIDE (D Bothamley) – Slow to begin. Held up passing 400 metres and again momentarily near the 300 metres.

PRODUCER (T Moseley) – Raced wide throughout. Rider reported having raced wide throughout had taken its toll on the gelding over the concluding stages.

NOPELE (G Jogoo) – Got its head up when racing keenly for a short distance passing the 800 metres.

LESEDI LA RONA (T Wenn) – Lay inwards passing the 100 metres and had to be straightened. Rider dropped whip passing 50 metres.

Race 5 VERNON AND VAZEY RATING 65 1100M

ALL DRESSED UP (K Kalychurun) – Crowded near the 50 metres and had to steady momentarily when CELEBRATEDACHIEVER (E Farr) shifted outwards simultaneous to OVERNIGHTSENSATION (T Moseley) shifting inwards. Both riders, Moseley and Farr, were advised to exercise greater care when shifting ground.

CELEBRATEDACHIEVER (E Farr) – Shifted ground outwards over the concluding stages.

OVERNIGHTSENSATION (T Moseley) – Shifted ground inwards over the concluding stages. When questioned regarding the improved performance, trainer K Rae advised that the mare had appreciated today's wetter track conditions.

Race 6 GREYMOUTH BUSINESSES SPRINT 1100M

PINZANO (K Kalychurun) - Underwent a veterinary examination prior to the start and was cleared to race after making heavy contact with the birdcage gate.

Race 7 RECREATION HOTEL GREYMOUTH CUP 2000M

OVERTHERIVER (K Mudhoo) – Raced keenly through the early to middle stages when leading.

SELWYN (S MacNab) – Raced keenly early with the saddle slipping forward passing the 1600 metres placing rider S MacNab at a disadvantage for the remainder of the event.

THE GORDONIAN (G Jogoo) – Crowded between runners at 250 metres becoming momentarily unbalanced. Brushed with KAHARAU passing the 200 metres.

Race 8 GUERIN FAMILY RATING 65 2000M

GINGERBREAD MAN (S MacNab) – Began awkwardly shifting out and crowding LADY LINDAUER. Shifted inwards under pressure at 50 metres having to steady when awkwardly placed on the heels of WHAT A DEEZA which was forced outwards

by LADY LINDAUER.

LADY LINDAUER (G Jogoo) - Crowded, lost ground at the start. Bumped and unbalanced at 200 metres. Shifted out at 100 metres bumping with WHAT A DEEZA who was forced outwards resulting in the trailing GINGERBREAD MAN having to be steadied momentarily. G Jogoo was issued with a warning under Rule 638(1)(d).

POINT PROVEN (K Kalychurun) – Raced wide through the early stages and attempted to improve wide from 600 metres.

ZAH CHAMP (T Wenn) – Raced keenly through the early to middle stages.

WHAT A DEEZA (E Farr) – Shifted in when struck with the whip passing 200 metres making firm contact with LADY LINDAUER with both runners becoming momentarily unbalanced. E Farr was issued with a warning under Rule 638(1)(d).

LOCALLY SAUCED (L Callaway) – Rider advised he was disappointed with the effort of the gelding and could offer no tangible excuses. Stewards ordered a post-race veterinary inspection of LOCALLY SAUCED which revealed no abnormalities.
