RACE COMMENTS:

Race 1 CROYDON CONTRACTING / ADVANCE AGRICULTURE MAIDEN (1335M)

Trainers **K, L Rae & K Williams** were issued with a warning pursuant to Rule 625(1) in that they presented AUGUSTACE late to the birdcage.

MISS GEE JAY (J Lowry) - Raced wide throughout.

HIGHER AUTHORITY (S Weatherley) – Bumped with PORTUMNA LASS passing the 150 metres. Rider **S Weatherley** was issued with a warning pursuant to Rule 648(3) after he weighed in 0.4kgs light.

DREAM RICH (S Wahab) - Over raced in the early stages and near the 850 metres had to be steadied when awkwardly

placed near heels.

THE GLISTEN (E Farr) – Crowded leaving the barriers.

PORTUMNA LASS (S Muniandy) – Raced wide without cover throughout. Lay in passing the 100 metres bumping with HIGHER AUTHORITY.

NETHERTOWN EXPRESS (S Collett) – Slow into stride. Raced keenly in the early stages and had to be steadied momentarily passing the 1200 metres.

Race 2 AON INSURANCE BROKERS / SGT DAN STOCKFOODS HANDICAP (1335M)

FLYING SARDINE (K Kalychurun) – Raced wide in the early stages. Lay outwards in the early stages of the run home. When questioned regarding the disappointing performance of the favoured runner rider K Kalychurun advised in his opinion the mare was looking for further distance at this stage of its preparation.

KASUNDI (K Mudhoo) – When questioned regarding the disappointing performance rider K Mudhoo advised in his opinion the mare was unsuited by todays prevailing track conditions.

TAPILIZE (E Farr) – Shifted inwards under pressure near the 250 metres when weakening. E Farr advised to exercise greater care when shifting round.

ALL THINGS NICE (C Barnes) – Began awkwardly losing ground. Steadied near the 250 metres when awkwardly placed near the heels of the weakening TAPILIZE which shifted inwards under pressure. ALL THINGS NICE then had difficulty obtaining clear racing room for the remainder of the home straight.

KATANGO (R Yatim) – When questioned regarding the improved performance trainer B Laking was unable to offer any tangible explanation other than the mare had benefited today from receiving an uncontested lead with a 4kg allowance.

Race 3 KEVIN COYLE MEMORIAL HANDICAP (1335M)

JOE BONANNO (K Mudhoo) – Forced wider on the track near the 700 metres when POLLY'S SISTER shifted outwards abruptly when over racing. JOE BONANNO was then obliged to race wide for the remainder of the event.

WILLOW (J Lowry) – Steadied passing the 500 metres resulting in the trailing ROBIN CHARLES and POLLY'S SISTER having to be steadied at this point. Shifted outwards under pressure in the early stages of the home straight.

ALITRON (S Muniandy) – Returned to the birdcage with blood present in both nostrils and following a post-race veterinary examination was deemed to be a bleeder with connections advised the gelding was stood down for the mandatory period of 3 months.

RETALLICK (S Collett) - Slow to begin.

LIZZIE BORDON (M Tanaka) – Tightened shortly after the start and had to steady when ALITRON shifted ground outwards slightly simultaneously to POLLY'S SISTER laying in.

ROBIN CHARLES (G Jogoo) – Had to be steadied passing the 500 metres.

DARCI GLITTER (K Kalychurun) – Held up and had to be steadied for a short distance passing the 400 metres. Had to shift ground inwards near the 150 metres to find clear racing room.

KNUTQUACKER (K Williams) – Raced wide without cover throughout.

ALOTTATOW (C Barnes) – Improved wide from the 500 metres.

POLLY'S SISTER (S Weatherley) – Over raced in the early stages and near the 700 metres shifted outwards abruptly when awkwardly placed near the heels of KNUTQUACKER. Steadied passing the 500 metres.

SUNFLOWER (C Johnson) – Raced wide through the early stages. Steadied passing the 500 metres.

Race 4 ARCHER CORP'S MCANGUS FILLIES & MARES HANDICAP (1335M)

FANTAMO (K Kalychurun) – Raced wide for the majority of the event.

RIDEITLIKEUSTOLEIT (G Jogoo) – Bumped with FASCINATE passing the 450 metres.

SPRINGWATER (M Tanaka) – Raced wide in the early stages. When questioned regarding the performance rider M Tanaka advised the mare had been under pressure throughout and commenced to give ground from the 600 metres. A post-race veterinary examination revealed no obvious abnormalities.

HOT DATE (C Johnson) – Steadied near the 700 metres when making the bend awkwardly. Held up and had to steady passing the 300 metres when a marginal run ahead closed.

FASCINATE (C Barnes) – Bumped with RIDEITLIKEUSTOLEIT passing the 450 metres.

Race 5 REGIONAL FORD GORE HANDICAP (2000M)

GOTTAGETMYWOOHOO (C Johnson) – Raced keenly in the early to middle stages.

CENTAVADA (S Collett) – Held up rounding the final bend and bumped with WILD JACK passing the 250 metres. Continued to be held up only gaining clear racing room inside the final 150 meres.

HE AIN'T HEAVY (W Papier) – Improved wide through the middle stages to sit outside the leader passing the 600 metres.

PRECIOUS PERCY (J Lowry) – Raced in restricted room rounding the final bend.

INDIANA PEARL (S Muniandy) – Momentarily inconvenienced near the 200 metres.

SPIDER LILY (E Farr) – Began awkwardly and shifted out bumping with STARBUCK losing ground as a result. Held up rounding the final bend and again near the 150 metres having to shift ground outwards across the heels of HE AIN'T HEAVY to obtain clear running and when doing so bumped with STARBUCK.

CONSOLIDATE (M Tanaka) – Raced wide in the early stages until near the 1200 metres.

QUINTASTICS (K Kalychurun) – Improved very wide from the 1000 metres.

WILD JACK (L Callaway) – Began awkwardly. Raced keenly in the early stages and had to be steadied off heels passing the 1200 metres. Bumped with CENTAVADA passing the 250 metres.

ZAH CHAMP (S Weatherley) – Hampered leaving the barriers when WILD JACK shifted outwards when beginning awkwardly. Got its head up when racing keenly in the early stages. Improved very wide rounding the final bend.

STARBUCK (G Jogoo) – Improved up onto heels at the 200 metres having to shift ground outwards to obtain clear racing room and when doing so momentarily inconvenienced INDIANA PEARL. Bumped and pushed wider passing the 100 metres when SPIDER LILY improved to its inside.

Following the running of this event the official track conditions were upgraded to Slow 7.

Race 6 GORE TOWN & COUNTRY CLUB HANDICAP (2000M)

THOUGHT THAT (C Johnson) – Raced keenly in the early stages and jumped the crossing near the 1600 metres.

GUNNA FLY (G Jogoo) – Slow to begin. Raced keenly from the 1400 metres and was allowed to stride forward to sit outside the leader near the 600 metres.

TAKE FIRE (S Collett) - Bumped with LA NOUVELLE VAGUE on jumping and lost ground as a result.

LA NOUVELLE VAGUE (S Weatherley) – Began awkwardly and shifted in bumping with TAKE FIRE. Made the crossing at the 1600 metres awkwardly. Lay inwards early in the home straight and had to be straightened.

Race 7 MLT / DB BREWERIES GORE CUP (2000M)

THE GORDONIAN (D Bothamley) – Bumped with MOTORBOAT MIKE leaving the barriers. Raced three-wide without cover in the early and middle stages.

MY CHINO (C Johnson) – Shifted out passing the 250 metres crowding PRINCESS BROOK momentarily. Shifted inwards under pressure near the 100 metres crowding MOTORBOAT MIKE. C Johnson was advised to exercise care.

MOTORBOAT MIKE (S Muniandy) – Began awkwardly shifting out and bumping with THE GORDONIAN. Steadied near the 900 metres when awkwardly placed near the heels of THE GORDONIAN. Crowded near the 100 metres.

PRINCESS BROOK (C Barnes) – Crowded momentarily passing the 250 metres.

THE ENERGIZER (K Kalychurun) – Lay inwards rounding the final bend and early in the run home.

Race 8 LIQUORLAND GORE GUINEAS (1335M)

DON CARLO (S Collett) – When questioned regarding the performance rider S Collett advised the gelding had failed to handle the prevailing Slow 7 track conditions.

STROWAN (S Muniandy) – Crowded and checked near the 150 metres when WONDER WOMAN (E Farr) shifted in when being ridden forward. Apprentice Rider E Farr with the assistance of senior rider Mr C Johnson admitted a breach of Rule 638(1)(d) when allowing her horse WONDER WOMAN to shift inwards when insufficiently clear of STROWAN. After viewing replays and hearing submissions on penalty the JCA suspended Miss Farrs' riding licence from the 27th January until the 2nd February inclusive (5 riding days).

MIDNIGHT GOSSIP (S Weatherley) – Raced wide in the early stages.

WHAT CHOUX WANT (L Callaway) – Raced wide throughout.

PLAY FOR TIME (M Tanaka) – Buffeted and unbalanced when TAP DIS shifted out making firm contact shortly after the start. Bumped with RESIDENTIAL passing the 1250 metres. Badly unbalanced and had to be firmly restrained passing the 1000 metres when racing keenly and crowded by DON CARLO which was also racing keenly and making the bend awkwardly having to shift outwards and away from the heels of STARVOIA who shifted in. C Johnson was advised to exercise care.

WONDER WOMAN (E Farr) - Shifted in near the 150 metres crowding and checking STROWAN.

SHIRLEY MAUDE (G Jogoo) - Slow to begin.

TAP DIS (K Mudhoo) – Crowded and buffeted leaving the barriers between PLAY FOR TIME and RAISE YOU TEN which shifted outwards.

Race 9 O'CONNOR RICHMOND / AUTO FUNDS HANDICAP (1200M)

SOMETHINGS BURNING (M Tanaka) – Re-plated and underwent a pre-race veterinary examination being subsequently cleared to start. Held up early in the run home and had to steady and shift ground inwards at the 175 metres to find clear racing room.

STOKERS ROCK (G Jogoo) - Slow to begin.

SECRET POWER (K Williams) – Got its head up when racing keenly passing the 900 metres.

SHAARA (K Kalychurun) – Bumped with SUPER TROUPER shortly after the start when both runners shifted ground.

FASTFOOT (C Barnes) – Lay in throughout the run home with the rider reporting the gelding had hung throughout.

SUPER TROUPER (S Collett) – Bumped with SHAARA shortly after the start when both runners shifted ground. Crowded and checked at the 500 metres when COULEE (J Lowry) shifted in. Apprentice rider J Lowry with the assistance of Mr B Anderton admitted a breach of Rule 638(1)(d) when allowing his horse to shift inwards when insufficiently clear of SUPER TROUPER. After viewing the replays and hearing submissions on penalty the JCA suspended Mr Lowrys' riding licence from the 27th January until the 3rd February inclusive. (2 riding days)

Race 10 FARMLANDS GORE HANDICAP (1200M)

PINZANO (K Kalychurun) -Lay out over the concluding stages and had to be straightened.

ACCIDENTAL OFFSIDE (K Williams) – Raced keenly in the early stages and wide without cover throughout.

TICKETS ON HER (K Mudhoo) – Lay out on the final bend.

RAJIV (S Wahab) – Rider reported the saddle had shifted forward during the running.
