KOWHAI KERRY (K Cowan) was slow away.

STORMY HABIT (R Hannam) was slow away.

C Lammas - admitted a breach of Rule 638(3)(b)(ii) Excessive use of the whip and was fined \$300.

When questioned regarding the performance of **REDDITO**, K McCulloch advised the gelding was unsuited by today's existing track conditions.

Race 2 | **DONALDSON PLUMBING 2000**

HOVER (R Myers) raced ungenerously in the early stages.

PARADISE ROCK (C Lammas) over-raced in the lead in the early and middle stages then was quickly beaten passing the 600 metres. Rider C Lammas advised that after over-racing the gelding had commenced to hang out rounding the final bend and had found today's track conditions too testing. A post-race veterinary examination revealed no abnormalities.

JUDITH KATE (S Collett) jumped away awkwardly.

Race 3 | **CIVIL PROJECT SOLUTIONS 1200**

SILVER MISSILE (C Lammas) began awkwardly losing ground.

COME DANCE WITH ME (A Collett) began awkwardly losing ground.

LADY ROSEANNE (C Grylls) over-raced through the early stages.

ST REGIS (R Myers) raced wide without cover and when placed under pressure passing the 400 metres, was unable to quicken. When questioned into the performance of the gelding, rider advised it was unsuited to today's existing track conditions.

Race 4 | **PAK'nSAVE 1200**

DEEJAY MAC (A Collett) was slow away.

SOPHIALIGN (A Jones) had to be steadied to avoid the heels of **INDULGENT** (E Farr) which shifted inwards when not fully clear near the 1100 metres. Rider E Farr was advised to exercise care when shifting ground.

SAIGNON (R Elliot) raced ungenerously when being steadied away from the heels of **INDULGENT** near the 1050 metres.

BELLA ROCCIA (D Hirini) was inclined to shift ground under pressure in the final straight.

Race 5 | **VINTECH PACIFIC LTD SPRINT**

CORPORATE MISSILE (A Collett) was crowded at the start losing ground.

DUALIS (S Collett) jumped away awkwardly.

CUTTING UP ROUGH (E Farr) jumped away awkwardly.

SMOKE HOUSE BAY (C Lammas) was slow away.

BRUEGEL (K McCulloch) ducked inwards when struck with the whip near the 300 metres.

SMOKE HOUSE BAY, when questioned regarding performance, rider C Lammas advised that the mare had travelled comfortably enough throughout the running but was unable to quicken in the heavy track conditions once placed under pressure.

Race 6 | **THE GISBORNE FINANCIAL & THERMISOL STAKES**

MAKE ME ACHIEVER (C Johnson) was slow away.

When questioned into the performance of **ABLOOM** rider C Lammas advised that the filly had travelled well until the 600 metres and once placed under pressure failed to respond and was not persevered with over the final 200 metres. Rider advised the filly was unsuited to today's existing track conditions.

STRAIGHT JACKET (R Myers) briefly held up entering the final straight near the 350 metres.

JAILHOUSE ROCK (A Collett) hampered early in the final straight near the 350 metres when **MAKE ME ACHIEVER** lay in.

JOVANNI (E Farr) briefly steadied when shifting outwards across the heels of **EXONERATE** (K McCulloch) to obtain clear running near the 300 metres.

Race 7 | **SEE YOU AT LONE STAR GISBORNE MILE**

LYCABEE (R Myers) was slow away.

GUY FOX (S MacNab) was slow away.

IMELDAS GIRL (A Collett) jumped away awkwardly after being reluctant to enter the barriers. When questioned rider advised the filly had travelled well during the early and middle stages and once placed under pressure failed to respond and was not persevered with over the final 200 metres. A Collett advised Stewards the filly did not handle today's existing track conditions. Underwent a post-race veterinary examination which revealed the filly had tied up badly and was treated by the Veterinarian.

GUY FOX (S MacNab) had to be firmly restrained when placed in restricted room to the outside of **YEARN** (K McCulloch) which had to steady and shift out abruptly when becoming awkwardly placed on heels of **CHOUX LACE** which was being steadied off the weakening **MIZ OLDFIELDS ROAD** (J Bassett).

R Elliot - admitted a breach of Rule 638(3)(b)(ii) Excessive use of the whip and was fined \$300.

Race 8 | **LINDAUER POVERTY BAY CUP**

SCAPOLO (D Hirini) began awkwardly.

CAJUN (R Myers) was slow away.

SCAPOLO was held up rounding the final turn from the 500 metres obtaining clear running passing the 400 metres.

R Elliot was spoken to regarding his whip use prior to the 200 metres on his mount **COLONEL CARRERA**.

Race 9 | **EMERRE & HATHAWAY INSURANCE BROKERS MILE**

WHIPPED (R Myers) was slow away before being further hampered when crowded.

CANTARE (S Collett) jumped away awkwardly hampering **I'M ALL EARS** (M Tanaka).

I'M ALL EARS hampered at the start.

WHY ME (E Farr) gave ground quickly passing the 700 metres and was not preserved with in the final straight finishing a distant last. Rider advised that she felt there was something amiss with the gelding. A post-race veterinary examination did not reveal any obvious abnormality with the gelding to be further accessed on return to stable.
