RACE COMMENTS:

Race 1 ISABELLA SPIERS PATHWAY 1800M

EFFECTAV (M McNab) – was inclined to lay inwards in the home straight. Bumped TWOZNOTENOUGH near the finish.

TWOZNOTENOUGH (J Waddell) – bumped EFFECTAV near the finish.

Prior to the authorisation of dividends the connections of the 2nd placed TWOZNOTENOUGH viewed footage of the home straight but elected not to proceed with an objection against the winner EFFECTAV.

The track was track downgraded to dead 4retrospective to race 1.

Stewards questioned the time of Race 1 (1.45.7) which was incorrect. This was amended to 1.51 after reviewing footage.

Race 2 PUKEKURA MOTOR LODGE 3YO 1800M

ITISWHATITIS (R Myers) – became fractious leaving the enclosure dislodging jockey R Myers who was checked by paramedics prior to the start and cleared to ride.

DIAMAINT (C Lammas) – made contact with the running rail prior to the start so underwent a veterinary inspection and was cleared to start. DIAMAINT tightened at the start after movement from runners either side.

BADUZZI (T Thornton) – tightened at the start.

IT'S PANDAMONIUM (R Hannam) – tightened at the start.

MADAM MONICA (M McNab) – reared and hit the top of its gate on jumping away losing several lengths. Underwent a veterinary inspection which revealed superficial cuts and abrasions around its mouth. Inclined to lay inwards in the home straight when attempting to angle across heels. A warning was placed on the barrier manners of MADAM MONICA.

SOLDIER FIELD had to be steadied off heels near the winning post on the first round when COTTONEVA (J Waddell) shifted in when not sufficiently clear. Rider J Waddell was advised to exercise greater care in similar circumstances.

SUBLIME HABIT (H Tinsley) – had to steady off heels approaching the 1000 metres going back on to COTTONEVA who also had to be steadied. After questioning riders it was subsequently established that MISS ELLAN VANNIN (S McKay) was not sufficiently clear when shifting ground. Stewards advised rider S McKay to exercise greater care. Raced in restricted room rounding the final turn.

MISS ELLAN VANNIN (S McKay) – raced three wide without cover around the first turn until approaching the 1000 metres.

COTTONEVA (J Waddell) – steadied off heels near the 1000 metres having to be angled three wide where it raced without cover for the remainder of the race.

SECRET HARMONY (A Collett) – began awkwardly. Had to be steadied off heels passing the 500 metres. Was held up for the entire straight going to the line untested.

STUNNING (M Tanaka) – commenced to over race rounding the turn into the back straight and had to be restrained. When questioned into the run of STUNNING M Tanaka reported the filly raced greenly and in his opinion may improve with experience.

Race 3 TREVOR WYLDE 80TH MDN 1100M

CARNATION (M Hills) – began awkwardly, was slow away then over raced.

HOW'S THAT GIRL (M McNab) – raced in restricted room for a short distance approaching the 100 metres.

Race 4 ECOLAB 1200

Following the race Stewards requested a ruling from the JCA under Rule 632(1) to determine whether ISOLA BELLA, EPROUVEZ and CLUBS CHOICE were afforded a fair start. After questioning riders it was established that CLUBS CHOICE charged the gate immediately prior to the start which affected its own and the gates of ISOLA BELLA, OCEAN EMPEROR and to a lesser extent EPROUVEZ, whose gate was marginally slow to open. After consideration, the JCA determined the chances of ISOLA BELLA (R Elliot) and CLUBS CHOICE (A Collett) were materially affected and were subsequently declared non-starters. After hearing the evidence of rider C Grylls EPROUVEZ was declared a runner and OCEAN EMPEROR was not considered under Rule 632(1).

OCEAN EMPEROR (M Hills) - gate slow to open.

CLUBS CHOICE (A Collett) – gate slow to open.

ISOLA BELLA (R Elliot) - gate slow to open

EPROUVEZ (C Grylls) – awkwardly away.

PLATINUM EXPRESS (R Hannam) – over raced early, also raced three wide without cover throughout.

Race 5 STELLA ARTOIS F 7 M MDN 1600M

Prior to the running of race 5 the gates underwent and passed testing.

TWILIGHT JEWEL (D Turner) - was slow away.

KEEPER GIRL (M Cameron) – raced three wide without cover throughout.

LE PETITE ROUGE (S Collett) – over raced early.

JANE'S SECRET (T Miles) – made the bend by the 1200 metres awkwardly, then commenced to over race along the back straight.

MUMM (J Waddell) – broke down in the near foreleg approaching the 150 metres and was humanely euthanised by veterinary staff. J Waddell was cleared to fulfill his remaining three engagements but stood himself down as a precautionary measure.

GRANDLY (L Hemi) – had to be angled off heels over the concluding stages.

Race 6 DAVE 7 EDDIE MDN 1400

DEEP BLUE (T Thornton) – shifted out abruptly passing the 200 metres and in doing so dictated EAGLE BAY over extra ground. Also effected was ALLMOSTA. Prior to the authorization of dividends M Cameron the rider of the 5th placed (ALLMOSTA) viewed footage of the home straight but elected not to proceed with an objection against the 4th placed DEEP BLUE.

EAGLE BAY (R Myers) – jumped inwards abruptly at the start bumping DEMI on to TINKALICIOUS. Dictated over extra ground passing the 200 metres. Had to shift inwards to improve near the 100 metres.

ALLMOSTA (M Cameron) – tightened at start. Dictated over extra ground passing the 200 metres.

RASCALLION (H Tinsley) – was inclined to lay in under pressure early in the home straight.

CANDY STAR (S Weatherley) – was held up for a short distance approaching the 200 metres.

WHAT NOW MY LOVE (D Turner) – over raced passing the 1000 metres.

Race 7

NZB INSURANCE PEARL SERIES 1400M

FASCINO LASS (R Hannam) – began awkwardly bumping SPRITZ.

SPRITZ (C Lammas) – bumped at the start settling back.

PETITE EN JEU (L Hemi) – awkwardly away.

TIFFANY'S TIME (M McNab) – jumped abruptly outwards at the start bumping PRINCESS RAAJ.

PRINCESS RAAJ (T Thornton) – bumped at the start.

MANEO INVICTUS (S Collett) – tightened at the start.

HOW PERFECT (M Tanaka) – awkwardly away.

GLADSTONE BELLE (R Elliot) – made the bend by the 800 metres awkwardly.

ALAMCFERSON S McKay) – rider S McKay was questioned regarding the performance of the filly but could offer no tangible explanation. A subsequent veterinary examination failed to show any obvious abnormalities.

Race 8

PLATINUM HOMES TARANAKI CUP 1800M

PURE SAVALINA (C Lammas) – raced very wide into the first turn. Had to be steadied off heels passing the 100 metres.

HIGH IN DEMAND (H Tinsley) – raced three wide without cover from the 1200 metres.

NEWSTEAD (A Collett) – was momentarily held up passing the 500 metres. Had to be steadied in restricted room passing the 150 metres.
