GENERAL:

All riders underwent and passed workplace alcohol testing.

Random pre-race blood testing of horses was carried out.

SUPPLEMENTARY:

Race 4 - Canterbury Racing 11 February 2017

ARYACRAZY - Trainer P Rudkin has advised that blood tests taken from ARYACRAZY following its performance at Riccarton on 11 February have revealed no abnormalities with the mare's preparation carrying on as planned.

Race 7 - Southland Racing Club 18 February 2017 - Southland Guineas 1600m

DONTPOKETHETIGER - Trainer P Rudkin advised stewards following its poor performance in this race that DONTPOKETHETIGER underwent a veterinary examination on return to the home stable. This resulted in the filly having three teeth removed which were rubbing on the mouth and were the probable cause for her to be skying her head and hanging. Mr Rudkin further advised that DONTPOKETHETIGER would continue on in its current campaign. Race 10 - Southland Racing Club 18 February 2017 - AON Insurance Brokers R65 1600m

LIZZIE BORDON - Trainer S McKay advised that following the disappointing performance the mare was found to be in a distressed state suffering dehydration. Subsequent to veterinary treatment LIZZIE BORDON has improved and will be given a brief respite from racing.

RACE COMMENTS:

NZB INSURANCE PEARL SERIES MAIDEN FILLIES & MARES (1200m) Race 1 HAND OF ACES (K Mudhoo) – Raced wide throughout, lay in passing the 300 metres having to be straightened. RAISE THE ANTE (G Jogoo) - Slow away. ULTRA CHIC (K Kalychurun) – Held up for several strides passing the 200 metres. **PER FORM** (C Johnson) – Crowded and checked to the inside of PROMISING (T Moseley) which shifted in under pressure approaching the 200 metres. PER FORM then steadied and shifted out to obtain clear running. Rider T Moseley admitted a resultant charge of careless riding with the Judicial Committee suspending his licence to ride at race meetings 25 February to 12 March inclusive, three riding days. Following the race Stewards lodged a protest on behalf of the connections of the 3rd placed horse **PER FORM** alleging interference by 2nd placed horse **PROMISING** in the final straight. After hearing submissions the Judicial Committee upheld the protest with placings now reading 1st ULTRA CHIC, 2nd PER FORM, 3rd PROMISING, 4th NAKYAMA. AUTUMN RACES SUITE PACKAGE - BOOK NOW RATING 65 (1200m) Race 2 **ARAPITO** (T Jonker) – After becoming fractious in its stall the mare was removed and underwent a veterinary check before being passed fit to race. WIZE ACT (A Collett) – Underwent a veterinary examination after becoming fractious in its barrier and was passed fit to race. Held up early in the final straight. BARANOO (R Yatim) – Began awkwardly. Following the race trainer S Tyler advised that the gelding was found to have some minor lacerations on both back legs consistent with being galloped on during the race. **GOOD MAMA** (K Williams) – Raced ungenerously when being restrained in the early stages. LIVADREAM (G Jogoo) – Raced keenly in the early stages. **LOTTERIO** (T Comignaghi) – Raced wide throughout. **CZARISTA** (C Johnson) – Held up throughout the run home until the final 100 metres. **RUBY ROW** (C Barnes) – Lay out early in the run home shifting wider on the track. **MOTHER SUPERIOR** (K Kalychurun) – Apprentice rider K Kalychurun reported that the mare had hung out badly over the concluding 200 metres which placed him at a disadvantage. Race 3 **NAUTICAL BOAT INSURANCE MAIDEN (1800m)** HE'S ROWDY (S Wynne) - Bounded and lost ground at the start.

PATROMIA (C Barnes) – Slow to begin.

PICKUP (C Johnson) – Crowded and had to steady passing the 1600 metres to the inside of MISTY TRELLA (W Papier) which shifted in when becoming awkwardly placed inside the heels of MOBY which was being steadied. Apprentice rider W Papier was advised he must exercise greater care in a similar circumstance.

SHARP ELLE (A Collett) – Raced keenly in the early to middle stages when being restrained. Held up rounding the final bend gaining clear racing room passing the 250 metres.

HIGH PLAY (S Muniandy) – Raced keenly in the middle stages.

MISTY TRELLA (W Papier) – Held up early in the run home.

Race 4 UNICHEM SPITFIRE SQUARE PHARMACY MAIDEN (1400m)

POWERBALL (A Collett) – Began awkwardly and lost ground. Became awkwardly placed on heels passing the 600 metres and was held up for a short distance.

NIGHT WATCHMAN (R Hannam) – Slow to begin.

PAHAU (K Kwo) – Commenced to over-race when being steadied in the early stages and then raced in restricted room to the inside of ZAH CAPTAIN (S Muniandy) which shifted in when not fully clear passing the 1000 metres. As a result BEATS WORKEN and SMOKE 'EM WILSON both had to be steadied when awkwardly placed. Rider S Muniandy was severely reprimanded by Stewards and advised to exercise greater care in similar circumstances.

BEATS WORKEN (C Barnes) - Raced in restricted room passing the 1000 metres having to be steadied.

SMOKE 'EM WILSON (K Mudhoo) – Steadied 1000 metres when awkwardly placed, then raced keenly through the middle stages.

WESLEY HALL (W Papier) – Shifted out passing the 1200 metres and then commenced to improved forward to dispute the pace near the 800 metres. WESLEY HALL then continued to race wide for the remainder of the final bend whilst continuing to disputing the pace. Stewards opened and adjourned an inquiry into the riding tactics adopted on WESLEY HALL.

Race 5 PUNTERS CHALLENGE APRIL 8 – ENTER NOW RATING 75 (1400m)

WINDERMERE LASS (C Spittles) – Slow to begin.

HOT TEMPO (C Johnson) – Made contact with FLICKA OF GOLD passing the 100 metres when both runners shifted ground.

FLICKA OF GOLD (R Yatim) – Made contact with HOT TEMPO passing the 100 metres when both runners shifted ground.

Race 6 CHRISTCHURCH CASINO RATING 75 (2000m)

SUZERAIN (R Firdhaus) – Raced wide throughout.

CRACKLING ROSIE (A Collett) – Held up rounding the final bend and early in the run home gaining clear racing room near the 300 metres.

Race 7 CHERYLE BARNSLEY – JOB WELL DONE RATING 65 (2000m)

PERFECT SECRET (C Spittles) – Slow to begin.

OPIHI JADE (K Mudhoo) – Began awkwardly losing ground.

GOTTAGETMYWOOHOO (L Callaway) – Became awkwardly placed on heels passing the 1700 metres when commencing to over race and continued to over race for a distance. Dictated outwards at the 200 metres. Briefly steadied passing the 50 metres when racing in restricted room to the inside of OPIHI JADE (K Mudhoo) which had shifted in under pressure, K Mudhoo was advised to exercise greater care.

YOURLIPS AR MOVIN (S Wynne) – Raced in restricted room passing the 300 metres between OPIHI JADE which commenced to lay in under pressure and PERCEPTIVE which lay out, then further crowded and steadied passing the 200 metres when PERCEPTIVE was dictated outwards slightly by GOTTAGETMYWOOHOO and ASOMA which were both dictated out by DARCI INN (T Comignaghi) which shifted out under pressure. Apprentice rider **T Comignaghi** was severely reprimanded by Stewards and advised that a warning would be placed against her record.

PERCEPTIVE (C Barnes) – Shifted out making early in the final straight making brief contact, then crowded near the 200 metres.

OLIGARCH – Rider C Johnson advised that the entire was under pressure throughout and had failed to run on. A post-race veterinary inspection did not reveal any obvious abnormalities.

Race 8 NZB SOUTH ISLAND SALE APRIL 21 RATING 65 (1600m)

DE CHINE (A Collett) – Slow to begin.

PLACID PRINCESS (S Muniandy) – Slow to begin, raced wide throughout.

SNIPARINDA (G Jogoo) – Raced keenly in the early stages, held up passing the 400 metres when improving into a marginal run.

ZIGWIG (T Moseley) – Raced wide in the early stages.

FERGIE (T Jonker) – Crowded and steadied passing the 1000 metres to the inside of ZIGWIG (T Moseley) which shifted in when not fully clear. T Moseley was reprimanded by Stewards and advised to exercise greater care.

MISS MIA (S Wynne) – Had to be restrained passing the 800 metres when improving onto heels.

RADIANT (R Firdhaus) – Held up for clear running early in the final straight, shifting out near the 250 metres. Rider R Firdhaus advised that he must ride his mounts out fully to the end of the race when circumstances permit him to do so.

SMICHAEL (R Yatim) – Crowded when awkwardly placed on heels near the 450 metres.

RISING SON (C Johnson) – Briefly crowded approaching the 400 metres when improving into a marginal run to the outside of FERGIE which shifted out slightly.

PENTIRE BABE (K Mudhoo) – Apprentice rider K Mudhoo was reminded of his obligations with regard to whip use on a horse out of contention.

PASSAMAQUODDY – Rider R Hannam reported that in his opinion the gelding was feeling the effects of recent racing.

I'LLBEYOURPLATINUM (K Kalychurun) – Trainer **P Collins** was issued with a warning after the mare was presented with incorrect gear (blinkers).
