RACE COMMENTS:

Race 1 Power Farming 1400

ASTRID (C Grylls) - crowded between runners at the start losing ground.

GO NICHOLAS (S Weatherley) - shifted out and away from CHEEKY BOY hampering MASSOFDASH on jumping away

MASSOFDASH (T Newman) - Hampered on jumping away, raced wide throughout.

GO NICHOLAS, SILHOUETTE NOIRE (S McKay) - and **MASSOFDASH** all over-raced due to the lack of pace through the early and middle stages.

When questioned into the performance of **RUUD NOT TOO** rider H Marzuki advised the mare raced handy due to the slow early pace and was unable to quicken in the final straight. Rider could not offer any other tangible reason. A post-race veterinary examination revealed no abnormalities.

Race 2 Thorburn Builders 1200

AILEEN GRACE (S Weatherley) - knuckled at the start losing ground. Was held up for clear running over the concluding stages when attempting a marginal run to the inside of CULZEAN.

PARK LANE (D Turner) - began awkwardly then briefly crowded passing the 1100 metres.

LADY ROSEANNE (E Farr) – crowded and steadied when becoming awkwardly placed on the heels of CULZEAN (B Hutton) passing the 1100 metres shifting in crowding SILVER SASANOF in on to PARK LANE. B Hutton was advised to exercise care when shifting ground.

SILVER SASANOF (R Hutchings) – briefly crowded to the inside of LADY ROSEANNE passing the 1100 metres. Steadied over the concluding stages when in restricted room to the inside of MY GIDDY AUNT which shifted in under pressure over the final 100 metres. V Colgan was advised to exercise care.

IMRAN (S McKay) - commenced to over race in the early stages making the bend by the 900 metres awkwardly.

MY GIDDY AUNT (V Colgan) - when shifting out to obtain clear running near the 400 metres, made contact with LADY ROSEANNE. Shifted in under pressure over the final 100 metres.

Race 3 Seafood Bazaar 1200

HIGH DISTINCTION (D Danis) - began awkwardly losing ground.

HONEY RIDER (J Nason) - shifted out at the start making firm contact with LOVE AFFAIR and over raced in the early and middle stages.

MEMORIES ONLY (R Norvall) - over raced in the early stages.

DON BLANCO (S McKay) - raced wide throughout.

TARDY CHARDY (C Grylls) - lay out throughout the run home.

LOVE AFFAIR (S Weatherley) - raced keenly in the early stages and steadied off heels passing the 900 metres and continued to race ungenerously for a short distance.

Race 4 Allied Security 1200

PASSING SHOT (S Spratt) - raced wide throughout. Shifted in making firm contact with OHOPE PRINCE passing the 200 metres.

OHOPE PRINCE (D Prastiyou) - bumped and momentarily unbalanced passing the 200 metres.

SOUTHERN ICON (M Hills) - was slow to begin.

Race 5Joe Black Munns The Man Store 2100

MASTER OF SPEED (S McKay) - shifted in abruptly at the start crowding FEROZ with both runners losing ground.

THAILAND (T Newman) - began awkwardly and was further hampered when runners either side shifted ground at the start having to be steadied losing ground. Then raced wide through the early and middle stages improving forward to sit outside the leader near the 800 metres.

BEAR (R Hutchings) - had to steady and shift out near the 600 metres when becoming awkwardly placed on the heels of LADY PIMPERNEL which was weakening inconveniencing DESERT STORM which was taken over extra ground and also forced wider on the track was SAKURA.

SAKURA (D Turner) - raced ungenerously in the early stages. dictated over extra ground 600 metres.

DESERT STORM (C Grylls) - got its head up when being steadied making the bend awkwardly near the 1800 metres. dictated over extra ground 600 metres.

SHERIDAN (V Colgan) - made the bend awkwardly passing the 1800 metres having to be steadied when becoming awkwardly placed on heels.

LADY PIMPERNEL (S Spratt) - gave ground rounding the final bend and was not preserved with over the concluding stages. Stewards ordered a post-race veterinary examination of the mare which revealed a slower than normal recovery rate.

SHERIDAN and MASTER OF SPEED - bumped over the concluding stages when both runners shifted ground.

MASTER OF SPEED shifted in under pressure in the final straight.

Race 6 Cal Isuzu 1400

THATSFORSURE (S McKay) - was slow to begin and was then further hampered when **SNOWDRIFT** shifted in at the start.

ENOUGH (M Hills) - began awkwardly.

BUY ME A ROCK (D Prastiyou) - bounded at the start losing ground.

KEEP ON COMING (G Cooksley) - bounded at the start losing ground. Held up for several strides passing the 200 metres.

RITCHIE MCHORSE (R Hutchings) - had to steady momentarily shortly after the start when SNOWDRIFT shifted in.

FLOATING HEART (C Grylls) - made contact with DEEDEE PANACHE on two occasions when attempting to shift out to obtain clear running passing the 400 metres.

ODISHA (D Turner) – had to be firmly restrained passing the 100 metres when improving quickly on to the heels of SNOWDRIFT.

Race 7Foster Maintain 1600

MANGAROA FLO JO (J Nason) – slow to begin.

SANASAR (E Farr) - began awkwardly.

THE JUSTICE LEAGUE (D Turner) - bounded at the start and was further hampered when SHOW THE WORLD shifted out abruptly at the start. Lay in early in the run home crowding BREAKING DAWN who lost ground near the 300 metres.

ALL ROADS (D Prastiyou) - buffeted at the start when crowded by THE JUSTICE LEAGUE which had begun awkwardly And then raced keenly in the early stages. Held up rounding the final bend and early in the run home. Had difficulty obtaining clear running early in the final straight having to be firmly restrained passing the 300 metres when becoming awkwardly placed on heels.

BREAKING DAWN (B Hutton)-raced wide throughout.

PROMISE TO REIGN (V Colgan) made the 800 metre bend awkwardly and was held up for the majority of the run home and went to the line untested by its rider

PRINCE MAMBO (A Schwerin) -shifted inwards passing the 100 metres crowding and checking MANGAROA FLO JO. A Schwerin admitted a resultant breech of [Rule 638 (1)(d)] careless riding and after hearing submissions from all parties the Judicial Committee imposed a suspension of 4 days from the conclusion of racing on Saturday 18 March until the conclusion of racing on the 29 March 2017.

Race 8\$5K Punters Challenge 6th May 2017 (1600)

NIKITA (R Norvall) - raced fiercely in the early stages with the saddle slipping forward placing the rider R Novell in difficulty being unable to ride his mount to any extent for the remainder of the race.

SASANOF'S HERO (R Jones) - Slow to begin.then was held up passing the 300 metres having to shift ground outwards obtaining clear racing room passing the 200 metres.

WIDE AWAKE (R Hutchings) - Slow to begin.

WOODEN RED (G Cooksley) - jumped away awkwardly losing ground.

DRAGON DANCER (M Hills) - threw its head in the air on a number of occasions when being steadied in the early stages and continued to do so for a distance

PIECE OF KATE – (J Nason) -lay inwards throughout the run home passing the 300 metres made contact with TATTERS for a short distance. J Nason was reminded of his obligations when riding his mounts out to the finish. Raced wide for the majority of the race.
