## RACE COMMENTS:

<b>Race 1</b>	<b>EDINBURGH REALTY MAIDEN 1200m</b>
<b>MACHINEGUN KELLIE</b> (T Comignaghi) – Was declared a late scratching at 12.34 pm after refusing to load into its barrier. Trainer T Beckett was advised that the gelding must trial satisfactorily prior to racing next.	
<b>OLAF</b> (R Cuneen) – Slow to begin.	
<b>WHERE'S THE FORMAN</b> (C Barnes) – Blundered at the start and unbalanced rider losing ground.	
<b>BY MAGIC</b> (K Kalychurun) – Raced wide throughout.	

**JANEFIELD JEWEL** (J Lowry) – Rider lost whip passing the 300 metres.

**MADAME LIBRE** (S Wynne) – Crowded and had to be firmly restrained passing the 900 metres when PIPPI REA (C Johnson) shifted in when not fully clear. Rider C Johnson admitted a resultant breach of Rule 638(1)(d) careless riding with the JCA imposing a suspension of his rider's licence from the conclusion of racing 25<sup>th</sup> March up to and including 6<sup>th</sup> April 2017 (4 days).

**GEORGEIOUS GEORGE** (R Yatim) – Clipped a heel and blundered losing momentum passing the 900 metres when following MADAM LIBRE who was being restrained.

**INTENSE** (R Yatim) – Shifted inwards at the start contacting FRESHMAN. Raced wide without cover throughout.

**ROBIN CHARLES** (D Turner) – Began awkwardly losing ground.

**FRESHMAN** (W Papier) – Wide through the early stages. Commenced to weaken rapidly from the 400 metres finishing a distant last. Trainer S McGarry was advised that FRESHMAN must trial satisfactorily prior to racing again.

**NO NO NO YES** (T Comignaghi) – Blundered and lost momentum passing the 900 metres.

**MOTHER SUPERIOR** (S Wynne) – Had to be heavily restrained near the 400 metres when improving up onto the heels of the quickly weakening FRESHMAN. Steadied near the 170 metres when laying out and becoming awkwardly placed on the heels of INTENSE.

Stewards and senior riders conducted a track inspection in the area of the 900 metres after the incident involving the horse blundering. Following this inspection a meeting was held with all riders who were unanimous that the meeting should carry on.

**KING PIN** (K Kalychurun) – Slow to begin.

**HIGH FORTY** (C Campbell) – Began awkwardly.

**HELL RAISER** (C Johnson) – Raced three wide without cover throughout.

**ENZED JEWEL** (T Comignaghi) – Shifted out under pressure over the concluding stages.

**PASSITO** (D Turner) – Began to over race passing the 900 metres and had to be firmly restrained off the heels of KOFFEE 'N KREAM.

**SHANTAV** (S Wynne) – Trainer B Verlinden admitted a breach of Rule 614(2) in that she presented her runner in the incorrect saddle cloth with the JCA imposing a fine of \$50.00. Raced keenly for some distance passing the 1200 metres due to the lack of tempo.

**VILLA ELBA** (T Moseley) – Over raced when passing the winning post on the first occasion and got its head up when being restrained.

**INDIANA PEARL** (K Mudhoo) – Raced wide without cover from the 1400 metres. Hung inwards throughout the home straight when placed under pressure.

**ODI ET AMO** (L Hemi) – Raced wide from 1000 metres.

**OOR WULLIE** (J Lowry) – Shifted in when under pressure near the 200 metres and had to be straightened.

<b>Race 5</b>	<b>LYNDSAY MOYLE MEMORIAL MAIDEN 1600m</b>

**THE STYLE** (E Farr) – Began very awkwardly losing ground. Held up for several strides rounding the final bend having to shift outwards off the heels of the tiring DEZZIES DELIGHT. Lay in over the concluding stages and had to be straightened

passing the 50 metres.

**LARRIKIN** (K Mudhoo) – Began awkwardly losing ground.

**GAZZA THE GURU** (K Kalychurun) – Crowded shortly after the start. Rider reported that the gelding had raced disappointingly and he could offer no tangible excuses.

**SHIRLEY MAUDE** (S Wynne) – Raced keenly early. When questioned regarding the performance rider S Wynne could offer no tangible excuses. Stewards ordered a post-race veterinary inspection which revealed no abnormalities.

**PAPINA** (T Comignaghi) – Raced three wide without cover throughout.

**HIGHER AUTHORITY** (D Turner) – Lay in early in the run home and greenly over the concluding stages.

**DEZZIES DELIGHT** (C Johnson) – When questioned regarding the performance of the favourite rider C Johnson being unable to offer any tangible excuse. Stewards ordered a post-race veterinary inspection which revealed no obvious abnormalities other than a superficial laceration to the left hind leg.

**PUBLICANS CUP 1600m**

**VOLCANO** (S Wynne) – Crowded and lost ground at the start when GALLANT BOY shifted in. When spoken to regarding the performance of VOLCANO rider advised that after being hampered at the start she got further back than anticipated and when placed under pressure over the final stages had only battled. Miss Wynne further added that in her opinion the gelding was better suited to tracks of a firmer nature.

**KOXINGA** (D Skerrett) – Began awkwardly. Over raced in the early and middle stages.

**PRINCESS BROOK** (C Johnson) – Raced keenly through the early stages.

**LOCHAN ORA** (R Yatim) – Raced three wide without cover throughout.

**MY CHINO** (T Comignaghi) – Shifted out under pressure over the concluding stages.

**NZB INSURANCE PEARL SERIES RACE 1600m**

**ROYAL DOLLAR** (E Farr) – Slow to begin. Rider E Farr was issued a warning under Rule 648(5) when weighing in in excess of her weigh out weight.

**MADAM DE SOIR** (D Turner) – Slow to begin.

**POLLY'S SISTER** (T Moseley) – Raced wide without cover in the early and middle stages.

**GALELLA** (C Barnes) – Was held up passing the 200 metres and raced in restricted room over the concluding stages.
