IRISH CALL (S Wynne) – Was steadied when placed in restricted room to the inside of **GALLANT BOY** which shifted inwards going into the bend near the 700 metres. Apprentice S Wahab was warned under Rule 638(1)(d). Received contact to hind quarters near the 150 metres.

GALLANT BOY (S Wahab) - Made contact with the hind quarters of IRISH CALL when taken out by GALLANT DAN (C Barnes) near the 150 metres. C Barnes was advised she must exercise greater care.

PINZANO (K Williams) – Shifted outwards under pressure in the final straight finishing wider on the track.

QUARTZ REEF WINES RATING 65 1220m Race 4

DONTPOKETHETIGER (A Collett) – Was slow away. Had to be severely restrained off the heels of KASUNDI which was being steadied near the 500 metres when placed in restricted room to the inside of FLYTIME (S Wynne) which had MACY (C Johnson) racing to its outside. With footage of the incident proving inconclusive riders Wynne and Johnson were advised on this occasion to exercise greater care. PATRICK ERIN had to be steadied off the heels of DONTPOKETHETIGER at this point as well.

KASUNDI (G Jogoo) - Had to be steadied near the 500 metres.

PATRICK ERIN (J Lowry) – Steadied off heels 500 metres. Held up momentarily passing the 100 metres.

SHOWEMUP (C Barnes) – Was slow away. Finished a distance last. Rider reported the filly was making unusual breathing noises during the running. Stewards ordered a post-race veterinary inspection revealed a suspected soft palate displacement. Trainer S McKay advised that she believed the tongue tie had moved forward during the running.

FLYTIME (S Wynne) – Shifted outwards leaving the barriers making contact with KNUTQUACKER resulting in crowding to THEM OR US, PATRICK ERIN, ENTRÉE and IN DANGER.

THEM OR US (D Bothamley) - Had to be steadied for some distance passing the 700 metres when crowded by IN DANGER which shifted in when being steadied off the heels of the runner in front.

PASSITO (K Kalychurun) – Crowded and buffeted at 200 metres.

S Wynne – Admitted a charge of careless riding in that she permitted her mount FLYTIME to shift outwards near the 200 metres when there was insufficient room to do so buffeting **PASSITO** which was checked. After hearing submissions the Judicial Committee suspended Miss Wynne's licence to ride in races from Sunday 4th December until Thursday 15th December (5 days) inclusive.

WINGATUI FUNCTION CENTRE MAIDEN 2030m Race 5

DARCI INN (D Bothamley) – Was slow away.

MADAM DE SOIR (R Black) – Crowded leaving the barriers. R Black warned for unnecessary use of the whip over the concluding stages.

EYES WIDE SHUT (K Kalychurun) – Was allowed to stride forward through the middle stages to lead passing the 1000 metres.

SMOKEM UP (S Wynne) – Had to be steadied in the shadows of the post when awkwardly place on the heels of BARCLAY CREEK.

SHE ROCKS (G Jogoo) – Rider advised the mare had never travelled throughout and had been disappointing.

GAZZA THE GURU (R Hannam) – Lay in over the final 200 metres and had to be straightened on a number of occasions.

Race 6

STEINLAGER TOKYO DRY RATING 75 1400m

The start of this race was delayed due to **MR CONDUCTOR** arriving late in the Birdcage.

MR CONDUCTOR (R Hannam) – Hampered leaving the barriers when ZUCCHERO jumped inwards.

ZUCCHERO (D Bothamley) – Crowded and forced outwards making contact with POP 'N' LINDAUER having to steady when RIDEITLIKEYOUSTOLEIT shifted out at the 350 metres. G Jogoo was issued with a warning under Rule 638(1)(d).

FANTAMO (K Kalychurun) – Wide throughout.

Race 7

PAUL FERRIS MEMORIAL TROPHY 1400m

FULL COUNT (L Callaway) - Slow to begin. Steadied near the 900 metres when placed in restricted room to the inside of EL CHICO which shifted inwards when being steadied to avoid the heels of MEURSAULT (C Johnson) which shifted in when also being steadied. C Johnson was issued with a warning.

TIMY TYLER – Keen through the early stages.

MEURSAULT and **THYME ZONE** (T Moseley) were both crowded and buffeted momentarily passing the 150 metres when **SIGNIFY** (A Collett) shifted out under pressure. Rider A Collett was issued with a warning.

SPEIGHT'S RATING 65 2030m Race 8

HARDYS REVENGE (R Black) - Reared in the barriers and underwent a vet check before being cleared to start.

SERVE DE AUNT (J Lowry) – Began awkwardly and raced wide throughout.

MISSTEEFLYING (T Moseley) – Momentarily crowded on jumping. When spoken to about the improved performance of the mare trainer A Carston advised the mare had been unlucky in its second last start and raced very wide at its previous start and was aided today by the addition of a senior rider.

CONSOLIDATE (S Wynne) – Passing the 1000 metres had to shift out to avoid heels. Had to be steadied passing the 800 metres when the pace of the race eased momentarily.

SHANTAV (S Wahab) - Commenced to over race passing the 1000 metres then improved to the inside of CONSOLIDATE with those two runners racing in restricted room for some distance.

SKEEN (R Hannam) – Held up rounding the final bend until early in the run home.

SHEZATOUCHA (A Collett) – Held up for the majority of the run home and went to the line untested by its rider.

INVERCARGILL LICENSING TRUST 2030m Race 9

SADLERS ROCK (M Tanaka) – Was slow away.

GUNNA FLY (T Moseley) – Commenced to over race when being restrained near the 1800 metres continuing to do so into the middle stages. Weakened over the concluding stages with the rider reporting he was not happy with the horse's action. Stewards ordered a post-race veterinary inspection which found the gelding to have suffered from cardiac arrhythmia. The connections were advised that the appropriate veterinary clearance is now required prior to **GUNNA FLY** racing again.

KEEP THE COURAGE (K Kalychurun) – Raced wide without cover throughout.

STOKERS ROCK (S Wynne) – Rider dropped whip passing the 300 metres. Brushed with REVELATOR (K Williams) approaching the 100 metres. **REVELATOR** then lay out from this point and made contact again with **STOKERS ROCK** near the 50 metres.

Race 10 **OTAGO RACING CLUB MEMBERS RATING 65 1400m**

The start of this event was delayed significantly due to SNIPARINDA proving difficult to load with the connections advised **SNIPARINDA** was on a barrier manners warning.

BURWOOD (D Bothamley) – Began awkwardly.

MULBERRY (K Williams) – Was hampered at the start losing ground. K Williams admitted a breach of Rule 638(1)(d) careless riding in that she allowed her mount to shift in crowding and checking KING PIN passing the 50 metres.

CENTAVADA and **PRINCE RANSOM** were also shifted inwards off their racing line. After hearing submissions the Judicial Committee suspended Miss William's licence to ride in races from Saturday 3rd December until Friday 16th December inclusive (3 days).

CENTAVADE (J Lowry) – Crowded and shifted inwards passing the 50 metres.

PRINCE RANSOM (S Wynne) – Crowded and shifted inwards passing the 50 metres.

THE ENERGIZER (K Kalychurun) – Was slow to begin.

ROBIN CHARLES (R Black) – Raced keenly through the early stages.

TAPILIZE (C Johnson) – Raced wide throughout.

KING PIN (R Hannam) – Held up early in the run home. Connections viewed replays of the incident passing the 50 metres before deciding not to lodge a protest.

JIMMY (L Callaway) – When questioned regarding its performance rider L Callaway was unable to offer any tangible excuses.

Race 11 SEE YOU NEXT YEAR CROMWELL! RATING 65 1400m

WILD WINGS (R Hannam) – Was slow to begin.

OPIHI JADE (R Black) – Jumped away awkwardly getting its head up and then racing ungenerously in the early stages. Had difficulty obtaining clear running in the home straight until near the 100 metres.

ALICE WEBB ELLIS (K Williams) – Shifted away from FASCINATE near the 1000 metres inconveniencing JUSTICE WELL. Raced three wide without cover.

BUSHIDO (C Johnson) – Raced keenly through the early and middle stages. When spoken to regarding the performance rider C Johnson advised that the gelding had been keen through the early and middle stages and had failed to respond when under pressure and had been disappointing.

QUINTASTICS (G Jogoo) – Held up early in the run home.
