GENERAL:

Race 1 - Rangiora New World Maiden

Trainer A Carston requested a ruling under Rule 330(2) to determine whether he had an engagement with rider **C Johnson** to ride HEE'S OUR SECRET. After hearing all relevant submissions the Judicial Committee determined that A Carston had precedence.

RACE COMMENTS:

Race 1 RANGIORA NEW WORLD MAIDEN (1100m)

C Johnson defended a charge under Rule 330(3)(a) in that he broke a riding engagement for **HEE'S OUR SECRET**. After hearing all relevant submissions the Judicial Committee imposed a fine of \$500.

EXCUSE ME HONEY which contacted the running rail during the preliminary underwent a pre-race veterinary inspection and was cleared to race.

MACHA (A Collett) – Bounded as the start was effected.

STANDREWS MASONIC (K Williams) – Began awkwardly and was further hampered when awkwardly placed on heels.

GALISINI (S Wynne) – Made firm contact on jumping away, steadied near the 200 metres when awkwardly placed.

ALWAYS EXPLOSIVE (M Tanaka) – Made firm contact on jumping away.

JEPEZZ GEORGE (J Lowry) – Slow to begin.

MASTERS CHOICE (S Collett) – Raced ungenerously in the early stages and got its head up on a number of occasions, lay inwards near the 200 metres having to be straightened. Rider advised to exercise care when shifting ground.

HEE'S OUR SECRET (S Muniandy) – Raced keenly in the early stages. A post race veterinary inspection revealed atrial fibrillation, with the connections advised that a vet clearance is required prior to racing next.

DROUGHT BREAKER (L Callaway) – Held up momentarily near the 500 metres.

PIPPI REA (C Johnson) – Shifted ground inwards to obtain clear running passing the 200 metres.

Race 2 DUNSTAN FEEDS STAYERS CHAMPIONSHIP QUALIFIER (1800m)

THE BEAUT (L Callaway) – Blundered shortly after jumping.

MOONOFKLAIRESSA (S Collett) – Slow to begin.

MISTER SPIDERMAN (S Wynne) – Raced ungenerously in the middle stages, lay in throughout the home straight having to be straightened

The track was downgraded to Dead (5) following this race.

Race 3 GARRARDS HORSE & HOUND OPEN (1600m)

NO EMOTION (P Shaikh) – Blundered as the start was effected, shifted wider on the track early in the run home.

CLARA JANE (S Wynne) – Began awkwardly losing its footing behind and getting back. Rider S Wynne reported that the mare felt indifferent in its action over the concluding stages. A post race veterinary inspection did not reveal any obvious abnormalities.

SCHMECKENBECHER (C Barnes) – Raced wide throughout.

PRETTY GOOD EXCUSE (C Johnson) – Raced keenly throughout when in the lead.

Race 4 VALE WD SKELTON MAIDEN (1600m)

HOU LA LA (T Jonker) – Began awkwardly and then shifted out making firm contact with **BIG MAC**, raced keenly in the early stages.

POROTENE RIPPA (R Firdhaus) – Raced wide in the early stages.

ALLAQUILA (W Papier) – Steadied near 800 metres, rider dropped his whip near the 400 metres.

BIG MAC (J Lowry) –Firmly contacted at stat. Held up for some distance when awkwardly placed on heels near the 600 metres.

Race 5 DUNSTAN FEEDS RISING STARS CHAMPIONSHIP QUALIFIER (1400m)

LONG HARBOUR (T Moseley) – Bounded as the start was effected.

THE REAL DEAL (J Lowry) – Began awkwardly and got its head up, raced keenly in the early stages and got its head up on a number of occasions.

SHANZOU (R Firdhaus) – Began awkwardly and got back.

PAT IN BRACKETS (T Jonker) – Raced keenly early stages.

TIARA CONCERTO (S Collett) – Slow to begin, raced wide without cover throughout, shifted in abruptly over the concluding stages. Rider S Collett was reminded of her obligations when shifting ground.

Race 6 MIKE PERO MORTGAGES OPEN (1200m)

RED DIRT GIRL (S Muniandy) – Raced keenly in the early stages. Post race veterinary inspection revealed the mare to have been galloped on during the running.

DOUBLE BLUE (T Moseley) – Held up in the early stages of the home straight.

RIDING SHOTGUN (A Collett) – Shifted out passing the 250 metres making contact with **KINAGAT** passing the 200 metres before being straightened. **RIDING SHOTGUN** continued to lay out throughout the concluding stages. Rider A Collett admitted a charge of careless riding under Rule 638(1)(d) with the Judicial Committee suspending her licence to ride at races for 4 days effective 8 December to 11 December inclusive.

Following this race Stewards instigated a protest alleging interference by 1st placed **RIDING SHOTGUN** to 2nd placed **KINAGAT**. After viewing replays and hearing evidence the Judicial Committee dismissed the protest.

Race 7 ACCESSMAN CITY RATING 65 (1200m)

The start was officially delayed 4 minutes by the TAB as a result of the protest in the previous race.

The start was further significantly delayed when **FLASH SUGGESTION** dislodged rider J Lowry escaping out the front of the barriers taking some time to be recaptured. Stewards ordered the gelding to be late scratched at 6.47 pm. The connections were advised that **FLASH SUGGESTION** must barrier trial to Stewards' satisfaction prior to racing next.

OVERNIGHTSENSATION (C Kwo) – Began awkwardly losing its footing behind and got back.

GREY SAPPHIRE (S Collett) – Steadied shortly after the start when placed to the outside of **MYSTIFY ME** which was shifted wider by **MR TYPHON** (S Wynne). **S Wynne** was warned under Rule 638(1)(d).

EL BEE DARCI (K Williams) – Shifted out abruptly after jumping.

WAIPARI LAD (P Shaikh) - Raced keenly in the early stages.

GLOBAL GODDESS (T Jonker) – Raced in restricted room passing the 700 metres, appeared indifferent in its action over the concluding stages. A post race veterinary inspection did not reveal any obvious abnormalities.

Race 8 RACECOURSE HOTEL & MOTOR LODGE RATING 65 (1600m)

TANTELLA (G Jogoo) – Slow to begin, held up in the early stages of the home straight.

PLACID PRINCESS (J Lowry) - Slow to begin.

GOODTAGO (M Tanaka) – Began awkwardly and was restrained to the rear.

LETMEGO (W Papier) – Raced wide throughout.

KEARNEY (C Barnes) — Raced wide throughout.

RISING SON (C Johnson) – Over raced in the early stages, held up for some distance passing the 300 metres when in restricted room.

LUKANDER (P Shaikh) – Steadied when awkwardly placed on heels near the 800 metres.

Dividends were delayed in this race due to awaiting confirmation of $\mathbf{4}^{th}$ and $\mathbf{5}^{th}$ placings.
