RACE COMMENTS:

Race 1 SOUTHERN INSULATION HANDICAP (2500M)

LADY LINDAUER (K Mudhoo) – Slow to begin. Raced in restricted room through the early and middle stages of the home straight and was unable to obtain fully clear running over the concluding stages.

CONSOLIDATE (R Cuneen) – Raced wide through the early stages.

ZAH CHAMP (S Wahab) – Raced keenly in the early stages. Held up rounding the final bend and early in the run home and raced in restricted room over the concluding stages.

DOUBLE PANDA (S Muniandy) – Raced wide through the early and middle stages. Gave ground from the 500 metres.

PAW PATROL (C Johnson) – Raced very keenly through the early to middle stages. Rider reported the gelding had failed to see out the distance of today's race.

BLUES BREAKER (K Kalychurun) – Raced wide from the 1000 metres.

Race 2 TRANSIT HOMES HANDICAP(1100M)

ENZEDJEWEL (K Mudhoo) – Began awkwardly making firm contact with the outside gate.

KARAKA DAWN (C Johnson) – Made the first bend awkwardly. When questioned regarding the performance rider reported the mare had only battled in a fresh state.

DERMOTT BROWN (T Moseley) – Raced wide through the early stages.

PAINTBALL (L Callaway) – Had to be angled wide rounding the final bend then lay in early in the run home.

THE BARMAID (J Lowry) — Held up rounding the final bend. Ran out of racing room in the shadows of the post when improving onto the heels of ENZED JEWEL.

Race 3 PETER BELLEW MEMORIAL HANDICAP (1400M)

MISS GEE JAY (K Kalychurun) – Began awkwardly losing ground.

BEETHOVEN (S Muniandy) – Dipped passing the 1100 metres, then raced keenly in the early stages and had to steady outwards off heels passing 1000 metres. Lay in passing the 125 metres and when being straightened hampered OVER TAKE who had to steady.

SILVER SPIER (K Selvan) – Raced wide through the early to middle stages.

TAPONISME (C Johnson) – Raced greenly and made the bend near the 1000 metres very awkwardly resulting in **BEETHOVEN** having to be steadied off heels.

TANIWHA (D Skerrett) – Raced wide throughout. Forced wider at 100 metres.

THE YOUNG PRETENDA (D Bothamley) – Raced in restricted room rounding the final bend. Failed to obtain clear racing room throughout the home straight and went to the line untested by its rider.

HIGHER AUTHORITY (R Cuneen) – Momentarily held up passing the 300 metres and had to be angled wider on the track to find clear racing room. Forced wider on track at 100 metres.

OVER TAKE (S Wahab) – Had to steady passing the 125 metres.

SATIN JITTERBUG (K Mudhoo) – Held up rounding the final bend and had to steady off heels passing the 100 metres.

NESTA (L Callaway) – Forced wider on track at 100 metres.

KRUGER RAND (G Jogoo) – Lay in passing the 100 metres and when being corrected shifted out resulting NESTA, TANIWHA and HIGHER AUTHORITY all being obliged to shift wider on the track.

BLACK LIZZIE (C Barnes) – Rider reported the mare had hung throughout.

Race 4 NIGEL ROBERTSON BUILDING HANDICAP (1400M)

INDIANA PEARL (K Mudhoo) - Slow to begin. Raced keenly in the early stages and wide throughout.

SHAKTI (T Moseley) – Began awkwardly losing ground.

RIDEITLIKEUSTOLEIT (G Jogoo) – Momentarily crowded and had to steady passing the 900 metres when FANTAMO shifted in. **K Kalychurun** (FANTAMO) was advised he must exercise greater care when shifting ground.

CIVIC RECEPTION (D Bothamley) – Held up rounding the final bend only gaining clear racing room passing the 175 metres.

WAYLAY (S Muniandy) - Held up rounding the final bend.

Race 5

JESCO HYDRAULICS HANDICAP (1200M)

SIR JACK REMINGTON (K Kalychurun) – Began awkwardly, shifted out and blundered momentarily losing ground. Held up rounding the final bend and early in the run home.

KING PIN (S Muniandy) - Crowded shortly after the start losing ground when inside runners shifted out.

TAPILIZE (J Lowry) – Slow through the early stages.

MIA MAMMA (G Jogoo) – Over raced through the early stages.

TICKETS ON HER (C Johnson) – Raced keenly through the early to middle stages and had to be severely restrained off heels passing the 600 metres when NATURAL CASH commenced to give ground.

MY SWISSMISS (K Selvan) – Raced wide without cover throughout.

KOFFEE 'N' KREAM (C Barnes) - Raced wide throughout.

NATURAL CASH (R Cuneen) – Gave ground from 600 metres. Returned to the birdcage with blood present in both nostrils. A post-race veterinary examination revealed NATURAL CASH to have bled with the gelding subsequently stood down for the mandatory 3 month period.

RUTHERFORD (R Yatim) – Returned to the birdcage with blood present in both nostrils. A post-race veterinary examination revealed RUTHERFORD to have bled with the gelding subsequently stood down for the mandatory 3 month period.

Race 6

WORLD SOLAR HANDICAP (1200M)

FASTFOOT (S Wahab) – Slow to begin.

KOXINGA (D Skerrett) – Began awkwardly losing ground. Raced wide throughout. Trainer W Humphries advised **KOXINGA** would now be sent for a spell.

MADAM BENTLEY (C Johnson) – Raced keenly in the early stages.

MAGIC EPIC (S Muniandy) – Held up rounding the final bend and early in the run home.

Race 7

AWS LEGAL SOUTHLAND CRYSTALS (2160M)

PRINCESS BROOK (C Barnes) – Began awkwardly. Lay out shortly after the start crowding OOR WULLIE. Crowded near the 200 metres having to shift ground outwards to find clear racing room and in doing so bumped with OOR WULLIE.

COME FLY WITH ME (L Callaway) – Shifted ground inwards shortly after the start crowding SUREASYOUWEREBORN who was checked. When questioned regarding the performance of favoured runner rider L Callaway advised the mare may be feeling the effects of recent racing.

SUREASYOUWEREBORN (T Moseley) – Veterinary clearance received. Crowded and forced inwards shortly after the start and then raced keenly in the early stages throwing its head around on a number of occasions and made the crossing by the 1600 metres awkwardly.

OOR WULLIE (S Muniandy) – Severely checked shortly after the start when crowded between SUREASYOUWEREBORN who was forced in when COME FLY WITH ME shifted inwards and PRINCESS BROOK who was laying out shifted out abruptly at this point.

MY CHINO (C Johnson) – Held up rounding the final bend and early in the run home. Shifted outwards off the heels of STOKERS ROCK near the 200 metres crowding PRINCESS BROOK who had to shift wider on the track. **C Johnson** was issued with a warning under Rule 638(1)(d). Then gained clear racing room passing the 150 metres.

L Callaway admitted a breach of Rule 638(1)(d) the particulars being that he allowed his mount to shift ground inwards when insufficiently clear of SUREASYOUWEREBORN who was checked shortly after the start. After viewing replays and hearing submissions on penalty the JCA suspended Mr Callaway's licence to ride from the conclusion of racing on the 10th December up to and including the 18th December (2 days).

Following the running of this event Apprentice R Cuneen was examined by St John Ambulance Paramedics and stood down from his remaining rides after advising he was suffering from a sore neck. Apprentice Cuneen was advised a medical clearance would be required prior to him riding next.

Race 8 AON INSURANCE BROKERS HANDICAP (1600M)

THE ENERGIZER (K Kalychurun) – Slow to begin.

STOLEN HEART (K Mudhoo) – Slow to begin. Held up rounding the final bend when attempting a marginal run to the inside of WILD JACK.

QUINTASTICS (R Yatim) – Slow through the early stages. Lost contact with the body of the field passing the 800 metres when the pace increased despite the efforts of its rider. Shifted in abruptly at the 100 metres and had to be straightened

PETER PARKER (C Barnes) – C Barnes replaced R Cuneen. Raced wide through the early to middle stages.

WILD JACK (L Callaway) – Held up rounding the final bend.

Race 9 TIM YEO CONTRACTING HANDICAP (1600M)

LOCHAN ORA (S Wahab) – Slow to begin. Improved wide rounding the final bend. When questioned regarding the performance of favoured runner Apprentice rider S Wahab advised in his opinion the gelding had been outpaced on the firm going.

FULL COUNT (K Kalychurun) - Had to be steadied when racing keenly passing the 1400 metres.

Race 10 INVERCARGILL LICENSING TRUST HANDICAP (1600M)

SNIPARINDA (R Cuneen) – Late scratching at 4.00pm due to no suitable replacement rider being available.

JIMMY (K Selvan) – Slow to begin.

CENTAVADA (J Lowry) – Raced wide through the early and middle stages.

THOUGHT THAT (C Johnson) – Raced wide throughout.

GRETA VALLEY (R Yatim) – Held up and had to steady passing the 450 metres by the tiring THE HEAT IS ON. Made the final bend awkwardly.

THE MAN (C Barnes) – Returned to the birdcage with injuries to a hind leg. A post-race veterinary examination revealed the gelding to have suffered an injury to the right hind fetlock consistent with having been galloped on during the running.
