TATTERS (J Waddell) – Co-trainer S Autridge advised that he was satisfied with the recovery of TATTERS following its performance in this race further advising that blood tests had been conducted which did not reveal any abnormality.

EL PISTOLA (T Thornton) – Co-trainer N Hanley advised Stewards that he was satisfied with the recovery of EL PISTOLA following its performance in this race, adding that it is his intention to continue on with its current preparation.

Race 1	TE AROHA LIQUOR 1200
<p>NAPLES (J Waddell) – Began awkwardly then further hampered when bumped losing ground. Made the bend near the 850 metres awkwardly.</p> <p>KOOL CONNECTION (D Johnson) – After being fractious in the barriers shifted inwards on jumping away making contact with NAPLES.</p> <p>RASPBERRY SWEET (C Grylls) – Slow to begin.</p> <p>JUST FOR KICKS (M Tanaka) – Raced three wide without cover throughout.</p> <p>AILEEN GRACE (M Cameron) – Had a tendency to race greenly throughout with rider advising that he had recommended to connections a change of bit.</p>

<p>JUSTACANTA (M Coleman) – Slow away.</p> <p>LOVE AFFAIR (O Bosson) – Raced keenly in the early stages.</p> <p>MYSTERY SHOW (D Johnson) – Placed in restricted room near the 200 metres when SHARP PROPOSITION lay out under pressure and MISS DALGHAR (J Waddell) lay in. Had to be steadied to avoid the heels of MISS DALGHAR which when continuing to lay in shifted inwards near the 100 metres when its rider was transferring his whip to his left hand. J Waddell was issued with a warning.</p>	
Race 3	FLAIR 2200
<p>BLUE LAGOON (D Johnson) – Made slight contact with APPREHEND when shifting outwards to obtain clear running near the 350 metres.</p> <p>APPREHEND (C Grylls) – Brushed 350 metres.</p> <p>THAILAND (S Collett) – Lay in behind DALEZINGA early in the final straight, and after being corrected by its rider then had to be steadied away from the heels of SYMPHONIC near the 250 metres.</p> <p>SLICE OF CAKE (V Colgan) – When questioned regarding performance rider was unable to offer any excuses.</p>	
Race 4	J SWAP TE AROHA CUP
<p>CLARIFY (S McKay) – After failing to improve into a tight run between SANASAR and ZARTAN early in the final straight then became awkwardly placed near the heels of ZARTAN for a distance approaching the 200 metres before shifting outwards across that runner's heels to obtain clear running near the 150 metres. When questioned rider S McKay advised that the gelding had initially felt reluctant to improve into a tight run, and had then been inclined to lay inwards when he was attempting to shift outwards across heels. S McKay's explanation was noted.</p> <p>SANASAR (J Riddell) – When questioned regarding performance rider was unable to offer any excuses.</p>	
Race 5	PYRAMID TRUCKING 1200

LEWIS CAROLL (O Bosson) – Over-raced when being restrained passing the 1000 metres, shifting outwards to avoid the heels of DANCING FLAMES (M Cameron) near the 900 metres when DANCING FLAMES was being steadied, inconveniencing TEMPLE TIGER which then raced ungenerously for a distance. Rider M Cameron was spoken to regarding the manner in which he eased the pace.

BATTLE TIME (Z Nor Azman) – Had to be firmly restrained after improving on to the heels of DANCING FLAMES rounding the bend near the 600 metres.

TEMPLE TIGER (M Hills) – Inconvenienced 900 metres then raced ungenerously for a distance. Had to be steadied when crowded onto PERSUASIVE over the concluding stages when BATTLE TIME shifted outwards. Apprentice Nor Azman was advised to exercise greater care. Contributing was some inward movement from GALAXY MISS.

PERSUASIVE (S Weatherley) – Rider dropped the right rein near the 75 metres. Steadied when crowded concluding stages.

Race 6	TE AROHA PLUMBING & DRAINAGE 1400

LIGHT SHADOW (S McKay) – Slow to begin. Raced ungenerously when being restrained in the middle stages.

ODISHA (M McNab) – Hampered leaving the barriers when LUEN YAT MIRACLE lay out away from NO NEED. Rider was unable to offer any excuses for poor performance. A post-race veterinary examination did not reveal any abnormality.

BAYMAX (M Vance) – Made contact with the running rail when shifting away from LUEN YAT MIRACLE which lay in going into the bend near the 850 metres despite the efforts of its rider.

KILLARNEY (M Cameron) – Hampered leaving the barriers. Held up rounding the final turn, and again early in the final straight before obtaining clear running passing the 200 metres.

MALIBU MISS (D Johnson) – Lost the left front plate during the running.

LATE DECISION (S Sprat) – Slow to begin.

JOCHEN RINDT (G Saejorhor) – Had to be steadied near the 1100 metres when crowded for room to the inside of SEIZE THE MOMENT which was taken in by SOUTHERN ICON (M Hills). M Hills was issued with a warning.

CHOCANTE (D Johnson) – Raced ungenerously when being steadied after becoming awkwardly placed near the 1100 metres.

WATCH THIS SPACE (C Grylls) – Raced three wide without cover.

PACKING TYCOON (M Du Plessis) – Had difficulty obtaining clear running until near the 250 metres.

SOFIA ROSA (D Johnson) – Began awkwardly and shifted outwards making contact with BIG DREAMER which was crowded. Made the bend near the 850 metres awkwardly making contact with the hind quarters of RISING SHOT.

BIG DREAMER (M Tanaka) – Crowded start losing ground.

LUCYINRIO (S Collett) – Over-raced when being restrained passing the 1000 metres.

RISING SHOT (M Du Plessis) – Bumped 850 metres. Raced three wide without cover.

CHARMONT (M Cameron) – Held up early in the final straight until obtaining clear running passing the 250 metres. Lost the right front plate during the running.

GIRL OF MY DREAMS (M McNab) – Rider was unable to offer any excuses for poor performance with a post-race veterinary examination finding the mare to have a delayed recovery with an elevated respiratory rate. Trainer Mr N Tiley indicated that the mare was now likely to be retired.

Race 9

TE AROHA VETERINARY SERVICES 1600

ARRAIGNMENT (D Danis) – Began awkwardly shifting out making firm contact with **COSTA BRAVO**. Raced wide throughout. Lay in under pressure in the final straight.

COSTA BRAVO (V Colgan) – Bumped start becoming unbalanced. Over-raced in the middle stages.

DEMELZA (M Cameron) – Slow to begin. Unable to obtain clear running until inside the final 200 metres.

MAXIMILLIEN (J Riddell) – Slow to begin. Hampered and forced wider on the track 900 metres.

MY PRIDE AND JOY (M Coleman) – Jumped away awkwardly.

BIG MIKE (D Johnson) – Over-raced badly when being restrained passing the 1400 metres and continued to do so into the middle stages, shifting outwards abruptly to avoid the heels of **SWINGING SKIRTS** near the 900 metres hampering **MAXIMILLIEN** which was forced wider on the track.

TRUDEAU (M McNab) – Unable to obtain clear running in the final straight.

YOUWANTMORE (C Grylls) – Had difficulty obtaining clear running in the final straight.

D Danis - Admitted a charge of careless riding in that he permitted his mount **ARRAIGNMENT** to shift inwards when not sufficiently clear crowding **HOT SAKI** which was checked near the 250 metres. After hearing submissions the Judicial Committee suspended his licence to ride in races from the conclusion of racing on Wednesday 12 March until the conclusion of racing on Monday 17 March, 3 riding days.

SASANOF'S HERO (S Weatherley) – Held up entering the final straight then having some difficulty obtaining clear running for the majority of the straight.
