#### **RACE COMMENTS:**

#### Race 1 BULK LINES LTD 2100

**MR KANTON** (T Newman) – Began awkwardly. Commenced to over-race in the early stages and shifted out near the 1700 metres when becoming awkwardly placed on heels forcing UABASSO wider.

**UABASSO** (T Thornton) – Forced wide near the 1700 metres then over-raced for a distance. Briefly steadied passing the 500 metres when awkwardly placed.

**MARTINIZ SPECIAL** (R Elliot) – Lay out in the early stages. When questioned regarding the performance R Elliot advised that the gelding had failed to handle today's track conditions.

## Race 2 STE INDUSTRIAL ELECTRICAL 1200

**WOODEN EDGE** (H Marzuki) – Trainer **C Wood** was fined \$100 under the minor infringement schedule for failing to declare a change of gear by the required time. Began awkwardly. Became awkwardly placed near the 300 metres when laying in.

**AZ GIVEN** (T Thornton) – Over-raced in the early stages.

**MCCULLUM** (Z Nor Azman) – Raced keenly in the early and middle stages.

**STOCKTAKE** (A Sims) – Had to be restrained off the heels of MCCULLUM (Z Nor Azman) near the 900 metres which shifted in when not fully clear. Apprentice Z Nor Azman was reprimanded and advised that he must exercise greater care.

## Race 3 GARTHSHORE RETAIL FIT OUTS 1600

Apprentice **E Farr** was fined \$200 under the minor infringement schedule for failing to make the contracted weight on IN A MINUTE. E Farr was replaced by R Elliot.

**ADRIATIC PEARL** (T Thornton) – Crowded shortly after the start.

**OCEAN EMPEROR** (M Hills) – Over-raced when being restrained in the early to middle stages. Taken wide entering the final straight in an attempt to gain better footing.

**MAXIMUM HEIGHT** (A Jones) – Raced three wide without cover throughout.

**IN A MINUTE** (R Elliot) – Apprentice **R Elliot** admitted a charge in that he used his whip excessively prior to the 200 metres with the Judicial Committee suspending R Elliot's licence to ride in races from the conclusion of racing on 25 April until the conclusion of racing on 5 May, 7 riding days.

## Race 4 TASTE OF ASIA MOUNT MAUNGANUI 1400

**MERITAGGIO** (C Grylls) – Began awkwardly then commenced to over-race through the early stages.

JOHN GREY (J Nason) – Began awkwardly, losing ground.

**SEVENTH UP** (G Cooksley) – Lay out under pressure inside the final 100 metres inconveniencing HAYLEY GRACE which was dictated wider on the track.

**DANZA LAD** (L Satherley) – Crowded on jumping away.

## Race 5 DOMINATOR GARAGE DOORS TAURANGA 1200

**AMBER RAYNE** (T Wenn) – Trainer **N Bishara** was issued with a warning for presenting AMBER RAYNE without notified gear (blinkers).

**LOLA JANE** (S Spratt) – Slow to begin.

**CLASSIC WARRIOR** (R Norvall) – Got its head up shortly after jumping away then raced ungenerously for a distance, making the bend awkwardly near the 900 metres.

**CHATHAM WHISPER** (C Grylls) – Raced in restricted room soon after the start.

**ACRYLIC** (G Cooksley) – Raced in restricted room soon after the start.

**GRAYSON** (E Farr) – Raced in restricted room soon after the start.

### Race 6 ANDREW AND LOUISE MARRIED TODAY 2100

**MOTUMAN** (J Nason) – Shifted out when placed under pressure in the final straight inconveniencing ESKIMO KISS near the 175 metres and then continued to shift out over the concluding stages.

ESKIMO KISS (Z Nor Azman) – Inconvenienced 175 metres.

# Race 7 ICON SECURITY TAURANGA 1600

**ARTERIAL** (L Satherley) – Had to briefly steady passing the 400 metres with rider L Satherley losing the use of her whip which became entangled for a short distance. Rider **L Satherley** admitted a charge in that she used her whip excessively prior to the 200 metres with the Judicial Committee suspending L Satherley's licence to ride in races from the conclusion of racing on 21 April until the conclusion of racing on 29 April, 4 riding days.

**QUEEN EL JAY** (R Elliot) - Apprentice **R Elliot** admitted a charge in that he used his whip excessively prior to the 200 metres with the Judicial Committee suspending R Elliot's licence to ride in races from the conclusion of racing on 5 May until the conclusion of racing on 24 May, 9 riding days.

**BROOKBARS** (S Spratt) – Rider **S Spratt** was reminded of her obligations with regard to her whip use prior to the 200 metres and further advised that a warning would be placed on her record.
