## RACE COMMENTS:

Race $1 \quad$ FRUITFED SUPPLIES RACEDAY 11 MAY MILE (1600 metres)
HELVETICA (N Teeluck) - began awkwardly. Raced ungenerously passing the 1200 metres

STRUT (R Jones) - Made the first bend awkwardly then continued to race greenly throughout, hanging outwards making the final turn.

WAIZ ONE (L Hemi) - held up when in tight quarters early in the home straight having to be restrained and angled across heels to gain clear running passing the 200 metres

FOGARTY FEGEN (J Parkes) - lay in under pressure over the final stages

## Race 2 PRODRIVE GOLF WELLINGTON 2YO (1200 metres)

SMOKIN' OAK (S Collett) - Prior to the start being effected, SMOKIN' OAK pushed open it's gate but was quickly regathered by its rider and after undergoing a veterinary examination was cleared to start. After being slow away the gelding commenced to over-race when three wide without cover so was taken forward near the 800 metres but was unable to cross to the lead. When questioned into the run S Collett was of the opinion the gelding did too much in the early and middle stages when wide and had little left at the finish. A post-race veterinary inspection failed to reveal any abnormality

AUTHENTIC CHARM (R Hannam) - was slow away

WISHFUL (S McKay) - was checked when improving into a run near the 100 metres when COME IN SPINNER (R Jones) shifted in under hard riding and was not clear.
$R$ Jones admitted a resultant charge of careless riding under [Rule 638 (1)(d)] and had his licence to ride in races suspended from the conclusion of racing Wednesday May $3^{\text {rd }}$ up to and including Saturday May $6{ }^{\text {th }}$ ( 3 days)

VAN HALEN (C Johnson) - raced in restricted room approaching the 200 metres

HE'S A FREAK (D Bradley) - was unable to obtain clear running in the straight and went to the line untested.

JIMMY LINCOLN (M Tanaka) - shifted out under pressure near the finish resulting in VAN HALEN shifting out and away from that runner into the line of PLATINUM VOLOS which was checked, also contributing to the incident was inward movement from COME IN SPINNER

PLATINUM VOLOS (J Riddell) - checked near the finish

## Race 3 LIVAMOL AUTUMN STAKES (1400 metres)

SOUTHERN ICON (R Hannam) - Prior to the start being effected SOUTHERN ICON pushed open it's gate but was pulled up after galloping a short distance and after being presented behind the barrier was cleared to start by the veterinary surgeon. A post-race veterinary inspection failed to revealed any abnormality

PROFILE (J Parkes) was slow away

KAIRANGA LAD (N Teeluck) - commenced to over-race for some distance rounding the first turn and into the back straight and brushed the running rail near the 1000 metres

NOTIONANNAGINS (R Hannam) - R Hannam was advised to exercise more care when shifting ground when angling his mount in near the 1400 metres resulting in CAPTAIN LINCOLN being steadied

CAPTAIN LINCOLN (J Riddell) - steadied at the 1400 metres

OCEAN EMPEROR (J Parkes) - raced wide early in the back straight
GOODSAV (C Johnson) - raced wide throughout

## Race 5 TRINITY HILL MILE (1600 metres)

MASU - D Bradley replaced H Tinsley. Held up early in the home straight having to be angled outward across heels to obtain clear running near the 250 metres

TATTERS (S McKay) - Tongue tie become dislodged and was unable to be replaced
STAR EMERALD (L Hemi) - raced three wide without cover throughout
FASTNET FIRE (M Tanaka) was held up rounding the turn and early in the home straight
HUNTA PENCE (C Johnson) - held up momentarily approaching the 250 metres
LADY GUINNESS (L Allpress) - lay out under pressure over the final stages.
The Rayner partnership were issued with a warning under Rule 616 (4) after presenting FLYING FLETCH with gear which was not notified (Blinkers)

## Race 6 VERTIGO CATERING @HB RACING 2100 ( 2100 metres)

TICKET CLIPPER (L Allpress) - was slow away and then raced keenly in the early and middle stages
VOLTS (K Cowan) - commenced to race keenly on entering the back straight
WAIT A SEC (J Parkes) held up passing the 800 metres
ALI BABA (R Jones) -when questioned into the run, $R$ Jones advised the gelding was unable to quicken when the tempo of the race increased in the middle stages.

## Race 7 HAWKE'S BAY OWNERS ASSOCIATION 1200 (1200 metres)

HOVER (S McKay) - was awkwardly away and then commenced to over-race for a short distance
Apprentice jockey K Cowan (SAVE THE STARS) admitted a breach of [Rule 638(1)(d)] - careless riding - in that she allowed her mount to shift in shortly after the start dictating STORYTIME (S MacNab) inwards onto WORLDCLASS (D Turner) which was checked and lost ground.
K Cowan had her licence to ride in races suspended from the conclusion of racing Thursday May 4th up to and including Thursday May $11^{\text {th }}$ (3 days)

WORLDCLASS (D Turner) - checked near the 1100 metres
SWISS ELLE (R Harris) - over-raced in the back straight and hung outwards near the 800 metres losing ground.
DIRECT CAPITAL (L Hemi) - three wide throughout
SAVE THE STARS (K Cowan) - Began awkwardly. Had to be steadied off heels near the 800 metres when ANIMATOR hung inwards into its line. Held up in the early part of the home straight and raced in restricted room shortly after.

ANIMATOR (J Riddell) - hung throughout and could not be ridden to full advantage in the final straight
STORYTIME (S MacNab) - raced in restricted room in the home straight contacting the rail on several occasions
approaching the 200 metres.

## Race 8 STELLA ARTOIS 1200 (1200 metres)

HOWBOWDAT (M Vance) -reared as the start was made and was then further hampered when OSCAR'S SHADOW (M Tanaka) crowded HIGH DISTINCTION (S Collett) into its line, resulting in HOWBOWDAT settling back

BOTANIC (H Andrew) - attempted to buck shortly after the start prior to settling. Connections were advised that a warning is placed against the mare regarding its racing manners. Raced wide without cover throughout

BALLYCHINE (J Parkes) - shifted in when being steadied near the 1000 metres resulting in HIGH DISTINCTION being tightened. Continued to over-race and had to be steadied for some distance near the 800 metres

HIGH DISTINCTION (S Collett) - tightened near the 1000 metres

SOLOMON (K Cowan) - was tightened when weakening near the 200 metres when runners either side shifted ground.

M Tanaka (OSCAR'S SHADOW) was reminded of his obligation regarding the use of his whip on a runner out of contention

BUSHFIRE (J Riddell) - J Riddell was questioned into his ride, in particular his lack of vigour over the final stages where he appeared to not ride his mount out fully to the finish. J Riddell advised that his mount was inclined to shift inwards throughout the home straight. He was concerned that he may have shifted into the line of and crowded SHERPA (R Hannam) near the 100 metres which was racing to his inside. J Riddell added that he had limited room to improve into over the final stages and was aware DANMULLAN (D Bradley) which was racing to his outside, was inclined to shift ground inward under pressure.
Race $9 \quad$ TIVACI@ WIKATO STUD 1400 (1400 METRES)
TEMPLE TIGER (D Danis) - underwent and passed a veterinary inspection prior to the start after becoming fractious in its gate. Tightened and got back at the start

HUNDYAMONTH (K Cowan) - was hampered at the start when tightened by runners either side, then raced three wide without cover throughout

COERCED WITNESS (J Riddell) - made the first bend awkwardly

BREAK MY STRIDE (J Parkes) - raced in restricted room near the 200 metres
