## RACE COMMENTS:

Race 1 Iplex Pipelines NZ 1600

TWIXT (C Grylls) - Slow to begin.

**OUR SISTERS SECRET** (S Collett) - Jumped away awkwardly losing ground.

**READY TO RUMBLE** (S Spratt) - Raced wide for the majority of the race.

**LEICA LADY** (D Johnson) – D Johnson advised that the filly had not travelled well throughout the race. LEICA LADY underwent a subsequent veterinary examination which could find no obvious abnormalities.

L Satherley MUELED - Reminded of her obligations with regard to whip use with a horse that is out of contention.

**S Spratt** READY TO RUMBLE - Reminded of her obligations with regard to whip use with a horse that is out of contention.

Race 2 Virkon 1200

**TUIGOLD** (S Collett) - Restrained in the early stages after drawing a wide barrier.

TEARANITA (M Du Plessis) - Began awkwardly.

EITILT (D Johnson) – Raced keenly when being steadied passing the 900 metres.

Race 3 Balance Agri-Nutrients 1400

**SACRED SIREN** (T Harris) - Crowded after leaving the barriers.

AVEC MOI (C Lammas) – Crowded soon after leaving the barriers and then recovered to lead.

**I PACO** (M Hills) - Began awkwardly. Raced wide without cover for the majority of the race.

**HUAYRA** (M Cameron) - Crowded soon after leaving the barriers making contact with the hind quarters of SINGLE SHOT which became unbalanced. Raced wide without cover for the majority of the race.

**SINGLE SHOT** (H Marzuki) – Contacted and unbalanced soon after leaving the barriers.

**WAR STORY** (L Satherley) - Raced ungenerously when being restrained in the early and middle stages. Briefly crowded when weakening to the inside of ANIMATOR which lay in passing the 250 metres.

**ANIMATOR** (D Johnson) – Commenced to race ungenerously when the pace steadied approaching the 1200 metres shifting in and crowding MAESTRO MAX which had commenced to fiercely. ANIMATOR then continued to race keenly shifting out and racing wide form the 800 metres.

MAESTRO MAX (C Johnson) - Raced fiercely in the early and middle stages.

**MAENOHA** (A Collett) - Rider A Collett reported that the filly made unusual breathing noises with the filly undergoing a veterinary examination including an endoscopic examination which showed a small ulcer on the tip of the epiglottis. Trainer R Prescott advised that MAENOHA will undergo further investigations when it returns to its stable.

 Race 4
 Farmlands Hautapu 2100

 M McNab was fined \$350.00 after failing to make the contracted weight for TWINKLES. M McNab was replaced by D Johnson.

**GENTIL TONTON** (S Weatherley) – Crowded leaving the barriers losing ground.

**TWINKLES** (D Johnson) - Steadied when awkwardly placed 1600 metres. **D Johnson** was issued with a warning for weighing in 0.7 kilograms above the weight in which she weighed out.

**FRANCIS DRAKE** (C Johnson) - Raced keenly in the early and middle stages. Had to shift out passing the 350 metres to obtain clear running.

Race 5 DLF Seeds NZ 2100

**NOTHING TRIVIAL** (D Danis) – Crowded shortly after leaving the barriers. Raced wide without cover for the majority of the race.

**DIVINE DUKE** (C Grylls) – Raced ungenerously when being steadied off heels passing the 1600 metres. When questioned regarding the improved performance, stable representative D Weatherley advised that the gelding had appreciated today's step up in distance, further advising that DIVINE DUKE had worked well leading into today's race and the stable was confident of an improved performance.

**SHOCK HORROR** (M Cameron) – Commenced to give ground passing the 800 metres and was not persevered with in the final straight. SHOCK HORROR underwent a veterinary examination which found the gelding to have an elevated respiratory rate and a delayed recovery.

LONG HARBOUR (V Colgan) - Raced ungenerously when being steadied off heels near the 1000 metres.

**SHEEZ THE BOSS** (A Collett) - Held up for a distance passing the 600 metres, SHEEZ THE BOSS then shifted out abruptly to avoid the heels of SHOCK HORROR which was weakening appreciably, hampering ARITE GURU which clipped a heel and blundered.

ARITE GURU (R Scott) – Hampered 500 metres clipping a heel and blundering.

HILARIOUS (S Collett) - Steadied near the 500 metres when in restricted room.

**STREET SMART** (C Johnson) - Hampered near the 350 metres by NINA ARORA (M McNab) which shifted out abruptly when improving on to the heels of ESKIMO KISS. **M McNab** was reprimanded by Stewards and advised he must exercise greater care when shifting ground. He was further advised that a warning would be placed on his record.

## Race 6 McMillan Equine Feeds 1200

**CITY BOY** (A Collett) – Knuckled shortly after leaving the barriers, shifting in making heavy contact with AMASTAR which was crowded on to MIGHTY ME which made heavy contact with the hind quarters of PAPPA RAGAZZO which then commenced to lay out. As a result PAPPA RAGAZZO shifted out, further crowding MIGHTY ME on to AMASTAR and CITY BOY which was forced on to the hind quarters of ROSE IMPERIAL which became badly unbalanced. MIGHTY ME, AMASTAR, CITY BOY and ROSE IMPERIAL were all badly hampered as a result, losing ground.

**MIGHTY ME** (M McNab) - Hampered soon after the barrier losing ground.

**AMASTAR** (D Johnson) - Hampered soon after the barrier losing ground. D Johnson advised that after suffering interference shortly after leaving the barriers the filly had not recovered.

**ROSE IMPERIAL** (V Colgan) - Hampered soon after the barrier losing ground.

ALAMER (S Collett) – Crowded and steadied passing the 900 metres when in restricted room to the inside of BLUE SHADOW (S Spratt) which shifted in when not sufficiently clear. PAPPA RAGAZZO who was racing to the inside of

ALAMER raced in restricted room and was also steadied. **S Spratt** was severely reprimanded by Stewards and further advised that a warning would be placed on her record.

PAPPA RAGAZZO (J Fawcett) – Crowded 900 metres and steadied.

MYSTERY SHOW (M Du Plessis) - Raced ungenerously when making the bend near the 900 metres.

Race 7Ebbett Toyota 1600SUFFIRE (C Grylls) - Slow to begin. Hampered 300 metres.

**IRISH MIST** (S Spratt) - Began awkwardly.

ADRIATIC PEARL (T Thornton) - Crowded leaving the barrier.

**KEEP ON COMING** (A Collett) – Slow to begin.

**SAFFRON LADY** (C Lammas) – Raced ungenerously when being restrained in the early and middle stages.

**PRIZE LAD** (H Marzuki) – Raced wide without cover for the majority of the race.

**WRANGLER** (S Weatherley) – Inconvenienced passing the 300 metres by ROC DE BANK (D Danis) which commenced to shift out when placed under pressure. WRANGLER then shifted away from ROC DE BANK inconveniencing BOWIE which shifted out hampering SUFFIRE with TAVIS STAR being inconvenienced as a result. ROC DE BANK then continued to shift out under pressure further inconveniencing WRANGLER which was dictated wider on the track for the remainder of the straight. Apprentice rider **D Danis** admitted a resultant breach of careless riding with his license to ride in races suspended from the conclusion of riding 17 June up to and including racing on the 25 June, 5 riding days.

The connections of the 5<sup>th</sup> placed horse WRANGLER observed Steward's footage following the race electing not to proceed with a protest against the 1<sup>st</sup> placed horse ROC DE BANK.

TAVIS STAR (M McNab) – Inconvenienced 300 metres.

**ROC DE BANK** (N Nor Azman) – Shifted out under pressure final straight, finishing wide on the track.

**THE KIPLING GIRL** (M Du Plessis) – Commenced to race greenly when placed under pressure in the final straight and then was inconvenienced passing the 200 meters by KEEP ON COMING which shifted out abruptly under pressure. A Collet was advised to exercise greater care.

The connections of the 3<sup>rd</sup> placed THE KIPLING GIRL observed Steward's footage following the race electing not to proceed with a protest against the 2<sup>nd</sup> placed horse KEEP ON COMING.

Race 8 Dow Agrosciences NZ 1600

PYTHAGORAS (T Harris) – Slow to begin.

**CORPORATE MISSILE** (S Spratt) – Crowded and hampered shortly after leaving the barriers. Hampered 300 metres losing ground.

**TWEEDLEDEE** (C Lammas) – Crowded shortly after leaving the barriers. Raced ungenerously passing the 1400 metres when being restrained.

**INNAMINCKA** (A Collett) – Contacted shortly after leaving the barriers, and became unbalanced.

**REBEL ROSE** (G Cooksley) – Crowded and checked passing the 300 metres by EL CAJERO (S Collett) which shifted out when not sufficiently clear. Hampered as a result was CORPORATE MISSILE. Rider **S Collett** admitted a resultant breach of careless riding with her license to ride in races suspended from the conclusion of racing on the 17 June up to and including racing on the 22 June, 3 riding days.
