| Race 1 | GARTSHORE CONSTRUCTION 3YO |
| <p>VINSANITY (S McKay) – Jumped away awkwardly. Lay out making the bend and as a result raced wide without cover.</p> <p>REILLY CENTRAL (M Cameron) – Over-raced when the pace steadied near the 900 metres. When questioned regarding the performance rider M Cameron could offer no tangible excuse. REILLY CENTRAL underwent a post-race veterinary examination which did not reveal any abnormality.</p> <p>COTES DE BOURG (A Collett) – Shifted out approaching the winning post.</p> <p>M Cameron (REILLY CENTRAL) – Admitted a breach of Rule 638(3)(b)(ii) in that he used his whip excessively prior to the 200 metres with the Judicial Committee imposing a fine of \$300.</p> | |
| Race 2 | NEW WORLD WHAKATANE 2YO |
| <p>SUPER HUNTER (M Du Plessis) – Began awkwardly. Commenced to race fiercely when being restrained passing the 1000 metres with the saddle shifting forward placing rider M Du Plessis at a disadvantage. SUPER HUNTER then shifted out off heels forcing LA MIA STELLA wide on the track.</p> <p>DANGERMAN (Z Nor Azman) – Began awkwardly losing ground.</p> <p>LADYNADEL (C Grylls) – Had some difficulty obtaining clear running early in the final straight having to shift ground outwards approaching the 200 metres.</p> <p>MALAMBO (R Elliot) – Briefly held up passing the 400 metres before shifting out to obtain clear running.</p> | |

| <p>LA ACHIEVER (M Du Plessis) – Underwent a pre-race veterinary examination and was cleared to start. Slow to begin.</p> <p>OUR GIRL MADI (D Johnson) – Raced ungenerously in the early stages. Rider D Johnson advised the filly had never travelled comfortably in the early and middle stages, had failed to respond when placed under pressure and was not persevered with in the final straight. OUR GIRL MADI underwent a post-race veterinary examination which did not reveal any abnormality.</p> | |

| <p>OUTSIDER (T Harris) – Began awkwardly. Over-raced passing the 1600 metres when the pace steadied, shifting out forcing HERE TO STAY wider on the track. Held up passing the 500 metres.</p> <p>ARTERIAL (R Norvall) – Began awkwardly. Over-raced passing the 1600 metres when the pace steadied.</p> <p>HERE TO STAY (A Collett) – Forced wider near the 1600 metres for a distance.</p> | |
| Race 5 | NZB INSURANCE PEARL SERIES RACE 1600 |
| <p>BELLA BLUE (A Collett) – Slow to begin.</p> <p>SOUL SISTA (M McNab) – Began awkwardly. When questioned regarding the performance rider M McNab could offer no tangible excuse.</p> <p>GANGSTERS LASS (T Thornton) – Raced wide without cover for the majority of the race.</p> <p>INTO THE MYSTIC (M Du Plessis) – Was held up until passing the 300 metres.</p> | |

| <p>EPROUVEZ (S Collett) – Slow to begin. Commenced to lay out when being steadied in the early stages making the bend awkwardly passing the 900 metres. When questioned regarding performance rider S Collett advised that in her opinion the gelding had failed to handle today's track conditions.</p> <p>TAVIGARDE (E Farr) – Raced in restricted room shortly after the start having to be steadied. Steadied when placed in restricted room passing the 250 metres.</p> <p>SLEEPING BEAUTY (C Grylls) – Made the bend awkwardly passing the 900 metres.</p> | |
