## **RACE COMMENTS:**

Race 1 NZB INSURANCE PEARL SERIES RACE MDN 2YO 1200M

**O'MARINA** (G Cooksley) – jumped out at the start checking PLATINUM CHANEL and KALIPER which lost ground and settled back. Rider G Cooksley had no excuse for the disappointing run.

**PLATINUM CHANEL** (M Tanaka) – checked at the start.

**KALIPER** (A Chan) – checked at the start which lost ground and settled back.

**STYLISH APPLAUSE** (S McKay) – raced three wide without cover throughout.

#### Race 2 CONTRACTORS & SUPPLIERS MDN 1200M

**DA JIN SHAN** (L Allpress) – was tightened at the start and got back. Commenced to over race and had to be steadied for some distance approaching the 800 metres.

**RUBY LOVE** (M Tanaka) – had to be steadied when over racing near the 900 metres.

**MAGICELLA** (D Turner) – shifted out under pressure in the home straight and over the final stages moved out and away from LASTING FRIENDSHIP

**LASTING FRIENDSHIP** (A Chan) – shifted out under pressure in the home straight and had to be straightened on two occasions. A Chan was shown footage of his ride in the presence of Riding Master N Harris and advised that he is expected to straighten his mount sooner than he did on this occasion.

### Race 3 HIREPOOL MAIDEN 1600M

SWISS ANGEL (A Chan) and KEEPER GIRL bumped at the start. Shifted out under pressure over the final stages.

**THE OTHER HALF** (S Wynne) – jumped the crossing near the 1500 metres.

**HERE TO STAY** (A Schwerin) – bumped with HARD TO BE HUMBLE near the 900 metres.

**CALLIDORA** (H Andrew) – had to be steadied and change ground when unable to take advantage of a narrow run near the 250 metres.

When questioned into the disappointing run of **KEEPER GIRL,** L Allpress was of the opinion the filly was short in its action so did not persevere in the home straight. A subsequent veterinary inspection was clear.

#### Race 4 LANDMARK HOMES 1600 RATING 75 1600M

**SILVER COURT** (D Turner) – was slow away.

**RAZOR'S EDGE** (Sam Wynne) – raced three wide without cover throughout.

**BLUE WAGON** (J Riddell) – disappointed finishing well back. J Riddell was of the opinion the gelding may not have been suited to the heavy 10 but was nevertheless disappointing. A subsequent veterinary inspection was clear.

**KOLEE** (K Cowan) – was held up rounding the final turn.

**TIMEBOMB** (R Goldsbury) – had to be shifted away from the heels of KOLEE near the 500 metres to improve.

J Millar presented TIME BOMB with incorrect gear (blinkers). J Millar was warned under Rule 616 (4)

# Race 5 ZANE DOOREY CONSTRUCTION 1200 RATING 65 1200M

O'GUY (L Allpress) – shifted out abruptly at the start into the line of ICEHOUSE which was tightened and got back.

**ICEHOUSE** (A Chan) – tightened at the start got back.

**MENDIP** (S McKay) – was tightened at the start and got back.

**H Andrew** (BUSHFIRE) – was shown footage of her ride and reminded of her obligations with regard to her use of the whip prior to the 200 metres.

**ANIMATOR** (J Riddell) – was inclined to shift ground under pressure in the home straight.

A post race veterinary inspection of SALTED CARAMEL which finished well back revealed the mare to have fibrillated. Connections were advised that a clearance would be required prior to its next start.

A Chan (ICEHOUSE) dropped his whip near the finish.

#### Race 6 THE KIWI BUTCHER OPN HCP 1200M

**DARCI MAC** (S Wynne) – was tightened at the start and settled back.

**HOTSHOT LASS** (R Goldsbury) – was held up for a short distance prior to entering the home straight.

**CLOSE UP** (G Cooksley) – shifted in under pressure over the final stages.

### Race 7 ENERGY CITY FORD OPN HCP 1800M

**OVERTHERIVER** (D Hirini) – raced keenly in the early and middle stages. D Hirini reported that she was unable to settle the gelding.

**KATIE MCKEEN** (S Wynne) – had to be steadied off heels passing the winning post on the first round. Raced wide in the back straight in search of better footing.

**BLATHWAYT** (R Goldsbury) – shifted out and away from BELLA'S DELIGHT near the 200 metres making contact with the tiring OVERTHERIVER.

**BELLA'S DELIGHT** (M Singh) – shifted out some distance under hard riding in the home straight. M Singh was shown footage of his ride in the presence of Riding Master N Harris and advised that he is expected to straighten his mount sooner than he did on this occasion. M Singh was issued with a warning under Rule 638(1)(d) (careless riding).

#### Race 8 SEATON PARK 1800 RATING 65 1800M

SHADOW TOWER (S McKay) and MR INK (E Farr) bumped at the start.

**OUTOFTIME** (R Goldsbury) – began awkwardly.

BOYSWAY (K Cowan) – made the first bend awkwardly and had to be steadied for some distance

ARTAXERXES (H Andrew) – steadied near 1600 metres.

**NEWSTEAD** (D Turner) – shifted in leaving the straight on the first round when not the required distance clear of ARTAXERXES (H Andrew) which had to be steadied off that runner's heels. After questioning riders D Turner was issued with a warning under Rule 638(1)(d).

**IFFITEL** (L Allpress) – checked near the 800 metres. When questioned into the run rider L Allpress advised that in her opinion IFFITEL was a one pacer and was unable to quicken over the final stages after incurring the check near the 800 metres.

**M Tanaka** (YOUWANTMORE) – admitted a charge under Rule 638(1)(d) careless riding in that he shifted in near the 800 metres when not clear of IFFITEL which was checked. M Tanaka had his licence to ride in races suspended from the conclusion of racing on 13/5/17 up to and including 27/5/17 (4 days).

# Race 9 PUNTING COMP SAT JULY 22<sup>ND</sup> – DON'T MISS OUT! RTG 65 1800M

**HEISTHEONE** (J Riddell) – bumped with SAKURA inside last 200 metres.

**CUTTINGUP ROUGH** (E Farr) – began awkwardly and was then tightened

**STOCKTAKE** (D Bradley) – finished some distance last after racing near the pace, rider D Bradley stated the mare was never comfortable in the going.

**SAKURA** (H Andrew) – raced wide throughout in search of better footing. Saddle slipped forward on SAKURA near the 1200 metres placing the rider at a disadvantage for the remainder. SAKURA and HEISTHEONE bumped for a short distance inside the last 200 metres.
