RACE COMMENTS:

Race 1 ARAWA PARK FUNCTION ROOMS 1400

SHELLEZ ACE (D Danis) – Jumped away awkwardly. Was inclined to lay out when placed under pressure in the final straight. Apprentice D Danis dropped his whip just prior to the winning post.

QUAINTRELLE (R Elliot) – Raced keenly in the early stages.

PAVLICHENKO (T Thornton) – Raced wide without cover throughout.

KEEPER GIRL (D Johnson) – Lost the right front plate during the running.

Race 2 ATKINSON & DONALDSON PLUMBERS 2YO

LORD BUFFALO (S Collett) – Jumped away awkwardly shifting out making contact with CASSIO. Was further hampered when MUTECHI shifted away from LADYNADEL.

Race 3 A T COOK CONTRACTING 3YO

ABOVE ALL (S Collett) – Slow to begin.

PEARLESCENCE (D Johnson) – Slow to begin.

EXONERATE (R Elliot) – Apprentice R Elliot was reminded of his obligations and advised that he must ride his mounts fully out to the finish when circumstances permit.

Race 4 NZB INSURANCE PEARL SERIES RACE

ENCHANTING BEAUTY (D Johnson) – Slow to begin. Held up early in the final straight before shifting inwards approaching the 100 metres to obtain clear running.

HOOFALOOF (J Fawcett) – Slow to begin. Raced wide without cover throughout.

MYLADYACHIEVER (E Farr) – Inconvenienced approaching the 100 metres by ENCHANTING BEAUTY which shifted in to obtain clear running.

COMBAT WARRIOR (R Elliot) – When questioned regarding performance apprentice R Elliot advised Stewards that after racing keenly in the early and middle stages he was of the opinion that the filly had failed to see out the 1400 metres.

Race 5 BDO ROTORUA 1230

WIMBLEDON (S Collett) – Late scratching at 2.48 pm on veterinary advice after escaping underneath the front of the barriers. Trainer Mr J Collett was advised the mare must barrier trial to the satisfaction of Stewards prior to racing next.

ESPRIT DE CORPS (M McNab) – Slow to begin, and then over-raced through the middle stages.

SENASSY (Z Nor Azman) – Had to be steadied when placed in restricted room when **TRUEMAN** (C Lammas) shifted out slightly approaching the 50 metres and **ESPRIT DE CORPS** (M McNab) shifted in slightly. Both M McNab and C Lammas were advised to exercise greater care in similar circumstances.

ENJOY THE RIDE (A Collett) – When questioned regarding performance rider A Collett could offer no tangible excuse.

Race 6THE JIM, JOE AND JOHN MEMORIAL 1230WHIPSRKRAKEN (J Fawcett) – Slow to begin.

NEW CROWN (S Collett) – Crowded shortly after the start losing ground when VINSANITY lay out and IDAHO'S PARTNER shifted in abruptly after NEW CROWN made contact with its hind quarters.

SUFFICIENT FUNDS (T Miles) – Over-raced in the early and middle stages.

VINSANITY (S McKay) – Lay out in the early stages, then was placed in restricted room near the 900 metres having to be steadied when continuing to lay out. Made the bend near the 800 metres awkwardly.

RED SHEERAN (S Weatherley) – Over-raced when being steadied passing the 1000 metres.

IDAHO'S PARTNER (D Danis) – Steadied when placed in restricted room near the 850 metres.

Race 7 NZB INSURANCE PEARL SERIES RACE

TICKET TO RIDE (D Danis) – Made contact with the running rail near the 800 metres when racing in restricted room.

MISS BUMBLEBEE (J Nason) – Steadied approaching the 800 metres with DESTINY ONE becoming awkwardly placed on heels having to be firmly restrained.

DESTINY ONE (T Thornton) – Firmly restrained when awkwardly placed on heels passing the 800 metres.

MISS MAZZY (A Collett) – Underwent a post-race veterinary examination which revealed the mare to be lame in the right foreleg due to a suspected tendon injury. The connections were advised that a veterinary clearance would be required prior to racing next. Trainer J Brosnan advised that the mare would now be retired from racing.

Race 8 CHRISTMAS AT THE RACES 29 NOVEMBER 1950

DELUXE EDITION (D Danis) – Slow to begin.

ESKIMO KISS (Z Nor Azman) – Got its head up when over-racing near the 1400 metres when the pace eased then continued to over-race for a distance.

THE ARABIAN DUKE (T Harris) – Unable to obtain clear racing room over the final 100 metres.

EL CAJERO (S Collett) – When questioned regarding the performance of the gelding rider S Collett advised Stewards that after being caught wide throughout EL CAJERO had failed to see out the 1950 metres.
