Race 8 JAMARK PLUMBING 1400

SACRED GURU (D Johnson) – Trainer T Pike advised Stewards that he was satisfied with the recovery of the gelding. It is his intention to freshen SACRED GURU, remove the blinkers and drop the gelding back in distance.

RAINBOW SONG (C Grylls) – Trainer A Scott advised Stewards that in the days following its performance in this race the gelding under-went a veterinary examination which did not reveal any abnormality and it is their intention to continue on with its current preparation

RACE COMMENTS:

Race 1 PIAKO MITSUBISHI MDN HURDLE

HESALLJAZZ (J Seivwright) – Slow to begin.

SINO HEIGHTS (M Gibbs-Manssen) – Commenced to race keenly after jumping the first fence with the saddle shifting forward placing rider M Gibbs-Manssen in difficulty for the remainder of the race. Jumped the fourth fence poorly with the rider becoming unbalanced for a distance. Put in a poor jump near the 1000 metres when commencing to weaken.

FINNS HALO (A Kuru) – Put in a poor jump landing awkwardly at the fence near the 1000 metres.

THE ARABIAN DUKE (R Cole) – Put in a poor jump at the fence passing the 2000 metres, and at the third and second to last fences landing awkwardly.

NOMBERO (C Studd) – Lost the left front plate during the running.

Race 2 STEVE'S DISCOUNT NURSERY MDN HURDLE

HIGH IN DEMAND (S Karnicnik) – Very slow to begin (5L). Trainer J Wheeler was advised that a warning would be placed against its barrier manners. Pulled up prior to jumping the third to last fence when well back.

IZZANORANGE (M Gibbs-Manssen) – Jumped the first fence poorly losing momentum, and then jumped indifferently for the remainder of the race.

DALRIADA (C Price) – Jumped indifferently throughout. Put in a poor jump at the fence near the 1000 metres landing awkwardly.

NOTABADROOSTER (W Gordon) – Raced keenly in the early to middle stages.

PRIMROSE HILL (S Phelan) – Jumped indifferently throughout.

READY TO RUMBLE (C Studd) – Ran down the fence near the 1400 metres forcing LACUSTRE outwards with that runner landing awkwardly losing ground. Pulled up prior to jumping the third to last fence when well back.

LACUSTRE (A Kuru) – Landed awkwardly after jumping the fence near the 1400 metres losing ground.

FAST CATCH (R Cole) – Misjudged the final fence landing awkwardly. Rider R Cole admitted a breach under rule 638(2) for making a celebratory gesture prior to the winning post and was fined the sum of \$100.

Race 3 PIAKO RURAL SERVICES OPN HURDLE

WIGGLE (S MacNab) – Raced ungenerously when being steadied in the early stages. Misjudged the fence near the 1000 metres and fell – both horse and rider were uninjured.

NGATIRA GOLD (A Kuru) – Put in a poor jump at the second to last fence.

IT'S A WONDER (W Gordon) – Hit the last fence landing awkwardly.

OLD COUNTESS (R Cole) – Rider R Cole admitted a breach of rule 636(1)(b) in that he failed to take all reasonable and permissible measures from the 500 metres to ensure he finished in the best possible placing with the Judicial Committee suspending his license to ride in races from the conclusion of racing today, up to and including racing on 29 July, 4 riding days.

Race 4 PATRON PADDYS PICKS 2200

ROOF OF RECKONING (J McIlroy) – Began awkwardly losing ground.

MAGNANIMOUS MAN (S Wenn) – Lay in shortly after jumping away making contact with MEDINI with that runner shifting in crowding HERE TO STAY on to the hind quarters of SUFFICE TO SAY which became briefly unbalanced.

HERE TO STAY (L Wheeler) – Crowded shortly after jumping away.

SUFFICE TO SAY (M Northcott) – Bumped becoming briefly unbalanced shortly after jumping away.

MEXICAN (S MacNab) – Had to be steadied when in restricted room to the inside of MEDINI which shifted in when not fully clear approaching the 2000 metres.

MUELED (L Calitz) – Raced wide without cover throughout.

Race 5 STALLION PLACEMENT SCHEME 2200

LONELY BOY (C Price) – Began awkwardly.

LETMEBY (R Cole) – Began awkwardly. Shifted out passing the 700 metres making brief contact with THE BIG OPAL.

BAD BOY BROWN (W Gordon) – Slow to begin.

THE BIG OPAL (S MacNab) – Knuckled leaving the barrier losing ground. Briefly contacted 700 metres.

Race 6 KNOTTINGLY FARM OPEN STEEPLECHASE

NELLS BELLE (J Seivwright) – Misjudged the first fence landing awkwardly. Misjudged the sixth fence landing awkwardly dislodging its rider who was uninjured. Hampered as a result were ISTIMAGIC and NOAH JON.

ISTIMAGIC (C Studd) – Hampered sixth fence.

NOAH JON (G Walsh) – Hampered sixth fence. Received veterinary attention following the race to two small abrasions to the right front pastern.

MR KANTON (W Gordon) – Hampered by the riderless horse near the 1400 metres. Stumbled after jumping the final fence and fell – both horse and rider were uninjured. Badly hampered as a result was WAI NOT.

HIS NIBS (C Price) – Retired from the race prior to jumping the final two fences when well back.

ZED CASE (S Karnicnik) – Pulled up prior to jumping the final fence when well back.

WAI NOT (D Turner) – Badly hampered final fence by fallen runner.

Following the race the connections of the second placed horse **ISTIMAGIC** (C Studd) lodged a protest against the first placed horse **NOAH JON** (G Walsh) alleging interference in the final straight. After hearing submissions the Judicial Committee dismissed the protest.

Race 7 BULLSEYE DIRECT 1600 HIGHWEIGHT

BARB DWYER (M Roustoby) – Began awkwardly losing ground.

ACEDECEE (R Cole) - Slow to begin.

SOROC (A Kuru) – Rider A Kuru was spoken to by Stewards for using his whip excessively in the final straight, and further advised that a warning would be placed on his record.

Race 8 JAN REVELL MEMORIAL 1600

SHE'S ALL CLANG (H McNeill) – Slow to begin. Steadied when awkwardly placed on heels 800 metres. When questioned into the disappointing performance rider H McNeill was unable to offer any reason.

J'WALKE (C Price) – Began awkwardly.

REMIND ME AGAIN (A Kuru) – Slow to begin.

UNVEILING (S Phelan) – Slow to begin.

EMBRACEABLE YOU (W Gordon) – Raced keenly when being restrained in the early stages. Shifted out when making the bend near the 800 metres awkwardly dictating ARTIFACT out into the line of SHE'S ALL CLANG which had to be steadied when awkwardly placed on that runner's heels.
