Race 2 – New Plymouth Motorcycle Centre 1,800 metres	
IFFITEL (L Satherley) – Trainer G Brick subsequently reported that on return to his stable the mare was found to have an upper respiratory tract infection being treated accordingly.	
Hawkes Bay Racing – Thursday, 20 July 2017	
Race 6 - Grant Plumbing Wellington Steeplechase 5,500 metres	
Following an adjourned enquiry into the riding tactics employed on NELL'S BELLE, J Seivwright was advised that notwithstanding the riding instructions issued by the trainer, in the stewards view he showed a lack of judgement with the extra ground covered and although no charges were preferred on this occasion, in future he would be expected to ride his mounts in a manner which is not left open to query.

Race 1	CHELTENHAM & DUBAI WITH T LEE & ARA MAIDEN HURDLE 3000m

HER SON (C Price) – Slow to begin	
HIGH IN DEMAND (S Karnicnik) – Slow to begin. Jumped last fence awkwardly when tiring and blundered on landing.	
ZED LEPLIN (H McNeill) – Poor jump at the fence near the 800 metres being a beaten runner shortly after and retired from race prior to the third last fence near the 600 metres. A post-race veterinary examination did not reveal any abnormality other than some blood on the lower lip and a superficial abrasion to the right fore leg.	
Race 2	BRIAN FM MAIDEN HURDLE 3000m
PUKEAKE SAM (S Fannin) – Slow away. Rider lost the use of his whip for a short distance after the last fence. Rider Fannin was spoken to regarding his whip action over the final stages.	
PALACIO (H McNeill) – Jumped indifferently throughout	
ZEDSATIONAL (C Price) - Pulled up at the second last fence. A subsequent veterinary inspection revealed lame left and right fore switching legs. Skin off bumpers.	
THATZ LOUIE (S Karnicnik) - Pulled up at the second last fence. Ducked inwards at the fence passing the 2,400 metres hampering ZEDSATIONAL .	
KANGAROO (E Farr) – Rider dropped whip approaching the second last fence	
HIGHLY LIKELY (D Turner) - Tailed the field from the 1,400 metres. A subsequent veterinary inspection including an endoscopic examination found the gelding to have bled now being subject to the mandatory two months stand down from training and three month stand down from racing with a veterinary clearance required prior to trialing or racing again.	
Race 3	WANGANUI RACEHORSE OWNERS ASSOCIATION OPEN HURDLE 3000m
YIPSON (C Price) – Awkwardly away	
NO EXCUSES (G Walsh) – Jumped indifferently. Pulled up approaching the fence by the 600 metres.	
KINGS DEEP (S Phelan) – Under pressure from the 1,600 metres and was pulled up approaching the fence by the 600 metres. When questioned into the performance Rider Phelan could offer no excuses. A subsequent veterinary examination revealed a slow recovery. Trainer Mr P Nelson reported that he believed the gelding had got its tongue over the bit.	
Race 4	JOLT COFFEE HOUSE MAIDEN STEEPLE 4100m
LONELY BOY (C Price) - Hit the fence and blundered passing the 2,600 metres	
PADDY OWEN (S Phelan) – Misjudged the fence approaching the 800 metres losing ground	
MAX (I Lupton) - Jumped high at the fence approaching the 800 metres losing ground. When questioned into the performance I Lupton advised that despite jumping high at several fences he could offer no real excuse.	
Race 5	GUTHRIE BOWRON OPEN STEEPLE 4100m
NELLS BELLE (J Seivwright) – Misjudged the fence approaching the 2,500 metres. Hit the fence passing the 600 metres and lost rider. Rider was uninjured.	
KIDDO (S Fannin) – Dipped on landing at the fence passing the 1,000 metres. Hit the fence at the 600 metres.	
D Turner (THE FOX) - Was issued with a warning under Rule 638 (3) (b) (ii) regarding his whip use prior to the 200 metres.	
Race 6	ALSCO AMATEUR RIDERS 2060m
J'WALKE (G Duncan) – Slow away. Received veterinary treatment following the race as it was found to have tied up.	
BAD BOY BROWN (J Lupton) - Awkwardly away making contact with the gates	
HAMILTONIAN (L Wheeler) – Slow away	

EDDIE GILBERT (K Asano) – Slow away	
MAKE ME ACHIEVER (B Rogerson) - Made contact with the rail when in restricted room approaching the 1,600 metres	
DES DE JEU (N Jensen) - Tightened approaching the 800 metres	
GUY FOX (C Myers) – Improved very wide on the track passing the 800 metres	
Race 7	PALAMOUNTAINS MAIDEN 2060m
CARTAGENA (R Goldsbury) – Slow away (4l)	
SIR RITCHIE (S MacNab) - Raced keenly in the early stages	
MESMERIZE (S McKay) – Lay out under pressure in the home straight	
MAYBE SOMETIME (D Turner) - Gave ground quickly prior to the 600 metres. Connections advised they will not be persevering with the mare as a racing proposition.	
Race 8	CERVUS EQUIPMENT NZ LIMITED MAIDEN 1600m
WENTWORTH (M Singh) – Slow Away	
LOOK OUT (M McNelis) - Raced keenly early and middle stages	
HEY MR FOX (D Turner) – Gave ground quickly from the 600 metres. Rider advised the gelding may have got its tongue over the bit. Connections advised they would use a tongue tie at the gelding’s next start.	
INFOXICATED (M Tanaka) – Ran up on to the heels of LOOK OUT and had to be restrained approaching the 200 metres	
BELLA’S EDGE (J Parkes) – Was unable to be ridden out to advantage early in the home straight gaining clear running passing the 150 metres when LOOKOUT (M McNelis) shifted ground. Rider M McNelis was advised to exercise greater care when shifting ground.	
Race 9	PROPERTY BROKERS COMPLIANCE 1360m
BROTHER ONE (S MacNab) - Tightened shortly after the start and settled back	
VERACIOUS (K Cowan) – Slow away	
CHESTER CARLSON (R Myers) - Raced keenly in the early stages	
AGOODDEAL (D Turner) – Rider advised that the mare was making a respiratory noise during the running. A subsequent veterinary examination revealed no obvious abnormalities.	
SEA PRINCESS (L Allpress) – When questioned into the performance L Allpress was of the opinion the mare resented the application of a tongue tie. Connections advised that the tongue tie would be removed.	
Race 10	AG CHALLENGE MAIDEN 1200m
TEDDY WONDER (L Hemi) - Jumped outwards bumping SHOCK ROCK	
KEEP DANCING (A Chan) - Ran outwards shortly after the start bumping STROPHE who was unbalanced. Also inconvenienced was RAWINIA . KEEP DANCING raced keenly in the early and middle stages having to be restrained off heels.	
GARMENT (D Bradley) – Tightened after passing the 500 metres, then had to be angled inwards to obtain clear running passing the 200 metres.
