GENERAL:

S Wynne did not attend today's re-scheduled meeting due to commitments at the Tapanui RC meeting at Gore.

RACE COMMENTS:

Race 1	MILLS REEF WINERY 2YO PREMIER
	NOTHIN' ON ME (J Parkes) – Passed fit to run following a veterinary examination at the start after dislodging its rider during the preliminary and making contact with the outside fence before being recaptured. Jumped away awkwardly crowding DREAMS OF PLATINUM onto DIJON BLEU and EMPRESS TZU HSI which was hampered. Raced three-wide without cover throughout.
	DREAMS OF PLATINUM (R Hannam) – Crowded start.
	DIJON BLEU (K McCulloch) – Crowded start. Raced keenly in the lead in the middle stages being inclined to get its head up.
	EMPRESS TZU HSI (D Johnson) – Hampered start.

DARE TO ROCK (M Tanaka) – Slow away. Raced greenly throughout. Had to be steadied passing the 200 metres when SAINTED PEARL was taken in by NOTHIN’ ON ME.

GOLD FEVER (J Riddell) – Had a tendency to lay inwards in the final straight and was unable to be ridden out fully by its rider who reported that the filly had raced greenly throughout.

Race 2 | **PROPERTY BROKERS PREMIER**

KONOHIKI (C Johnson) – Blundered badly leaving the barriers. Required veterinary treatment following the race as was showing signs of lameness having suffered a muscular injury to the right shoulder.

JUDI ANNE (R Elliot) – Began awkwardly losing ground.

INCANTATION (R Hannam) – Slow away. Held up rounding the final turn until near the 250 metres.

MANEO INVICTUS (S McKay) - Jumped away awkwardly inconveniencing HANDSOME RETURN.

HANDSOME RETURN (L Hemi) – Inconvenienced start. Was unable to obtain clear running from the 200 metres until the concluding stages.

BLUE LAGOON – Raced ungenerously when being restrained passing 1200 metres.

CASAQUINMAN (J Riddell) – Raced three-wide without cover. Inconvenienced near the 150 metres when MANEO INVICTUS shifted away from PRINCESS BELLE.

O’CEIRINS CHOICE (J Parkes) - Held up early in the final straight before angling outwards across heels to obtain clear running near the 200 metres.

GREAT HASTE (D Bradley) - When questioned regarding performance the rider was unable to offer any excuses but was of the opinion that the gelding may benefit from the addition of an item of headgear and would be recommending accordingly to the connections. D Bradley subsequently reported that he had been advised by connections that the gelding had not pulled up well and would be subjected to veterinary tests on return to its stable.

Race 3 | **RICH HILL STUD 3YO PREMIER**

LEADING ROLE (C Johnson) – Had to be steadied after improving onto the heels of FINE TAYLOR near the 1100 metres. Held up early in the home straight before angling across heels passing the 200 metres to obtain clear running.

ALMO STREET (J Riddell) – Crowded between TIPTRONIC and DESANO leaving the barriers. Held up early in the final straight angling outwards across heels near the 200 metres before gaining clear running near the 150 metres.

TIPTRONIC (J Parkes) – Raced keenly in the middle stages. Briefly lost its footing near the 500 metres. J Parkes advised that the gelding had raced greenly throughout. Was inclined to shift inwards under pressure having to be straightened near the 200 metres. When questioned, J Parkes was unable to offer any excuses for the gelding’s disappointing performance. A post-race veterinary examination did not reveal any abnormality.

PLATINUM DIVA (K McCulloch) – Crowded when weakening near the 200 metres when DESANO was taken in by TIPTRONIC which shifted in under pressure. J Parkes was advised to exercise greater care.

FINE TAYLOR (H Tinsley) – Held up early in the final straight.

GOBUYIT (R Goldsbury) – Placed in restricted room when weakening passing the 200 metres to the inside of SAVASAVA which was taken in by UNDERCOVER.

Race 4 | **PAVEMASTERS PREMIER**

Trainer **Mr M Brooks** was issued with a warning after presenting EL FERNANDO to race without an item of notified gear (blinkers).

ROCK ON (J Parkes) – Slow away.

CHINA STAR (R Hannam) – Began awkwardly.

WAIT A SEC (D Turner) – Slow away.

CAPTAIN LINCOLN (K McCulloch) – Over-raced when being restrained passing the winning post on the first occasion.

PRIZE LAD (D Bradley) – When questioned regarding performance rider advised had been outpaced and would in his opinion benefit from some easing of the ground.

ALL IN VOGUE (C Johnson) - Rider was unable to offer any excuses for the mare's poor performance. A post-race veterinary examination did not reveal any significant abnormality.

Race 5 | **HOTEL COACHMAN MANAWATU CUP - GpIII**

ENDEAVOUR (S McKay) – Blundered at the start shifting outwards making contact with TIFFANY'S.

TIFFANY'S (M Tanaka) - Bumped at the start and settled back.

WHITE DIAMOND (R Hannam) – Jumped away awkwardly.

JACKSTAR (A Collett) – Slow away. Commenced to over-race when placed in restricted room to the inside of FIVE TO MIDNIGHT which was taken inwards by TEQUILA SUNRISE (C Dell) near the 2000 metres. C Dell was advised to exercise greater care. Continued to over-race into the middle stages before improving forward to sit outside the leader near the 900 metres.

DUBAI SHUFFLE (T Johnson) – Raced three-wide throughout.

FIVE TO MIDNIGHT (D Bradley) - Inclined to over-race in the early to middle stages.

Race 6 | **KAMADA PARK MANAWATU CHALLENGE STAKES - GpII**

LA FILLE EN JEU (L Hemi) – Shifted outwards abruptly at the start crowding PROFILE which settled back. Lay out rounding the final turn dictating SUMMER'S DAY outwards onto MIGHTY SOLOMON which made contact with the hindquarters of MAYBE MIAMI turning that runner inwards.

PROFILE (S McKay) – Crowded start.

SCAPOLO (J Parkes) – Hampered start when MISS APPLETON shifted inwards leaving the barriers.

MAYBE MIAMI (C Johnson) – Raced three-wide without cover throughout. Turned inwards when received contact to hindquarters 350 metres. Bumped just short of finish.

SLICE OF CLASS (K McCulloch) – Slow away. Briefly held up early in the final straight.

RINGO (J Riddell) - Slow away. Had difficulty obtaining clear running until near the 150 metres.

NYMPH MONTE (R Elliot) – Slow away.

SUMMER’S DAY (D Johnson) - Came together with **MIGHTY SOLOMON** for a distance when racing in restricted room to the inside of **MAYBE MIAMI** passing the 250 metres.

MIGHTY SOLOMON (J Riddell) – Came together with **SUMMER’S DAY** for a distance when racing in restricted room to the inside of **MAYBE MIAMI** passing the 250 metres. Made contact with **MAYBE MIAMI** just short of the finish.

Race 7

BROKERWEB RISK SERVICES PREMIER

HOTSHOT LASS – Declared a late scratching at 4.42pm after refusing to enter the barriers. Trainer Mr J Bliss was advised the mare is now required barrier trial to the satisfaction of a Stipendiary Steward before racing next.

CHIC (D Turner) – Raced ungenerously when being restrained passing the 1000 metres.

BEEFEATER (H Tinsley) – Had a tendency to lay inwards in the final straight having to be straightened on several occasions.

D Turner (CHIC) - Admitted a charge under Rule 648(5) in that he had weighed in 1kg in excess of the weight at which he weighed out. After hearing submissions the Judicial Committee imposed a fine of \$350.
