Race 4 - BLUSTEEL – Trainer advised the gelding will now go out for a spell.
Race 5 - CARAMAC – Trainer reported that the mare was now likely to be served before continuing racing.

RACE COMMENTS:

Race 1	THE HITS R85 1000 (1000 metres)
ISHINKTAATLEDO (A Chan) –Tongue tie removed immediately prior to the start when it was considered by the rider to be restricting the horse’s breathing. Slow away. Had to change ground approaching the 200 metres to improve.	
BALLYBAY (L Allpress) Lugged outwards shortly after the start hampering BANNOCKBURN. When questioned, rider L Allpress was of the opinion the gelding was not comfortable in today’s track conditions.	

BANNOCKBURN (D Bradley) – Hampered shortly after the start.

Race 2	SOUTH WAIRARAPA VETERINARY SERVICES R65 1000 (1000 metres)

BLAME DE ANGELS (M Singh) – Awkwardly away.

LAST CHANCE (L Hemi) – Tightened at the start, settling back.

PICKNGO (L Allpress) – When questioned into the performance of PICKNGO, L Allpress considered something amiss with the mare. A post-race veterinary inspection revealed the mare to have an abnormally low heart rate. Connections were advised that a veterinary clearance is required before PICKNGO races next.

RAM SAM SAM (T Johnson) – Dictated wider on the track passing the 300 metres.

M Tanaka (TOULOUSE) – Admitted a breach of Rule 638(3)(b)(ii) in that he used his whip excessively prior to the 100 metres and was fined the sum of \$300 by the JCA.

Race 3	JOHNSON BROTHERS OPEN 1400 (1400 metres)

DARCI MAC (A Chan) – Raced ungenerously when being restrained in the early stages. Raced up on to heels of NYMPH MONTE and became awkwardly placed inside THORN PRINCE bumping on several occasions passing the 800 metres. Checked across heels passing the 300 metres.

THORN PRINCE (J Parkes) — Awkwardly away. Bumped on several occasions passing the 800 metres.

NYMPH MONTE (R Myers) – Raced keenly in the early stages.

Race 4	SCOTT'S AG CONTRACTING MAIDEN 1400 (1400 metres)

SIOUX (M Singh) - Jumped outwards sharply at the start, contacting MUSTAFA which was dictated on to BELTOY. Also contributing was ZEDUZZI, which shifted inwards. M Singh was advised to exercise greater care after angling his mount in shortly after the start when not the required distance clear of ZIP ZAP (M Tanaka) which had to steady.

MUSTAFA (H Tinsley) – Dictated out onto BELTOY at the start.

ZIP ZAP (M Tanaka) – Had to steady shortly after the start.

ZEDUZZI (T Allan) – Jumped inwards at the start.

MASTER PAT (R Jones) – Slow away.

BELTOY (S Collett) - Rider advised that after getting back at the start the filly was unable to make any discernable ground in the holding track conditions. A subsequent veterinary inspection failed to reveal any abnormalities.

Race 5	PRINCRAFT R75 1400 METRES (1400 metres)

BIG BEN (D Turner) – Jumped outwards at the start tightening COOL MOON, which settled back.

COOL MOON (A Chan) – Tightened at the start, settling back. A Chan was reminded of his obligation with regard to the use of his whip on a runner out of contention

BRAD THORN (K Cowan) – Slow away.

ARTAXERXES (L Hemi) – Gave ground quickly from the 800 metres finishing a distant last. A subsequent veterinary examination failed to reveal any obvious abnormalities. Connections advised the gelding would be monitored over coming days and any findings reported to the stewards.

LORD ERNESTO (H Andrew) – Finished some distance back. H Andrew considered something may be amiss with the gelding. A subsequent veterinary inspection revealed the gelding to be lame in the right hind leg.

Race 6	LIQUORLAND MASTERTON R85 2050 (2050 metres)

D Hirini (PENCURI) – Unable to claim allowance, fined \$200.

YAMATO NADESHIKO (K Cowan) - Slow away. When questioned regarding the disappointing performance, rider noted that the mare had been unable to quicken in today's holding track conditions.

SYLVESTER (S Collett) - Awkwardly away.

SUSSED (C O'Beirne) - Had to be restrained passing the winning post on the first occasion when ITSALL BELT (H Andrew) shifted in when not clear. Apprentice jockey H Andrew was issued with a warning under Rule 638(1)(d).

ZENTANGLE (S MacNab) - Made the first bend awkwardly.

TICKET CLIPPER (R Myers) – When questioned, rider advised the gelding had travelled well but had been unable to quicken in the going.

GOBSTOPPER (M Singh) - Shifted in when struck with the whip near the 200 metres.

Race 7	EV'S BAR CARTERTON R65 1600 (1600 metres)

WHIPPED (R Myers) – Slow away

DON'STOPGIRL (L Hemi) – Slow away.

CENTRE ATTENTION (A Chan) – Shifted out abruptly shortly after the start. Lay out under pressure over the final stages.

MR DARCEE'S GOLD (M Singh) – Contacted and dictated outwards sharply when CENTRE ATTENTION shifted out abruptly shortly after the start despite the rider's effort to correct its line. Also dictated outwards in the incident was SOLESEIFEI, which briefly inconvenienced ANDARTA.

TALK THE TORQUE (D Hirini) - Raced keenly in the early stages.

SOLESEIFEI (J Parkes) – Had to steady when in restricted room passing the 700 metres.

Race 8	SELLAR & SELLAR CHARTERED ACCOUNTANTS R65 1600 (1600 metres)

PHILIPA CHARLOTTE (K Cowan) – Underwent a veterinary examination and cleared to run after galloping some distance at a moderate pace prior to the start. Lay out under pressure in the home straight.

LADY ECHEZEAUX (S MacNab) – Checked inwards across heels approaching the 600 metres, losing ground.

CARNABY (D Turner) – Reported the gelding was never comfortable in the going.

D Turner (CARNABY) – Admitted a breach of Rule 638(3)(b)(ii), excessive use of the whip, and was fined \$300 by the JCA.
