GENERAL:

F	Race 1	ITM TOOLWARE 1200M

SMOOCHY (R Elliot) – Slow away. Raced keenly in the early stages.

THE ARK (H Marzuki) – Bumped and tightened at the start when SAPPHIRE SKY jumped outwards and WINTHORPE jumped awkwardly away.

WYNTHORPE (J Parkes) – Awkwardly away bumped THE ARK. Raced wide throughout.

SAPPHIRE SKY (A Collett) – Jumped outwards at the start and bumped.

BRAVE KAT (D Turner) – Raced three wide throughout without cover.

H Andrew (MISS LIZZIE) – Admitted a breach of Rule 638(3)(b)(ii) in that she used her whip excessively in the home straight and was fined the sum of \$300.

Race 2 ITM FIRTH DRICON SC MAIDEN 1400M

MANHATTEN FLAME (T Harris) – Raced wide throughout. When questioned T Harris advised despite racing wide the gelding may be better suited to a looser track.

BROTHER ONE (S MacNab) – Got up on to the heels of LORD BUFFALO and made the bend awkwardly passing the 800 metres.

LIQUID INSPIRATION (A Collett) – Over raced in the early stages.

PERCY'S GEM (J Parkes) – Had to steady off the heels of SEA STAR near the 800 metres and when being shifted outwards bumped with SHELLEZ ACE for a short distance.

Race 3 ITM WINSTONE WALLBOARDS 1400M

COOL MOON (M McNellis) – Reared at the start then was severely tightened and lost ground. Raced wide throughout.

ISHINKTAATLEDO (K Cowan) – Slow away. Raced three wide without cover throughout.

SHADOW KING (R Myers) – Awkwardly away. Raced keenly in the early stages.

KEEPING TOM (D Hirini) – Raced keenly in the early stages having to be restrained off the heels of FINN approaching the 900 metres dictating ISHINKTAALEDO wider on the track.

SECONDS OUT (J Fawcett) – Briefly held up approaching the 250 metres when FARCE rolled in under pressure.

Race 4 ITM PSP OPEN HCP 1300M

GYPSY FAIR (A Chan) – Began awkwardly resulting in A Chan losing his irons for a short distance. Raced ungenerously in the early stages getting up on to the heels of BANNOCKBURN. Bumped on a number of occasions with OCEAN EMPEROR in the back straight.

OCEAN EMPEROR (M Hills) – Bumped with GYPSY FAIR in the back straight.

ZORRALI (T Johnson) – Held up passing the 500 metres.

BANNOCKBURN (D Bradley) – Raced in restricted room approaching the 50 metres having to be steadied.

GALAXY MISS – Rider J Parkes was spoken to regarding his use of the whip in the home straight.

Race 5

ITM INTERPROVINCIAL CHALLENGE 1600M

STORMY HABIT (P Shaikh) – Slow away. Returned to the enclosure with blood present in its right nostril. A subsequent veterinary inspection revealed a laceration consistent with having hit the starting gate.

WOODEN EDGE (H Marzuki) – Held up passing the 400 metres having to be angled inward early in the home straight to gain clear running.

JUSTLIKEYASISTER (L Hemi) – Briefly inconvenienced approaching the 200 metres when MANGAROA FLO JO improved to the inside.

MERITAGGIO (V Colgan) – Lost the near front plate during the running.

A Jones (MANGAROA FLO JO) – Advised to exercise greater care after bumping with STOKERS ROCK when improving into a narrow run near the 200 metres.

S McKay (SHE'S POPPY) – Admitted a breach of Rule 638(3)(b)(ii) in that he used his whip excessively prior to the 100 metres and was fined the sum of \$400.

Race 6

ITM MAKITA 1600M

RED RASCAL (D Turner) – Slow away.

MILLY MOO (H Marzuki) Saddle slipped forward shortly after start placing rider at a disadvantage.

NO LOITERING (J Fawcett) – Bumped with BELLA BLUE when attempting a narrow run near the 250 metres. Apprentice Jockey Fawcett was shown footage of her ride in the presence of the Riding Master and advised to exercise greater care. Stewards took into account outward movement from CHELA CHOI when assessing the interference. Shifted ground inwards under pressure over the final stages and had to be straightened.

Race 7

ITM PINK BATTS SC MAIDEN 1800M

EM KAY POPS (P Shaikh) - Slow away.

MISTRESS POROTENE (M Tanaka) – Raced wide throughout.

LECTIO DIVINIA (K Cowan) – Steadied near the 800 metres.

JAYPERNO (L Hemi) – Lay inwards in the home straight and was in restricted room near the 150 metres.

BIG BEN (J Parkes) – Raced in restricted room over the final stages.

K Cowan (LECTIO DIVINIA) – Admitted a breach of Rule 638(3)(b)(ii) in that she used her whip excessively prior to the 100 metres and had her licence to ride in races suspended from conclusion of racing on 26 August to the close of racing on 1 September 2017 (2 days) and fined the sum of \$500.

Race 8

ITM SUPERIOR DOORS 2000M

Apprentice Jockey O'Malley (HIGH QUALITY) was fined \$100 under the minor infringement rule after failing to claim his full allowance

HAMILTONIAN (L Allpress) – Stood in its gate and was very slow away. (4 lengths). Shifted out under pressure in the home straight.

ONEFORTHEDITCH (S MacNab) – Slow away (6 lengths)

NITRO TED (T Johnson) – Over raced early.

HIGH QUALITY (S O'Malley) – Shifted out under pressure in the home straight. Momentarily inconvenienced near the 100 metres when HAMILTONIAN shifted ground outward.

Prior to the authorisation of dividends, an objection was lodged by the connections of the 2nd placed HIGH QUALITY (S O'Malley) against 1st placed HAMILTONIAN (L Allpress) alleging interference near the 100 metres. After hearing evidence and viewing footage the JCA dismissed the protest.
