Hampered as a result was DARK SEQUOIA.</p> <p>DARK SEQUOIA (S Weatherley) – Hampered 1000 metres.</p> <p>RUBY CHOUX ROSE (T Wenn) – Held up early in the final straight.</p> <p>Rider C Dell (LOWRIDER) – Admitted a breach of Rule 638(3)(b)(ii) for excessive use of the whip and was fined a sum of \$300.</p>
