Race 1	Coca-Cola Hurdle (2760 metres)
	CRUISEO (T Harris) - Hit the final fence and blundered unbalancing its rider.
	HER SON (C Price) - Slow to begin, retired from race prior to jumping the final fence.
	EL FERNANDO (P Hamblin) - Retired from race prior to jumping the final two fences.
	NEWSTEAD (R Cully) - Retired from race prior to jumping the final two fences.
	CRACKTHEGOODSTUFF (S Karnicnik) - Put in a poor jump at the fence approaching the 1000 metres, retired from race prior to jumping the final fence.

MANGATUTU (S Fannin) - Retired from race prior to jumping the final two fences.

NOMBERO (S Higgins) - Retired from race prior to jumping the final two fences.

JEM RUNNER (W Gordon) - Retired from race prior to jumping the final two fences.

LONELY BOY (C Studd) - Retired from race prior to jumping the final two fences.

THE ARABIAN DUKE (G Walsh) - Hit the second to last fence.

STORMING THE TOWER (E Farr) - Put in a poor jump at the final fence.

Race 2 | **JRA Trophy (1400 metres)**

ADMIRAL (H Marzuki) - Raced keenly in the lead through the middle stages.

BRANSOME (D Hain) - Had a tendency to lay outwards under pressure in the final straight.

FIRE JET (S Spratt) - When questioned regarding performance the rider advised that the gelding had failed to hit out in today's very testing track conditions. A post race veterinary inspection did not reveal any obvious abnormality.

Race 3 | **Hyland Race Colours Steeplechase (4150 metres)**

ZAMORA (E Farr) - Misjudged the first fence and landed awkwardly, continued to jump indifferently throughout.

PADDY OWEN (P Hamblin) - Put in a poor jump at the second fence on top of the hill on the first occasion, retired from the race prior to the second to last fence when well beaten rider advising that the gelding had never travelled comfortably in today's track conditions.

DECOY (M Cropp) - Landed awkwardly after jumping the fence near the 1700 metres and was inclined to jump indifferently at the rear throughout rider advising that the gelding was still green and would benefit from the experience of today's race.

E Farr (ZAMORA) - Spoken to regarding riding her mount out to the finish.

A Kuru - Fined \$300 by the Judicial Committee for excessive use of the whip on his mount TOP CHOICE prior to the 100 metres.

Race 4 | **Barfoot & Thompson Steeplechase (4150 metres)**

OUR JACKSON (I Lupton) - Misjudged the first fence landing very awkwardly.

THE KAKAHU EXPRESS (M Cropp) - Put in a poor jump at the fence near the 1700 metres.

ADEQUACY (R Cully) - Retired from the race prior to the first fence on top of the hill on the final occasion after becoming tailed off.

KANGAROO (E Farr) - Put in a poor jump at the first fence on top of the hill on the final occasion, retired from the race prior to the final fence when well beaten.

GLOBAL WARRIOR (S Higgins) - Retired from the race prior to the final fence when well beaten.

Race 5 | **Schweppes Great Northern Hurdle (4190 metres)**

HESALLJAZZ (H McNeill) - Hit the fourth fence, hampered by fallen runner 2000 metres, retired from the race prior to the fence near the 700 metres.

THENAMESBOND (J Seivwright) - Hit the fence near the 1000 metres on the first circuit, hit the fence near the 2200 metres, retired from the race prior to the fence near the 700 metres.

EL CORBY (G Walsh) - Hit the fence near the 700 metres on the first circuit, misjudged the fence near the 2000 metres and fell. Rider G Walsh was uninjured. EL CORBY required veterinary treatment for a small wound inside the left stifle and a small wound in the left nostril.

SHAMAL (M Cropp) - Trainer Mr K Duncan applied for and was granted permission to race without the declared gear of blinkers due to today's track conditions, hit the fence near the 700 metres on the first circuit, retired from the race prior to the second last fence.

MAX (I Lupton) - Retired from the race prior to the second last fence.

STORMIN NORMAN (S Fannin) - Poor jump final fence.

MONARCH CHIMES (W Gordon) - Poor jump final fence.

ZEDEEDUDADEEKO (C Studd) - Lost the right front plate during the running.

Race 6

SIERRA BEEL (M Du Plessis) - Jumped away awkwardly then being further hampered when runners to either side shifted ground.

MYRCELLA (M Coleman) - When questioned regarding performance rider advised that the mare had been unable to cope with today's extremely testing track conditions.

KENSINGTON (S Weatherley) - Lost the right front plate during the running.

Race 7

Irvines Great Northern Steeplechase (6400 metres)

AMANOOD LAD (A Kuru) - Made contact with the running rail when crowded leaving the centre on the first occasion when racing to the inside of UPPER CUT which was forced inwards by MR MOR (S Fannin). **S Fannin** was issued with a warning. Crowded near the 800 metres after jumping the second fence on top of the hill on the final circuit, shortly after being crowded rider lost left stirrup iron becoming unbalanced and being dislodged from his mount.

UPPER CUT (P Hamblin) - Hampered when crowded leaving the centre on the first occasion.

S Fannin - Suspended from the conclusion of racing today, Saturday 9 September 2017 until the conclusion of racing on Sunday 1 October 2017 (3 riding days) after admitting a charge of careless riding in that he permitted his mount MR MOR to shift inwards when not sufficiently clear crowding AMANOOD LAD after jumping the second fence on top of the hill on the second circuit.

MR MOR (S Fannin) - Blundered after jumping the fence near the 1300 metres on the second circuit.

MENDOZA (R Cully) - Put in a poor jump at the first of the double on the second circuit, retired from the race prior to the final fence, lost the right front plate during the running.

KINA WIN (S Higgins) - Poor jump at the fence near the 1400 metres on the final occasion, jumped the two fences on top of the hill on the final occasion indifferently, lost the left front plate during the running, dismounted shortly after

the finishing line and after being attended to by the Course Veterinarian was humanely euthanased after being found to have suffered a fracture to the left foreleg.

WISE MEN SAY (I Lupton) - Poor jump at the fence near the 1400 metres on the final occasion.

NELLS BELLE (E Farr) – Landed awkwardly after jumping the water jump, retired from the race prior to the final fence.

THE OYSTERMAN (H McNeill) - Landed awkwardly when negotiating the water jump.

TIZZA SECRET (W Gordon) - Landed awkwardly when negotiating the water jump, lost the left front and left hind plates during the running.

V Colgan - Suspended from the conclusion of racing on Saturday 16 September 2017 until the conclusion of racing on Friday 22 September 2017 (3 riding days) after admitting a charge that he used his whip excessively prior to the 100 metres on his mount EL LUCHADOR.

JAYLA MONET (L Innes) - When questioned regarding performance rider advised that the mare had failed to cope with today's track conditions.

CATARINA (M Coleman) - Rider advised that the mare had failed to handle today's track conditions.

SECONDS OUT (J Fawcett) - Lay out under pressure in the final straight inconveniencing STOKERS ROCK.

STOKERS ROCK (S Spratt) - Inconvenienced final straight.

COOL CASSIE (S Weatherley) - Slow away.

NO LOITERING (J Fawcett) - When questioned regarding performance rider advised that the gelding had raced keenly early then had been quickly beaten once placed under pressure in today's track conditions.

VIVA LA JOUR (M Hills) - Rider advised that the mare had failed to cope with today's extremely testing track conditions.
