Race 7 HAUNUI FARM KARAKA CLASSIC (1600 metres)
ROCKABYEBABY (A Collett) – Trainer C Gibbs advised Stewards that the mare underwent a veterinary examination upon return to his stable which revealed a fractured pedal bone in the right foreleg, with Mr Gibbs adding that ROCKABYEBABY would now be retired from racing.

COLORADO BAY (K Cowan) –Began awkwardly settling back.	
Race 2	NZB INSURANCE PEARL SERIES RACE 1200
CARAMAC (S MacNab) – Bumped with ROSEWOOD passing the 1000 metres when racing keenly.	
ROSEWOOD (A Chan) – Bumped with CARAMAC near the 1000 metres. Improved on to heels just prior to the winning post having to be steadied.	

NEW YORK MINUTE (J Parkes) – When questioned regarding the performance Rider J Parkes advised Stewards that the mare may have found carrying 61.5kg on a heavy track too testing. However further advised in his opinion NEW YORK MINUTE would derive benefit from today's race.	
Race 3	DENIS WHEELER EARTHMOVING MDN 1300
<p>VALENTIA (J Riddell) – Slow away.</p> <p>PRINCESS DILLON (D Hain) – Slow away.</p> <p>CAPBLAMO (L Allpress) – Raced ungenerously when being restrained in the early stages. Momentarily inconvenienced passing the 500 metres when improving up on to the heels of the tiring TOM LYFORD.</p> <p>TOM LYFORD (K Cowan) – Raced keenly in the early stages. Commenced to give ground approaching the 400 metres.</p>	
Race 4	TARANAKI PINE 1300
<p>ACCOLADES (K Cowan) – Refused to leave its barrier and took no part in the race. Connections were advised the mare must barrier trial to the satisfaction of the Stewards prior to racing next.</p> <p>MISS LIZZIE (A Jones) – Raced wide without cover throughout.</p> <p>SMOKEN' ACE (H Andrew) – Briefly held up rounding the final bend before being tightened having to be restrained approaching the 200 metres, when UJUMPIJUMP (D Hain) shifted out under pressure and TARA TOA (L Hemi) shifted in. Both D Hain and L Hemi were advised to exercise greater care.</p> <p>UJUMPIJUMP (D Hain) – Lay out under pressure in the home straight.</p> <p>AGOODDEAL (L Allpress) – When questioned regarding the performance Rider L Allpress advised Stewards the mare had failed to handle today's holding track conditions.</p> <p>ISHINKTAATLEDO (A Chan) – Slow to begin.</p>	
Race 5	EKRAAR & ECHOES OF HEAVEN @ LINWOOD PARK 1400
<p>TABARD (R Myers) – Slow to begin.</p> <p>ITSAGEM (L Allpress) – Placed in restricted room having to be steadied near the 1250 metres when IMPULSIVE HABIT (T Thornton) shifted outwards abruptly away from RESURRECT when making the crossing on to the course proper.</p> <p>BATCHELOR BABE (A Chan) – Steadied when placed in restricted room near the 500 metres. Bumped entering the home straight when TABARD angled for a marginal run. R Myers was advised to exercise care.</p> <p>RESURRECT (V Colgan) – Had to be steadied when becoming awkwardly placed on the heels of JUSTLIKEYASISTER (T Johnson) who was forced inwards by BATCHELOR BABE (A Chan) passing the 1100 metres. Apprentice A Chan was issued with a warning.</p> <p>IMPULSIVE HABIT (T Thornton) – Raced ungenerously when placed in restricted room for a distance approaching the 1000 metres. When questioned regarding the performance Rider T Thornton advised that the gelding had failed to handle today's holding track conditions.</p>	
Race 6	POWERWORX GREYS 1400
I SUGGEST (M Singh) – Raced in restricted room inside the final 100 metres when OUR KING SWAY lay out under pressure.	

SILVER COURT (T Thornton) – Connections advised that the gelding would now be retired.

CARTAGENA (D Hirini) – Slow away (3L).

ALFIE DEE (A Chan) – Raced keen in the early and middle stages.

BLAZING OPAL (S MacNab) – Raced keenly in the middle stages. When questioned into the performance Apprentice S MacNab stated that after racing keenly the gelding had failed to finish the race off.

ITSALLBELT (h Andrew) – Over raced in the early and middle stages.

NOTHING TRIVIAL (T Thornton) – When questioned into the performance Rider T Thornton advised that in her opinion the gelding had failed to see out the distance of today's race. Underwent a post-race veterinary examination which failed to reveal any abnormality.

THATZ DAVID (D Bradley) – When questioned into the performance Rider D Bradley could offer no excuse. Underwent a post-race veterinary examination which failed to reveal any abnormality.

GEORGETHEFIFTH (K Cowan) – Improved on to the heels of the weakening NOTHING TRIVIAL near the 500 metres having to shift ground outwards.

GO TO MAN (S McKay) – Bumped with ONEFORTHEDITCH at the start settling back. When questioned regarding performance Apprentice S McKay advised Stewards that the gelding had not handled today's track conditions. A Post race veterinary examination did not reveal any abnormality.

ONEFORTHEDITCH (R Myers) – Began awkwardly making contact with GO TO MAN, losing ground.
