RACE COMMENTS:

Race 1 FARM SOURCE 1200m

CUIDADO CALIENTE (K Cowan) – Tightened at the start when **SON OF SURF** jumped inwards settling back. Raced keenly in the early stages. Lay out in the home straight dictating **KARIMA** wider on the track approaching the 200 metres.

KARIMA (J Parkes) – slow away, dictated wider on the track approaching 200m.

MR WILBAR (D Bradley) – Slow away. Raced three-wide without cover throughout. Was not persevered with over the final stages. When questioned rider advised that the gelding had been making respiratory noises during the running. A subsequent veterinary examination revealed the gelding to have a slow post-race recovery and the veterinary surgeon was of the opinion the gelding may have choked down during the running.

SON OF SURF (D Hirini) - held up for a distance passing the 600 metres

WESTSIDE (A Chan) - Rider dropped the whip at the 200 metres. Raced greenly in the home straight.

DRAIOCHTA (M Cameron) – Rider advised the colt had raced greenly throughout.

M CAMERON (Draiochta) – Admitted a charge under Rule 638 (3) (b) (ii) in that he used his whip excessively prior to the 100 metres and was fined \$300.

Race 2 BRUCE CLIFTON BUILDER/SUMMIT ELECTRICAL 1200m

SPONDULIX (A Chan) – Fractious in the barrier prior to the start then was slow away.

BLOOMSBURY (R Myers) - Tightened at the start losing ground when **KEEP DANCING** jumped outwards abruptly at the start bumping **PERAZZO**.

KEEP DANCING (C Waddell) – Jumped outwards at the start bumping. Shortly after the start ducked outwards inconveniencing **PERAZZO**. Lay out rounding the home turn.

VINCENT (J Parkes) – Bumped approaching the 100 metres when RUFUS RUFFCUT ducked inwards under hard riding.

RUFUS RUFFCUT (L Allpress) - Ducked inwards approaching the 100 metres bumping having to be straightened.

SARDEEN (K Cowan) - Lay in under pressure passing the 100 metres.

ILLIE O'CEIRIN (A Collett) – Checked 75 metres.

J Parkes – the rider of the second placed VINCENT lodged a protest against the winner RUFUS RUFFCUT alleging interference in the home straight. After viewing footage and hearing submissions from connections of both runners the Judicial Committee dismissed the protest.

All in bloom (T Allan) – Checked when MAGICELLA (D Turner) shifted ground when not sufficiently clear passing the 75 metres. ALL IN BLOOM was dictated outwards on to ILLIE O'CEIRIN (A Collett) who was also checked. Rider D Turner admitted a charge under Rule 638 (1) (d) and the Judicial Committee suspended his licence to ride in races from the close of racing on Sunday, 8 October up to and including racing on Thursday, 19 October – five days.

Race 3 CLARENDON HOTEL 1650m

MISTER GERONIMO (A Collett) – slow away

CORNERSTONE (L Hemi) – slow away

KING MAX (S O'Malley) – Slow away then improved quickly to sit three-wide without cover outside the leaders passing the 1,400 metres. S O'Malley was reminded of his obligations regarding whip use.

COASTAL DROUGHT (D Bradley) - tightened shortly after the start having to be restrained

HANDYMAN (H Andrew) - raced keenly in the early stages

WHOSHOTMYMATE (S McKay) – Dictated outwards approaching the 250 metres when **LEICACUTCUT** improved to the inside.

Following the running of this race Jockey **D TURNER** was inspected by St John paramedics and was stood down for the remainder of the day due to injury. D Turner will require a medical clearance prior to riding again.

Race 4 MARKHAMS/FOMS 1400m

AMACHI (S O'Malley) - began awkwardly and was slow away (21)

SIOUX (L Hemi) – raced three-wide without cover in the early stages

LOOK OUT (C Waddell) - Held up for a distance passing the 400 metres and again approaching the 200 metres.

CHONNEY (L Allpress) – raced in restricted room early in the home straight when runners either side shifted ground

NEWTON (M Cameron) – When questioned rider advised the gelding had been caught wide in the early stages and being fresh up had been unable to finish the race off. A subsequent veterinary report revealed normal post-race condition, with the gelding losing the near fore plate during the running.

Race 5 MITAVITE 1200m

GARFUNKEL (R Myers) – slow away

CASSIE ANNE (J Parkes) – Slow away. Had to be restrained when in restricted room passing the 100 metres when **SIR KINGWOOD (M Singh)** shifted outwards after becoming awkwardly placed on the heels of **HUNDYAMONTH (L Allpress)** who shifted ground. After viewing footage and evidence from riders Stewards could not conclusively establish that any one rider was at fault and no further action was taken. Rider M Singh was advised to exercise care.

HUNDYAMONTH (L Allpress) – Raced greenly in the home straight when under pressure.

SIR KINGWOOD (M Singh) – Disappointed for a run passing the 200 metres then shifted outwards when awkwardly placed on heels passing the 100 metres having to be angled inwards to gain clear running.

PINSRAAD (K Cowan) – Raced three-wide without cover throughout. Ran in under pressure passing the 100 metres tightening **DRAMATIST** who had to be restrained. K Cowan admitted a charge under Rule 638 (1) (d) and had her licence to ride in races suspended from the close of racing on Sunday, 8 October up to and including racing on Sunday, 15 October – five days.

DRAMATIST (A Collett) - Tightened having to be restrained 100 metres.

Race 6	ULTRA SCAN 2200m

WHIORAU (S Weatherley) – slow away

FUSION (M McNelis) – tightened passing the 1,700 metres

COUNTER ATTACK (T Allan) – Inconvenienced and dictated wider on the course approaching the 1,700 metres when **DEZZY MAC** shifted out when being restrained. **DEZZY MAC** then shifted inwards tightening **FUSION** passing the 1,700 metres.

DEZZY MAC (A Collett) – improved three-wide without cover from the 1,200 metres

JAYPERNO (L Hemi) - Briefly held up approaching the 500 metres. Lay in under pressure in the home straight.Race 7SANDFORDS 2200m

BLAZING OPAL (S O'Malley) – The gelding suffered an abrasion to its nose on the way to the track. Following a veterinary inspection **BLAZING OPAL** was declared a late scratching at 4.02 pm.

SEA CRUISER (K Cowan) – Slow away then commenced to give ground passing the 1,400 metres finishing a distance last. When questioned rider could offer no excuse. A subsequent veterinary examination revealed pain over the hind quarter muscles. A veterinary clearance is required prior to next racing.

I'VE GOT THIS (R Myers) - slow away

NOM DE BOSS (L Hemi) - Raced ungenerously when being restrained passing the 1,700 metres.

J PARKES (All in Luck) -was reminded of his obligations regarding whip use
