M McNab – Fined \$400.00 by the Judicial Committee after admitting a breach in that he failed to make the contracted weight for AVANTAGE and IMPERIUM.

Race 1	RICCARTON PARK FUNCTION CENTRE MAIDEN (1400m)
<p>FALTAINE (R Bishop) – Crowded start losing ground.</p> <p>TE QUIERA (G Jogoo) – Began awkwardly. Raced ungenerously when being steadied in the early stages.</p> <p>STITCH (S Wynne) – Over raced in the early stages.</p> <p>HANNAH MARENE (C Johnson) – Raced keenly in the early and middle stages.</p> <p>DON'T SHUFFLE ME (A Morgan) – Raced wide throughout.</p> <p>JUST (J Lowry) – Crowded approaching the 1200 metres to the inside of NAME OF THE STARS which lay in and away from DON'T SHUFFLE ME. As a result JUST had to be steadied, shifting back onto CINNAMON KISS which was hampered.</p> <p>CINNAMON KISS (R Cuneen) – Hampered 1200 metres and steadied.</p> <p>FEROCIOUS (S Muniandy) – Had some difficulty obtaining clear running in the early straight, shifting out passing the 200 metres.</p>	
Race 2	SPEIGHT'S MAIDEN (1400m)
<p>MISS DOLCE VITA (J Morris) – Began awkwardly. Raced ungenerously throughout and hung out when placed under pressure in the final straight and could not be ridden to full advantage.</p> <p>LAY OFF (C Johnson) – Crowded leaving the barrier.</p> <p>DAMANAKA (J Lowry) – Raced wide in the early stages.</p> <p>DONT GET COURT (T Moseley) – Commenced to over race when being restrained in the early stages making contact with ABOLI which was racing ungenerously. DONT GET CAUGHT and ABOLI then raced in restricted room to the inside of HEART OF COURAGE (M McNab) which shifted in slightly passing the 1000 metres with DONT GET COURT having to be further restrained, losing ground. Rider M McNab was reprimanded by Stewards and advised that a warning would be placed on his record taking into account the racing manners of ABOLI and DONT GET COURT at the time.</p> <p>BON SHOWVI (R Bishop) – Contacted and unbalanced passing the 1000 metres. Raced wide for the majority of the event.</p>	

FIRE LILY (K Williams) – Raced wide throughout.

ROULETTE (R Yatim) – Raced ungenerously passing the 1000 metres.

CAPONE IN CHARGE (S Wynne) – Commenced to over-race approaching the 800 metres and then raced in restricted room to the inside of DAMANAKA (J Lowry) which shifted in slightly. J Lowry was advised to exercise greater care.

OUR NINA (D Prastiyou) – Steadied off heels passing the 500 metres and then held up for a distance.

A Morgan (SARONIC MISS) – Admitted a breach of Rule 638(3)(b)(ii) in that she used her whip excessively prior to the 100 metres, with the Judicial Committee imposing a fine of \$300.

J Lowry (DAMANAKA) – Issued with a warning for his whip use in the final straight.

M McNab (HEART OF COURAGE) – Issued with a warning for his whip use in the final straight.

THUNDER BAY (P Shaikh) – Slow to begin. Dipped passing the 75 metres.

ANNE (T Jonker) – Raced wide throughout. Lay inwards when placed under pressure early in the final straight.

Race 4	PRYDE'S EASIFEED RATING 75 (1600m)

SON OF ZAC (T Jonker) – Slow to begin. Raced wide for the majority of the event.

NOT AVAILABLE (S Muniandy) – Raced wide in the early stages.

DISTURBANCE (C Johnson) – Over raced in the early stages having to be restrained off heels passing the 1000 metres.

CAPO (S Wynne) – Steadied when awkwardly placed on heels approaching the 1000 metres. Steadied again passing the 600 metres when awkwardly placed.

WHAT'S UP ALF (G Bourke) – Held up rounding the final turn and early in the final straight.

MONTRACHET (A Collett) – Hampered approaching the 300 metres when laying in across the heels of GRAZIA which shifted out slightly.

T Jonker (SON OF ZAC) – Issued with a warning for her whip use in the final straight.

HOU LA LA (J Morris) – Began awkwardly losing ground, raced wide throughout.

JUMEIRAH (C Johnson) – Slow to begin. Steadied passing the 450 metres when improving into restricted room between SWEET TIME (P Shaik) and SHEZATOUCHA (G Jogoo) which both shifted ground under pressure with JUMEIRAH then shifting in to obtain clear running. Riders P Shaik and G Jogoo were advised to exercise greater care in a similar circumstance.

FIRST OF A KIND (L Callaway) – Commenced to over race passing the 1400 metres becoming awkwardly placed on heels then having to be further restrained for a distance losing ground.

SHEZATOUCHA (G Jogoo) – Became awkwardly placed inside heels approaching the 1200 metres and was steadied shifting back onto GOLDEN BAY which was also steadied.

GOLDEN BAY (D Prastiyou) – Steadied for a distance at the 1200 metres.

THE KRAKEN (S Muniandy) – Raced keenly for a distance through the middle stages.	
D Prastiyou (GOLDEN BAY) – Issued with a warning for his whip use in the final straight.	
Race 6	INGLEWOOD STUD GUINEAS TRIAL (1400m)
IRISH EXPRESS (S Wynne) – Began awkwardly and then crowded losing ground.	
SAVVY COUP (A Morgan) – Over raced when being restrained in the early stages and then raced fiercely through the middle stages.	
AGE OF FIRE (M McNab) - Shifted in under pressure over the final 200 metres with HOT FUSS moving away from that runner.	
S Wynne (IRISH EXPRESS) – Issued with a warning for her whip use in the final straight.	
Race 7	COUPLAND’S BAKERIES MILE PRELUDE (1400m)
LA DIOSA (R Cuneen) – Slow to begin. When questioned R Cuneen advised that the mare had found the conditions too testing in a fresh condition.	
TIMY TYLER (G Bourke) – Raced ungenerously when being restrained in the early and middle stages.	
NO EMOTION (P Shaikh) – Raced ungenerously when steadied in the early stages. Hampered and forced wider passing the 450 metres when WIZE ACT (K Williams) shifted out to obtain clear running. As a result NO EMOTION made contact with FLAG THE GROOM which was dictated wider on the track. K Williams was severely reprimanded by Stewards and advised that a warning would be placed against her record.	
FLAG THE GROOM (S Wynne) – Forced wide 450 metres.	
R Cuneen (LA DIOSA) – Issued with a warning for his whip use prior to the 100 metres.	
Race 8	WAIMAKARIRI BUSINESSES NORTH CANTERBURY CUP (2000m)
IMPERIUM (A Collett) – Began awkwardly, losing considerable ground. The connections were advised that a warning would be placed against the gelding. When questioned regarding the performance, Rider A Collett advised that after a poor beginning the gelding had never recovered. A post-race veterinary inspection did not reveal any obvious abnormalities.	
NIGHT NURSE (K Gundowry) – Held up early in the final straight and then raced in restricted room for a distance.	
PLATINUM COMMAND (S Wynne) – Rider S Wynne advised the mare had traveled comfortably but had not responded as anticipated when placed under pressure in the final straight. A post-race veterinary inspection did not reveal any obvious abnormalities.	
Rider T Mosely (WHAT A DEEZA) accidentally struck Rider K Kwo (LOCALLY SAUCED) with the whip near the 250 metres.	
Race 9	RANGIORA NEW WORLD RATING 75 (1200m)
ZAWHIP (S Wynne) – Began awkwardly. Became awkwardly placed on heels passing the 50 metres and was inconvenienced.	
STROWAN (M McNab) – Raced keenly in the early stages. Shifted in under pressure passing the 150 metres becoming awkwardly placed.	
CARNIVAL (T Jonker) – Lay inwards when placed under pressure in the final straight.	

Race 10	PLOUGH HOTEL RATING 65 (1400m)
<p>M Harris - Issued with a warning for presenting OLIGARCH with incorrect gear (blinkers instead of side blinkers).</p> <p>NOWHERE MAN (K Gundowry) – Slow to begin. Shifted in under pressure over the concluding stages.</p> <p>MACY (S Muniandy) – Raced keenly in the early stages.</p> <p>OLIGARCH (T Jonker) – Raced wide throughout.</p> <p>INDY EVOLUTION (A Morgan) – Got its head up when being restrained to take a trail passing the 1000 metres.</p> <p>A Morgan (INDY EVOLUTION) – Admitted a breach in that she used her whip in an excessive manner. Following submissions Stewards requested to withdraw the charge which was granted by the Judicial Committee.</p>
