GENERAL:

No issues to report.

RACE COMMENTS:

Race 1 PRYDE'S EASIFEED RATING 75 (1800m)

WHO DARES WINS (S Wynne) - Began awkwardly, raced ungenerously when being restrained in the early and middle stages.

WISE MOVE (K Kwo) - Commenced to over race when the pace eased having to shift outwards to avoid the heels of HONOR THAT near the 1400 metres.

SON OF ZAC (T Jonker) - When questioned regarding performance, rider T Jonker advised that the gelding had not been suited by the slow tempo of the race and had been left flat footed when the pace quickened approaching the home turn.

Race 2 NZB INSURANCE PEARL SERIES TWO YEAR OLD (800m)

DEVIOUS (J Waddell) - Late scratched on veterinary advice after becoming fractious and rearing over backwards in the barriers. The connections were advised that the colt must barrier trial to the satisfaction of a Stipendiary Steward prior to racing next.

PATSYS LASS (T Moseley) - Hampered leaving the barriers when ANNE jumped outwards losing ground. Underwent a veterinary inspection after returning to the birdcage with blood present in the mouth which revealed a minor laceration having bitten its tongue.

THUNDER BAY (P Shaikh) - Held up rounding the final turn passing the 500 metres.

DREAMTESTA (R Cuneen) - Lost a hind plate during the running.

Race 3 NZB READY TO RUN SALE RATING 65 (1200m)

ZAKYNTHOS (S Wynne) - Began awkwardly, had to be steadied to avoid the heels of MYSTIFY ME which shifted away from GLOSS near the 200 metres.

ZOUGA (T Moseley) - Began awkwardly.

MYSTIFY ME (L Callaway) - Raced wide throughout.

MAUI MISS (J Lowry) - Raced keenly in the middle stages.

J Waddell (BARABAS) - Admitted a charge of careless riding in that he permitted his mount to shift outwards near the 300 metres when not sufficiently clear of LADY AMADEUS which was checked. The Judicial Committee suspended J Waddell's licence to ride at race meetings for 4 days effective 29 October to 7 November inclusive.

LADY AMADEUS (S Weatherley) - Checked 300 metres when BARABAS shifted ground outwards.

Race 4 CANTERBURY LANDSCAPE SUPPLIES 75 (1200m)

CARNIVAL (T Jonker) - Began awkwardly.

O'KIWI (K Gundowry) - Slow to begin and then further hampered when crowded.

ENZO'S LAD (BB Hong) - Raced wide throughout.

BB Hong (ENZO'S LAD) - Admitted a breach of Rule 638(3)(b)(ii) for excessive use of the whip prior to the 100 metres with the Judicial Committee imposing a fine of \$500.

QUEEN SERENE (A Morgan) - Raced wide throughout.

P Shaikh (MR TYPHON) - Charged with using his whip excessively prior to the 100 metres with Mr Shaikh initially denying the breach. During the course of the hearing Mr Shaikh's employer Mr M Pitman sought leave of the Judicial Committee to amend the plea to admitted which was granted. After viewing films and hearing submissions the Judicial Committee imposed a fine of \$600.

MAL D'MOUR - Rider S Wahab reported that the saddle shifted backwards passing the 400 metres.

Race 5

COUPLAND'S BAKERIES MILE TRIAL (1400m)

BOOTS 'N' ALL (K Williams) - Slow to begin, over raced when being restrained approaching the 800 metres when shifting outwards to avoid the heels of TOMMY TUCKER and forcing TIMY TYLER to a three wide position.

LA DIOSA (R Cuneen) - Blundered on jumping and as a result got back, held up in the early stages of the run home having to shift ground outwards to obtain clear running near the 250 metres.

TIMY TYLER (K Kwo) - Raced three wide without cover from the 800 metres.

K Williams (BOOTS 'N' ALL) - Reminded of her obligations to ride her mounts out fully to the finish after narrowly gaining 5th placing despite relaxing her ride over the concluding stages.

TOMMY TUCKER - When questioned regarding performance, rider J Lowry advised that the large weight carried and being fresh up had taken its toll and he believed the gelding would take benefit from the run.

Race 6

ZACINTO STAKES (1600m)

LETSBRINGITON (C Barnes) - Slow to begin.

ZENTESSA (A Jones) - Slow to begin.

IRISH EXPRESS (J Lowry) - Jumped away awkwardly, when attempting to recover was checked passing the 1400 metres when crowded for room by TALKABOUTME (A Morgan) which after racing in restricted room between THE SPARKLE (S Muniandy) and RIVER RUN lay in across the heels of RIVER RUN when being steadied. S Muniandy and A Morgan were both advised to exercise greater care. Steadied when awkwardly placed on heels near the 900 metres and then blundered shortly after. Underwent a post race veterinary inspection which did not reveal any obvious abnormalities.

AKOYA PEARL (L Callaway) - Commenced to over race passing the 1400 metres and continued to do so through the middle stages.

THE SPARKLE (S Muniandy) - Raced ungenerously when being restrained going into the bend near the 1000 metres, forced wider on the track rounding the bend near the 400 metres.

THE LUSTRE (T Jonker) - Raced three wide without cover for the majority of the race, forced wider on the track rounding the bend near the 400 metres.

SWING NOTE (S Weatherley) - Bumped at the 750 metres when TALKABOUTME ducked outwards after brushing the running rail with SWING NOTE then becoming awkwardly placed inside the heels of THE SPARKLE, forced wider on the track rounding the bend near the 400 metres.

UPPERHAND (J Morris) - Hung outwards rounding the final bend forcing THE SPARKLE, SWING NOTE and THE LUSTRE wider on the track approaching the 400 metres.

SCOTT BASE (S Wynne) - Had some difficulty obtaining clear running rounding the final bend before shifting back to the inside to obtain clear running passing the 400 metres and was then inclined to lay out when placed under pressure.

Race 7

CHRISTCHURCH CASINO SPRING CLASSIC (2000m)

NO EMOTION (P Shaikh) - Blundered badly at the start and got back.

KINGS PAL (S Muniandy) - Raced wide in the early stages.

FIVE KINGS (R Cuneen) - Raced wide from the 600 metres.

ASPEN LASS (S Wynne) - Held up in the early stages of the run home only obtaining clear racing room inside the 150 metres.

Race 8 SONIA & GARRY

SHOCKTILLYOUDROP (S Wynne) - Jumped away awkwardly, hampered when becoming awkwardly placed on the heels of the weakening MYSTERY MAN rounding the bend near the 450 metres and was then held up for a short distance.

RAPT N RED (T Moseley) - Very slow to begin losing several lengths.

DREAM RICH (C Campbell) - Began awkwardly.

PENDLETON (J Waddell) - Raced wide from the 900 metres, checked 300 metres.

FORGED (S Muniandy) - Raced keenly in the lead in the middle stages.

K Williams - Admitted a charge under Rule 638(1)(d) in that she permitted her mount to shift outwards near the 300 metres when not sufficiently clear of PENDLETON which was checked, with the Judicial Committee suspending her licence to ride at race meetings for 2 riding days effective 29 October to 5 November inclusive.

MYSTERY MAN (S Weatherley) - Eased down in the final straight with the rider reporting there may be something amiss with the gelding. Underwent a post race veterinary inspection which did not reveal any obvious abnormalities.
