#### Race 4 J&R CONTRACTING 1400

**MAID OF STEEL** (M McNab) – Trainer T Pike advised Stewards that he was satisfied with the recovery of the mare and it is his intention to continue on with its current preparation.

### **Race 7 PARTNERS LIFE SOLILOQUY STAKES**

**CHARLI ROSE** (M McNab) – Trainer A Forsman advised Stewards that in the days following its performance in this race the filly underwent blood tests which did not reveal any abnormality, Mr Forsman added it is their intention to continue on with its current preparation on improved track conditions as he believed she was unsuited by the Slow 9 track conditions on this occasion.

### Race 7 GRANT PLUMBING THOMPSON HANDICAP (1600 metres)

**BEAUMARCHAIS** (D Johnson) – Trainer J Richards advised Stewards that he was satisfied with the recovery of the gelding and it is their intention to continue on with its current preparation.

#### **RACE COMMENTS:**

### Race 1 COMCAT MDN 2000M

MASTER COURTSMAN (S McKay) – Slow to begin.

PATRICIA ROSE (J Nason) – Crowded shortly after the start having to be steadied.

### Race 2 TOTAL PAINT SUPPLIES MDN 3YO 1300M

**OFF THE GRID** was scratched in error by the TAB briefly before being rectified and the correct runner MIGHTY POWER was scratched.

**KING'S VEE** (S Weatherley) – Hampered when crowded shortly after the start.

OFF THE GRID (J Riddell) – Raced three wide without cover.

**PLATINUM CHANEL** (M Tanaka) – Raced wide without cover.

ICEBOMB (C Lammas) – Received post race veterinary treatment after suffering a bout of colic.

J Parkes (BRIMM) – Was reminded of his obligations in relation to use of the whip prior to the 100 metres.

### Race 3 STELLA ARTOIS MDN

**HOW'S THAT GIRL** (K Cowan) – Reared in the barrier dislodging its rider, was then removed to undergo a veterinary inspection before being passed fit to run.

**WESTPORT QUAY** (S Weatherley) – Slow away. Checked near the 1050 metres.

**K Cowan** (HOW'S THAT GIRL) - Admitted a breach of careless riding in that she permitted her mount to shift inwards when not sufficiently clear of WESPORT QUAY (S Weatherley) which was checked near the 1050 metres. After hearing submissions the Judicial Committee suspended Miss Cowan's licence to ride in races from the conclusion of racing on Saturday 4 November until the conclusion of racing on Saturday 11 November (5 national riding days).

PRETTY LIPPY (D Hirini) – Hung outwards throughout the running.

**BRIMM** (J Parkes) – Over raced in the early and middle stages.

## Race 4 THE GRAHAM COCHRANE, BAYLEY 1200M

**HONEY RIDER** (J Riddell) – When questioned regarding the performance rider was of the opinion that the mare had failed to handle today's track conditions.

### Race 5 WAIKATO EQUINE VET CENTRE MDN 1400M

**SPONDULIX** (S Collett) – Slow away.

**COTTONEVA** (J Parkes) – Slow away.

BELLE CANTO (R Myers) – Had a tendency to over race in the early and middle stages.

KEEPARIO (T Johnson) - Raced wide without cover.

MISSTART (J Nason) - Held up until passing 200 metres.

**D Bradley** (EXONERATE) – Was issued with a warning for his use of the whip prior to the 100 metres.

## Race 6 ISABELLA SPIERS 1400M

**ALAMCFERSON** (S Weatherley) – Rider dropped his whip passing the 200 metres.

**GLADSTONE BELLE** (A Jones) – Unbalanced when bumped near the 175 metres when WOODBINE LADD (T Johnson) shifted outwards. Apprentice T Johnson was advised to exercise greater care.

**WOODBINE LADD** (T Johnson) – Shifted outwards over the final stages.

**STREET RANGER** (J Riddell) — When questioned regarding the performance rider advised that the mare had made abnormal breathing noises during the running. Underwent a post race veterinary inspection which did not reveal any abnormality.

ENJOY THE RIDE (J Fawcett) – Ducked outwards near the 150 metres.

## Race 7 C & C AUTOS 1800M

**G Hayward** (CALL DOUBT) – Admitted a breach of Rule 802(1)(a) in that she failed to comply with a NZTR directive that horses must be presented in the tie up stall area by one hour prior to the horse's race having saddled CALL DOUBT in a stable outside of the designated area. After hearing submissions the Judicial Committee imposed a fine of \$250.

**PIAZZA** (S Weatherley) – Was placed in restricted room over the concluding stages when TIME BOMB (R Myers) shifted out slightly. R Myers was advised to exercise greater care.

**CALL DOUBT** (H Andrews) – When questioned regarding performance rider was unable to offer any excuses other than the gelding possibly struggling under its top weight in today's track conditions.

### Race 8 SEATON PARK 1800M

J Fawcett was permitted to ride BELLA BLUE as there was no suitable senior rider available.

**BELLA BLUE** (J Fawcett) – Slow away.

**RHYMIC DANCER** (K Cowan) – Slow away.

**KAIRANGA LAD** (J Parkes) – When questioned regarding performance rider advised that the gelding had failed to handle today's track conditions.
