**DRAGON STORM** (O Bosson) – Trainer C Gibbs advised Stewards that he was satisfied with the recovery of the colt, adding it is their intention to added blinkers to its notifiable gear and continue on with its current preparation.

Racing Tauranga - 4 November 2017 Race 2 - CLASSIC CUISINE 1200 **MONGOLIAN GENERAL** (O Bosson) – Trainer A Forsman advised Stewards that he was satisfied with the recovery of the colt and it is their intention to continue on with its current preparation.

**BREAK MY STRIDE** (O Bosson) – Trainer A Forsman advised Stewards that he was satisfied with the recovery of the gelding and it is their intention to continue on with its current preparation.

**MANGAROA FIRE** (L Satherley) – Removed from the barrier after becoming fractious and was cleared fit to race after undergoing a veterinary examination. Crowded 1800 metres.

**BELLE VOLANT** (C Dell) – Crowded passing the 1800 metres to the inside of MANGAROA FIRE which was dictated inwards by MEDINI (T Thornton) which shifted in when not clear. **T Thornton** was issued with a warning. BELLE VOLANT steadied and shifted out when becoming awkwardly placed 600 metres.

SWITCH PITCHER (S Collett) – Made the bend awkwardly passing the 1800 metres and then raced keenly.

Race 2AJC MEMBERS 1200DEUCALION (V Colgan) – Began awkwardly.

SUNBURST (M Coleman) – Commenced to over-race passing the 1000 metres making the bend awkwardly.

**THE SWISS MAESTRO** (S McKay) – Slow away then crowded shortly after. Steadied off heels 900 metres. Steadied when improving onto the heels of THE ICE KNIGHT which shifted out over the concluding stages. M McNab was advised to exercise greater care when shifting ground.

**RUNNING MAN** (O Bosson) - Raced ungenerously when being restrained in the early stages.

**URALLA** (S Collett) – Was found to be lame following the race in the left foreleg with the filly requiring a veterinary clearance prior to racing next.

## Race 3 AVONDALE 1200

TIME LORD (A Collett) – Began awkwardly losing ground. Inconvenienced 1000 metres.

**TIN SOLDIER** (C Dell) – Slow to begin then crowded. Commenced to race ungenerously having to be firmly restrained passing the 1000 metres when becoming awkwardly placed on heels, continuing to race ungenerously through the middle stages.

**AULYN DANCER** (L Innes) – Became awkwardly placed on heels shortly after leaving the barriers losing ground. Steadied passing the 1000 metres when in restricted room to the inside of JIMMY ROCKET (V Colgan) which shifted in when not sufficiently clear losing ground. V Colgan was advised to exercise greater care.

RAPOSA RAPIDA (D Johnson) - Raced three wide without cover.

**SHOW ME YOUR PINS** (M Coleman) – Raced ungenerously when being steadied in the early stages making the 900 metre bend awkwardly.

SCARFI (C Lammas) – Steadied for a distance when awkwardly placed on heels near the 750 metres.

**CROSSEDEM** (J Waddell) – Lay out when placed under pressure in the final straight shifting out abruptly near the 150 metres inconveniencing RAPOSA RAPIDA. Following the race the connections of the 2<sup>nd</sup> placed horse RAPOSA RAPIDA

wished to view Stewards footage alleging interference by the 1<sup>st</sup> placed horse CROSSEDEM electing not to proceed with a protest.

**M Coleman** SHOW ME YOUR PINS – Issued with a warning for the use of the whip prior to the 100 metres.

#### Race 4 AVONDALE SUNDAY MARKETS 1200

DAZED AND CONFUSED (O Bosson) - Slow to begin

**MARC ONE** (C Dell) – Crowded shortly after the start having to steady.

COPPER XPRESS (H Marzuki) - Slow to begin.

**THE REBEL KNIGHT** (T Thornton) – Commenced to over-race in the early stages shifting out near the 1000 metres forcing COPPER EXPRESS over extra ground. THE REBEL KNIGHT then raced wide without cover.

COPPER EXPRESS (H Marzuki) – Forced wider at the 1000 metres and then raced wide for the remainder of the race.

**LOVERS LANE** (J Waddell) – Became awkwardly placed on heels shortly after the start having to be steadied. Shifted out to obtain clear running 350 metres inconveniencing ALL TRUMPED UP and then lay out for the remainder of the race.

J Fawcett (CLARIOS) – Admitted a breach of careless riding in that she allowed CLARIOUS to shift in passing the 1000 metres when not clear of ALL TRUMPED UP and NEON LIGHT which were both crowded and hampered with the Judicial Committee suspending her license to ride in races from the conclusion of racing on 14 November up to and including racing on 18 November, 4 national riding days

**T Harris** (FOREVER BLUE) – Admitted a breach of careless riding in that he allowed FOREVER BLUE to shift in near the 900 metres when not sufficiently clear of NARVICK which was forced in onto ALL TRUMPED UP which was checked with the Judicial Committee suspending his license to ride in races from the conclusion of racing on 12 November up to and including racing on 17 November, 4 national riding days

ALL TRUMPED UP (M Vance) – Crowded and hampered passing the 1000 metres. Crowded and checked 900 metres. Inconvenienced 350 metres.

NEON LIGHT (C Lammas) - Crowded and hampered passing the 1000 metres.

**MARC ONE** (C Dell) – Made heavy contact with the running rail passing the 500 metres with rider becoming briefly unbalanced.

## Race 5 WESTBROOK.CO.NZ 2100

**TOURMALINE** (S McKay) – Hampered start losing ground.

**RED MY MIND** (M Cameron) – Began awkwardly and crowded shortly after the start. A post-race veterinary examination could find no obvious abnormalities.

**DOUGIE** (D Johnson) - Over-raced in the early stages becoming awkwardly placed on heels and shifted out passing the 1700 metres.

**NARVICK** (D Prastiyou) – Over-raced in the early stages becoming awkwardly placed near the 1600 metres having to be firmly restrained for a distance.

**CONTESSA BELLA** (M Du Plessis) – Got its head up when being steadied off heels and raced ungenerously for a distance. Raced wide without cover from near the 900 metres.

BELLE TESTA (S Collett) - Held up until near the 300 metres having to shift out to obtain clear running.

Race 6 RODEBANK 1600

**HEADLINES** (D Prastiyou) – Slow to begin.

MASKOBI PEARL (H Marzuki) – Raced wide without cover throughout. Inconvenienced 400 metres.

GO FOR DOUGH (T Thornton) – Briefly held up early in the final straight. Lost the off fore plate during the running.

DARCI DENIRO (J Waddell) – Lost the near fore plate during the running.

**ENGLISH ROSE** (C Lammas) – Shifted out to obtain clear running forcing MASKOBI PEARL wider on the track near the 400 metres.

D Prastiyou HEADLINES - Was issued with a warning for his whip use prior to the 100 metres.

Race 7 NZB INSURANCE PEARL SERIES RACE

**ORPHEA** (L Innes) – Slow away. A request for a ruling was filed with the Judicial Committee who determined that ORPHEA be declared a non-runner under the provisions of Rule 632(1) after the barrier was slow to open.

SOUND WORKS (J Bayliss) - Crowded and hampered leaving the barriers, losing ground.

**RASPBERRY SWEET** (S Collett) - Crowded and hampered leaving the barriers, losing ground.

**TATTYBOGLER** (J Fawcett) - Crowded and hampered leaving the barriers, losing ground.

**ELUSIVE METEOR** (T Thornton) – Began awkwardly losing ground. Had to be firmly restrained when improving onto heels passing the 700 metres.

**SAIGNON** (R Elliot) - Began awkwardly losing ground. Steadied concluding stages when in restricted room to the outside of CONJURING (J Nason) which shifted out under pressure. J Nason was advised to exercise care.

**INDECISION** (D Johnson) – Slow away. Was unable to obtain clear running in the final straight.

SHOW BIRD (L Satherley) - Hung outwards through the early and middle stages.

**INFINITE JOY** (H Marzuki) – Raced wide throughout.

**MAJIC RULER** (M Du Plessis) - Returned to the enclosure with blood present in the nasal area and after undergoing an endoscopic examination was found to be from lesions in the nasal area.

**INFINITE JOY** (H Marzuki) – Raced wide throughout.

Race 8 WEST BROOK WINES 1600

ASCOMANNI (T Wenn) – Slow to begin.

CRITICS CHOICE (C Dell) - Slow to begin.

**ASTON PARK** (M Du Plessis) - Over-raced in the early stages and raced wide from near the 800 metres after having to shift out to avoid heels.

**ARCHDUCHESS** (D Johnson) - Held up early in the final straight then had difficulty obtaining clear running until near the 150 metres.

WIDE AWAKE (O Bosson) – Held up until shifting out passing the 300 metres.

**STEPHEN BOND** (R Elliot) - Held up early in the final straight.

**WINMOTION** (T Thornton) - Inconvenienced passing the 150 metres when laying out onto the heels of WIDE AWAKE which shifted in slightly.
