#### **RACE COMMENTS:**

Race 1	TEAM WEALLEANS 1000		
Nothing to report.			
Race 2	TECHO LTD 2100		

MAGIC CHAI (S Collett) - Slow to begin.

**CHACHI ARCOLA** (L Satherley) - Raced in restricted room passing the 1700 metres to the inside of NO NEED which shifted in when being restrained. Held up rounding the final turn.

**NO NEED** (H Marzuki) – Made contact with the running rail on a number of occasions when racing in the early to middle stages. Raced in restricted room passing the 900 metres to the inside of UNVEILING which had improved to the inside of ST SATURNIN when racing keenly with ST SATURNIN steadying and shifting in slightly. As a result NO NEED then made contact with the running rail and went off stride. Rider T Thornton was advised to exercise care when in similar circumstances.

A Sims (ARITE GURU) - Admitted a breech that she used the whip excessively when riding ARITE GURU.

# Race 3 BELL NEUHAUSER & (MATTHEWS) OPTOMETRISTS 1600

**EL COOLIO** (L Satherley) – Slow to begin.

RODOLFO (R Elliot) - Began awkwardly losing ground.

**NEW LAWS** (J Parkes) - Began awkwardly making contact.

THE BOY WONDER (J Bayliss) - Hampered start. Could not obtain clear racing room until approaching the 250 metres.

**S McKay** (THE MITIGATOR) - Defended a charge in that he weighed in one kilogram above the weight in which he weighed out. After hearing submissions the Judicial Committee found the charge proven and fined S McKay \$500.

#### Race 4 L3 AIRLINE ACADEMY 1400

**RIPLEY** (T Harris) - Crowded leaving the barrier.

**EMBEYA** (J Bayliss) – Began awkwardly losing ground.

**BROTHER** (B Morgenrood) – Shortly after leaving the barrier was crowded having to steady. Crowded approaching the 200 metres and hampered between WRINKLE (T Thornton) which shifted in and away from PENZERO (D Johnson) and DANCINGINTHESTORM (L Satherley) which lay out under pressure. Jockeys T Thornton, D Johnson and L Satherley were all advised to exercise care in a similar circumstance.

MATUZALEM (J Parkes) - Raced wide without cover.

**O'HARA** (M Coleman) – Ducked out over the concluding stages making contact with SIMPLY OPTIMISTIC which became unbalanced.

**SIMPLY OPTIMISTIC** (G Cooksley) - Inconvenienced passing the 400 metres by O'HARA which shifted out to obtain clear running. As a result SIMPLY OPTIMISTIC shifted out slightly inconveniencing MATUZALEM. Crowded and unbalanced over the concluding stages.

RISING ROSE (H Marzuki) - Made contact with the running rail passing the 450 metres becoming unbalanced.

#### Race 5 MUNNS WINNERS STYLE FOR RACEDAY 1400

**SEA HOME** (C Dell) - Crowded start losing ground.

**ARMAGUARD** (J Fawcett) - Crowded shortly after the start having to be steadied. Had to steady when improving onto heels passing the 100 metres before shifting out to obtain clear running.

LADY ROSEANNE (R Elliot) - Raced wide without cover throughout.

**ONE PRIZE ONE GOAL** (T Harris) – Raced keenly through the middle stages crowding BLACK LACE after becoming awkwardly placed inside the heels of LADY ROSEANNE passing the 800 metres.

BLACK LACE (T Wenn) - Crowded 800 metres.

**PIECE OF KATE** (J Nason) – Improved onto the heels of ONE PRIZE ONE GOAL over the concluding stages having to be steadied.

**SAVASAVA** (S McKay) – Had difficulty obtaining clear running in the final straight.

#### Race 6 LEGACY LODGE SPRINT

**FERRANDO** (J Parkes) - Knuckled leaving the barrier.

**SEIZE THE MOMENT** (J Bayliss) - Crowded leaving the barriers.

CHAMBORD (C Lammas) - Slow to begin. Raced keenly when being restrained in the early stages.

**UNTAMED DIAMOND** (T Thornton) - Held up early in the final straight.

**RUUD NOT TOO** (D Johnson) – When question regarding the performance rider advised that after settling back from a wide draw the mare had been unable to recover.

**S McKay** (SPEECH CRAFT) - Admitted a breech that he used the whip excessively with the Judicial Committee suspending his licence to ride in races from the conclusion of racing on 18 November, up to and including racing on 26 November, 6 national riding days.

J Parkes (FERRANDO) – Issued with a warning for using his whip in an excessive manner prior to the 100 metres.

## Race 7 DISTINCTION HAMILTON HOTEL 1200

**NOTHINGLEFTTOLOSE** (S Collet) - Began awkwardly.

**THATSFORSURE** (H Marzuki) – Crowded leaving the barriers losing ground.

ENDEAN EXPRESS (C Lammas) - Began awkwardly.

**ICHIBAN** (R Elliot) – Shifted in approaching the 1000 metres placing RICKY BAKER and I PACO in restricted room. ICHIBAN then commenced to race ungenerously further crowding RICKY BAKER onto I PACO which was hampered for a distance losing ground. Raced in restricted room passing the 800 metres when becoming awkwardly placed inside the heels of ELUSIVE TREASURE which had made the bend awkwardly. ICHIBAN was then badly checked when crowded by RICKY BAKER which shifted out when commencing to over-race.

**ELUSIVE TREASURE** (T Thornton) – Made the bend awkwardly passing the 850 metres when awkwardly placed inside the heels of MAGIC OF THE SUN.

**RICKY BAKER** (J Fawcett) - Crowded for a distance 1000 metres. Commenced to over-race passing the 800 metres shifting out off heels.

**I PACO** (L Satherley) – Crowded for a distance 1000 metres then hampered losing ground. Raced in restricted room for a distance passing the 250 metres.

BELLA GIOIA (D Johnson) - Held up approaching the 300 metres.

**THATSFORSURE** (H Marzuki) - Attempted to improve to the inside of NOTHINGLEFTTOLOSE passing the 150 metres when there was not sufficient room to do so with THATSFORSURE then becoming unbalanced. Jockey **H Marzuki** was issued with a warning.

## Race 8 BCD GROUP 1400

**V Colgan** – Fined \$100 under the minor infringement schedule after he failed to make the contracted weight for THE KIPLING GIRL and was replaced by L Satherley.

**AOTEAROWER** (G Cooksley) - Slow to begin (5L). Trainer K Kelso was advised that a warning would be placed on the horse's barrier manners. Had difficulty in obtaining clear running inside the 150 metres.

L'ESCALIER ROSE (A Jones) - Raced without cover throughout.

**PRINCESS DAVONE** (C Lammas) – Held up until passing the 200 metres.

SARABANDE (J Fawcett) - Raced in restricted room over the concluding stages having to be steadied.

**TOMMYRA** (H Marzuki) – Shifted out to obtain clear running passing the 400 metres making firm contact with LEGRAMOR which became unbalanced.

**LEGRAMOR** (J Parkes) – Bumped and unbalanced passing the 400 metres by TOMMYRA (H Marzuki) which shifted out to obtain clear running. Apprentice Jockey **H Marzuki** was issued with a warning.

THE KIPLING GIRL (L Satherley) - Held up for the majority of the final straight.
