Race 2 - Thank You Fiona Stuart Three-Year-Old Maiden

**FERRARI** - Co-trainer K Moore advised was found to have slight shin soreness following its run at Motukarara but has recovered well and will carry on with its current preparation. Mr Moore added that the filly will be ridden in a more conservative manner in upcoming starts should circumstances permit.

#### RACE COMMENTS:

# Race 1 CHRISTCHURCH CASINO PREMIER (2000m)

**STANDREWS MASONIC** (T Newman) - Slow to begin, held up near the 200 metres and had to steady and shift outwards across heels to obtain clear running near the 100 metres.

**WHO DARES WINS** (S Wynne) - Got its head up on a number of occasions in the early stages when being restrained, held up for a distance passing the 500 metres.

FLAG THE GROOM (O Bosson) - Raced keenly in the early stages, lay inwards under pressure in the final 200 metres.

**EVA JENSINE** (R Myers) - Raced keenly in the early stages, held up having to be steadied off heels near the 100 metres and shifted ground outwards to obtain clear running.

**CALL ME ROYAL** (M Cameron) - Lay outwards under pressure passing the 400 metres, when questioned regarding performance the rider was unable to offer any excuses other than the horse possibly being better suited by some easing of the ground. A post race veterinary inspection did not reveal any obvious abnormality.

**BRAD THORN** (T Moseley) - When questioned regarding performance rider advised that the gelding had been caught flat footed when the pace increased near the 600 metres and had been unable to recover. A post race veterinary inspection did not reveal any obvious abnormality.

**S Wynne** (WHO DARES WINS) - Admitted a charge of excessive use of the whip prior to the 100 metres with the Judicial Committee imposing a fine of \$500.

#### Race 2 NZ BLOODSTOCK INSURANCE PREMIER (1600m)

**SHOOT TO KILL** (A Collett) - Late scratched behind the barriers at 12.40 pm on veterinary advice as it was showing signs of lameness. A post race veterinary inspection revealed severe lameness in the left foreleg. Trainer T Rae was advised that a veterinary certificate of fitness is required prior to racing next.

LOCHAN ORA (C Campbell) - Slow to begin.

**SHADOW KING** (R Myers) - Knuckled leaving the barriers, got its head up in the early stages when being restrained, shifted outwards across heels near the 200 metres to obtain clear running.

**SAVANNAH GEM** (R Yatim) - Lay inwards and raced wide throughout becoming awkwardly placed on heels near the 900 metres and had to be straightened.

**TAXIHOME** (K Williams) - Raced keenly in the early stages.

**IRISH CALL** (S Wynne) - Was dismounted after the race and led back into the enclosure with the rider advising that the gelding had felt indifferent in its action. A post race veterinary inspection found the gelding to be suffering from lower back pain.

**LINDIS PASS** (L Hemi) - Awkwardly placed on heels near the 400 metres then being held up until passing the 200 metres.

## Race 3 MURITAI GROUP PREMIER (1400m)

SAVVY COUP (C Johnson) - Began awkwardly, raced keenly in the early stages getting its head up.

**EPEE** (K Williams) - Blundered leaving the barriers unbalancing its rider, raced fiercely in the early stages.

**AKOYA PEARL** (S Wynne) - Hampered at the start then contacted a heel shortly thereafter and restrained to the rear, steadied off heels at the 600 metres.

**ALL ABOUT ROY** (D Bothamley) - Blundered badly leaving the barriers, a post race veterinary inspection did not reveal any obvious abnormality.

**TATUM** (M Cameron) - Blundered on jumping.

**PRAWN STAR** (R Myers) - Knuckled shortly after the start, inclined to lay inwards under pressure in the final straight hampering OUR NINA passing the 200 metres, when questioned regarding performance rider was unable to offer any excuses and advised that the gelding had been disappointing.

LADY DAVONE (A Collett) - Raced three wide without cover.

MAMMA SANS (M Du Plessis) - Got its head up when over racing near the 1000 metres.

**HANNAH MARENE** (J Lowry) - Held up near the 300 metres and continued to have difficulty obtaining clear running until near the 50 metres.

RAVENHILL (J Riddell) - Held up from the 250 metres until near the 150 metres.

**OUR NINA** (K Mudhoo) - Hampered passing the 200 metres.

#### Race 4 ANDIE MCNEILL BIRTHDAY PREMIER (1100m)

MARGARITA MOVER (A Collett) - Began awkwardly.

MR CONDUCTOR (M Cameron) - Over raced in the early and middle stages when racing wide.

**BARABAS** (J Waddell) - Held up in the early stages of the final straight having to shift ground outwards to obtain clear running near the 250 metres.

**STARVOIA** (C Johnson) - Held up in the early stages of the run home until shifting outwards across heels to obtain clear running near the 200 metres.

NAKYAMA (T Jonker) - Ducked outwards away from the running rail near the 250 metres unbalancing its rider.

# Race 5 YESBERG INSURANCE SERVICES PEGASUS STAKES HANDICAP (1000m)

EL BEE DARCI (A Collett) - Began awkwardly.

**DON CARLO** (K Williams) - Raced wide throughout, inclined to shift ground under pressure in the final straight.

**SIGNIFY** (R Cuneen) - Checked to avoid the heels of DON CARLO near the 600 metres.

**MR TYPHON** (S Wynne) - Held up in the early stages of the run home having to shift wider in the final straight to obtain clear running passing the 250 metres.

**KINAGAT** (M Cameron) - Held up early in the final straight then being inclined to lay in under pressure, co-trainer Michael Pitman applied and was granted permission to add a cheek burr to the gelding's notified gear for its engagement at Wednesday's racemeeting.

**ENZO'S LAD** (C Johnson) - Held up until near the 300 metres.

MORSE CODE (L Hemi) - Rider dropped her whip approaching the 200 metres.

Following the race a protest was lodged by the connections of the 3<sup>rd</sup> placed SIGNIFY alleging interference by the 2<sup>nd</sup> placed DON CARLO near the 600 metres. After viewing films and hearing submissions the Judicial Committee dismissed the protest.

## Race 6 M SOCIAL AUCKLAND PREMIER (1400m)

**ZAWHIP** (O Bosson) - Lost its footing and blundered badly at the start. Following the race O Bosson was attended to by St John Paramedics after suffering a thumb injury leaving the barriers.

GLORY DAYS (R Myers) - Slow to begin.

MIRA (BB Hong) - Began awkwardly.

**KING KANE** (M Cameron) - Briefly held up entering the final straight.

**BB Hong** - Issued with a warning after shifting inwards on his mount MIRA passing the 200 metres when not fully clear of ELFEE which had to be steadied.

**ELFEE** (S Wynne) - Steadied passing the 200 metres when crowded.

**S MacNab** (BISOU BISOU) - Fined \$300 after admitting a charge of excessive use of the whip prior to the 100 metres.

**T Moseley** (ADMIRAL ROUS) - Fined \$300 after admitting a charge of excessive use of the whip prior to the 100 metres.

**PINSRAAD** (R Jones) - When questioned regarding performance rider advised that the mare would be better suited to more cut in the ground.

#### Race 7 AL BASTI EQUIWORLD 45<sup>TH</sup> NZ 2000 GUINEAS (1600m)

**IRISH FLAME** (A Collett) - Began awkwardly then further hampered when crowded between runners, raced wide throughout, forced over extra ground rounding the final bend.

**SENSEI** (C Johnson) - Began awkwardly, over raced in the middle stages, forced over extra ground rounding the final bend.

**BOSTONIAN** (L Innes) - Lost its footing and blundered leaving the barriers, severely checked passing the 1400 metres, inconvenienced when placed in restricted room between TE AKAU SHARK and AGE OF FIRE which both shifted ground near the 300 metres.

**EMBELLISH** (O Bosson) - Lost its footing leaving the barriers, severely checked passing the 1400 metres.

**UPPERHAND** (D Bradley) - Raced fiercely when being restrained shortly after leaving the barriers and continued to race ungenerously throughout with the rider advising that the gelding had proved very difficult to control. A racing manners warning was placed against the gelding with trainer B Court advising it was now his intention to spell UPPERHAND.

**FINBARR** (J Lowry) - Steadied when placed in restricted room near the 1500 metres.

**SCOTT BASE** (M Du Plessis) - Checked passing the 1450 metres losing ground, hampered passing the 1400 metres, forced over extra ground rounding the final bend.

O Bosson - Admitted a charge of careless riding in that he permitted his mount EMBELLISH to shift inwards when not sufficiently clear of BOSTONIAN which was forced inwards into the line of SCOTT BASE which was checked near the 1450 metres. After viewing films and hearing submissions the Judicial Committee suspended O Bosson's licence to ride at race meetings from the conclusion of racing on Saturday 18 November until the conclusion of racing on Saturday 2 December, 10 National days.

STAR TREASURE (R Myers) - Hampered and dictated inwards passing the 1400 metres.

AGE OF FIRE (M Cameron) - Over raced in the middle stages.

J Waddell - Admitted a charge of careless riding in that he permitted his mount EVER LOYAL to shift inwards when not sufficiently clear of STAR TREASURE which was forced inwards causing severe crowding to EMBELLISH, BOSTONIAN and LINCOLN HILLS passing the 1400 metres. Also hampered as a result was SCOTT BASE. After viewing films and hearing submissions the Judicial Committee suspended J Waddell's licence to ride at race meetings from the conclusion of racing on Saturday 18 November until the conclusion of racing on Friday 8 December, 14 National days.

LINCOLN HILLS (J Riddell) - Severely checked passing the 1400 metres, over raced badly in the middle stages.

Following this race rider O Bosson advised that his thumb injury had worsened and after again being attended to by St John Paramedics was stood down from his remaining engagements with a medical clearance now required prior to riding next.

## Race 8 GOLD CLUB PREMIER (1200m)

MASABIO - J Lowry replaced O Bosson (injured).

**NOWHERE MAN** (K Gundowry) - Began awkwardly, held up in the final straight until shifting outwards across heels to obtain clear running near the 150 metres.

BRUEGEL (R Firdhaus) - Blundered at the start, briefly held up early in the final straight.

**PIPPI REA** (C Johnson) - Crowded on jumping, held up behind weakening runner until near the 200 metres, when questioned regarding performance rider could offer no tangible excuse however did add that the gelding would derive natural benefit from today's fresh up run.

**HEE'S OUR SECRET** (M McNab) - Crowded shortly after the start, raced wide throughout, badly held up in the final straight until near the 150 metres.

**DAIFUKU** (K Williams) - Raced wide throughout.

**STROWAN** (R Cuneen) - Raced ungenerously when being restrained to avoid heels near the 1000 metres continuing to do so through the middle stages, held up in the early stages of the run home then hampered when becoming awkwardly placed on the heels of FLYTIME which shifted out under pressure near the 300 metres.

SARONIC MISS (A Morgan) - Had difficulty obtaining clear running in the final straight.

## Race 9 REDWOOD METROPOLITAN TROPHY HANDICAP (2500m)

**BEE TEE JUNIOR** (J Waddell) - Raced keenly for a distance passing the 1800 metres.

GRAZIA (M McNab) - Briefly held up passing the 400 metres.

**SACRED EMPIRE** (M Du Plessis) - When questioned regarding performance rider could offer no excuse for the disappointing performance.

## Race 10 BLUE STAR TAXIS PREMIER (1600m)

**RUBY ROW** - R Cuneen replaced O Bosson (injured). Hampered 800 metres.

**TOETWOTOE** (A Collett) - Slow to begin, ducked outwards abruptly hampering RUBY ROW by the 800 metres after being placed in restricted room to the inside of SCOOBY which was taken in slightly by GOLDEN BAY (D Hirini). **D Hirini** was issued with a warning.

SCOOBY (J Lowry) - Slow to begin.

**SO BRAZEN** (A Morgan) - Hampered shortly after the start and got back.

FIRE LILY (K Williams) - Began awkwardly, raced wide in the early stages, lay out throughout the final straight.

CHIC (S MacNab) - Raced keenly in the early stages getting its head up, crowded passing the 200 metres.

O'KIWI (S Wynne) - Raced keenly when in restricted room passing the 1400 metres.

**VENCEDORA** (T Moseley) - Raced wide in the early and middle stages.

**FINAL SAY** (Du Plessis) - Raced wide for the majority of the race, unbalanced when received contact to hindquarters passing 200 metres.

**A Morgan** - Issued with a warning after permitting her mount SO BRAZEN to shift outwards crowding GOLDEN BAY onto CHIC which made contact with the hind quarters of FINAL SAY passing the 200 metres.

**GOLDEN BAY** (D Hirini) - Crowded passing 200 metres.

**DUPLICITY** (J Waddell) - When questioned regarding performance rider reported that the gelding had raced wide but with cover and when placed under pressure had failed to respond being disappointing.
