**Race 7 AL BASTI EQUIWORLD 45 TH NZ 2000 GUINEAS (1600m)**

**BOSTONIAN** (L Innes) – Trainer T Pike advised Stewards that he was satisfied with the recovery of the gelding adding that he has now been sent for a spell.

**RACE COMMENTS:**

**Race 1 BAY OF ISLANDS ITM**

**BRIGHTLIGN** (J Nason) - Began awkwardly losing ground and then commenced to race ungenerously when being restrained shifting out to avoid heels passing the 1700 metres. When questioned as to why the horse had been ridden back on this occasion, rider J Nason advised that as it was the gelding's first start over ground, they intended to ride the gelding back to try and get it to settle as it was also wearing blinkers for the first time. Trainer advised that it was his intention to spell the gelding prior to racing again.

**SMILING ASSASSIN** (R Elliot) - Steadied approaching the 1200 metres when awkwardly placed.

**GOOOSUNSHINE** (S Collett) – Became awkwardly placed when laying out across heels approaching the 200 metres.

**Race 2 FELL ENGINEERING**

**ALBERTON STARFISH** (A Schwerin) – Began awkwardly losing ground. Was denied clear racing room passing the 350 metres then becoming awkwardly placed on the heels of the tiring WHO'S QUEEN and steadied for a distance.

**ENDOWMENT** (A Collett) – Began awkwardly losing ground. Commenced to race ungenerously in the early stages when being restrained making the bend awkwardly near the 900 metres and continued to do so through the middle stages.

**O'ANGEL** (S Spratt) – Raced wide for the majority of the race.

**SHEZAROCKSTAR** (S Collett) – Raced wide for the majority of the race.

**Race 3 CROFT POLES**

**RUNNING BEAR** Late scratched Veterinary advice at 12.30pm.

**SLICE 'N DICE** (S Weatherley) – Slow to load with trainer D Logan being advised that a warning would be placed against the filly's barrier manners. Slow to begin. Commenced to race ungenerously in the early stages laying in when making the bend near the 900 metres briefly crowding ANAHERA LASS. Had to be firmly restrained going off stride when becoming awkwardly placed on heels passing the 450 metres then had difficulty obtaining clear running until passing the 300 metres.

**ANAHERA LASS** (S Spratt) – Crowded shortly after leaving the barrier and then steadied. Briefly crowded 900 metres.

**ONE BAKERSTEET** (M du Plessis) - Commenced to hang out shortly after leaving the barrier and continued to for the remainder of the race.

**NOODLES** (J Nason) - Commenced to race ungenerously when being steadied approaching the 800 metres making the bend awkwardly.

**Race 4 WHANGAREI ITM**

**RUNNING SMOOTH** Underwent a pre-race veterinary inspection and was cleared to start.

**PISTOL PETE** (D Prastiyou) - Began awkwardly and then was hampered shortly after losing ground.

**LAKE SUPERIOR** (M du Plessis) - Crowded shortly after leaving the barrier losing ground. Had to be firmly restrained off heels passing the 1300 metres.

**OUR KATY CRUZ** (A Collett) - Began awkwardly losing ground.

**SINGLE MOMENT** (S Weatherley) - Steadied when crowded passing the 1300 metres to the inside of BET SHE IS which was taken in slightly by EUROSTAR (A Jones) which shifted in when not fully clear. A Jones was issued with a warning.

**ROSA STELLA** (T Thornton) – Was dictated wider by BET SHE IS which made the bend awkwardly. Hampered losing ground near the 300 metres.

**BET SHE IS** (S Collett) – Made the 800 metre bend awkwardly. Forced wider 300 metres

**OUR KATY CRUZ** (A Collett) - Hampered losing ground near the 300 metres.

**G Cooksley** admitted a breach in that he allowed HEREMON to shift out when not clear of BET SHE IS forcing that runner out into the line of OUR KATY CRUZ and ROSA STELLA which were both badly hampered losing ground . After viewing films and hearing submissions the Judicial Committee suspended G Cooksley’s licence to ride at race meetings from the conclusion of racing on Sunday 19 November until the conclusion of racing on Wednesday 29 November, 6 National days.

**EUROSTAR** (A Jones) Raced disappointingly. Rider was unable to offer any reason for the gelding’s performance. A post-race veterinary examination revealed no abnormalities.

**S Cameron** (BACHATA) was fined \$50 under the minor infringement schedule after presenting BARCHATA to race in gear that had not been notified (pacifiers).

**STREET SMART** (L Innes) underwent a pre-race veterinary inspection and was cleared to start. Held up early in the final straight and then had difficulty obtaining clear running for a distance passing the 250 metres.

**TOBI** (C Dell) – Crowded shortly after jumping away and steadied. Unable to obtain clear running in the final straight.

**REBEL ROSE** (A Jones) – Crowded shortly after jumping away and steadied.

**BACHATA** (J Nason) - Commenced to over race when being restrained passing the 1000 metres for a distance.

**WAWRINKA** (R Elliot) - Raced wide without cover for the majority of the race.

**HELLO IT’S ME** (C Lammas) - Held up early in the final straight before shifting in to obtain clear running passing the 300 metres.

**LUPELANI** (S Collett) – Unable to find clear running for the majority of the final straight.

**CAMEAHOTFRIDAY** (A Schwerin) – Got its head up when being firmly restrained when attempting a marginal run to the inside of BREEZON which shifted in slightly under pressure passing the 300 metres and was then further hampered when WAWRINKA shifted out and away from WARSET which had become awkwardly placed on the heels of SAIGNON.

**WARSET** (A Collett) - Slow to begin. Held up till passing the 200 metres.

**A Collett** admitted a breach of Rule 638(3)(b)(ii) in that she used her whip excessively prior to the 100 metres and was fined a sum of \$500.

Trainer **S Cameron** was reprimanded for removing the blinkers prior to leaving the birdcage.

**AMUN RA** (J Nason) - Crowded leaving the barrier losing ground.

**TE WAEWAE BAY** (R Elliot) - Crowded leaving the barrier losing ground.

**CREATIVE GENIUS** (A Collett) - Slow to begin. Raced wide without cover throughout. Had difficulty obtaining clear running until inside the final 100 metres.

**SPIDER** (T Thornton) - Had difficulty obtaining clear running until inside the final 100 metres.

**TOORAK TOWER** (S Collett) - Lay out passing the 200 metres making contact with GREENCAST.

**DIG IT UP** (L Innes) - Refused to leave the barrier and took no effective part in the race. Trainer S McKee was advised the gelding would be required to barrier trial to the satisfaction of the Stewards prior to racing.

**KOLAMAN** (A Jones) - Knuckled when pulling up dislodging rider A Jones and was excused from weighing in. After been attended to by the Paramedics, A Jones was found to be un-injured.

**GREEN SPIRIT** (C Lammas) – Slow away. Inconvenienced passing the 150 metres when becoming awkwardly placed on the heels of ST REGIS which shifted out and away from AIR CENTRE inconveniencing BIGSIE.

**AIR CENTRE** (D Prastiyou) - Over raced through the middle stages making the bend awkwardly near the 800 metres.

**ST REGIS** (R Elliot) - Made the 800 bend awkwardly.

**RIKKI TIKKI TAVI** (S Collett) - Raced wide without cover throughout.
