RACE COMMENTS:

Race 1	C & C AUTOS 1100M
Trainers P Pascoe and J Millar were given a warning under Rule 802 1 (a) in that they saddled their respective runners outside the designated area.	
ACQUILO (M McNab) – Reared as the start was made with the gelding's head making contact with the top of the starting gates losing significant ground. Raced greenly throughout and when being angled outwards for a run near the 300 metres over reacted and bumped with RUBY LOVE for a short distance. M McNab was advised to exercise care when shifting ground. Not persevered with over the final stages when out of contention.	

A subsequent veterinary inspection revealed a superficial laceration to the forehead consistent with making contact with the starting gates.

KATIES SO KOOL (R Myers) – Awkwardly away. Raced ungenerously in the early stages making the bend passing the 800 metres awkwardly.

LADY HASS (J Bayliss) – Was not persevered with in the home straight. J Bayliss advised the mare had not travelled comfortably throughout. A subsequent veterinary examination revealed a slow recovery rate.

Race 2	ECOLAB MAIDEN 1100M

SIDART (D Turner) – Began awkwardly shifted in contacting NGARIKI FLYER.

PIRIWAI (J Nason) – Raced keenly in the early stages. Held up for a distance approaching the 400 metres.

POWNCE (S Collett) – Raced keenly in the early and middle stages. Held up for a distance approaching the 400 metres. In restricted room near the finish.

NGARIKI FLYER (A Shin) – Bumped at start. Held up for a distance approaching the 400 metres.

ZENVO (S Weatherley) – Held up for a distance approaching the 400 metres. Lugged inwards in the home straight and had to be straightened.

JOY RIDE (M Tanaka) – Lay out early in the home straight contacting LADY KARTEL. M Tanaka reported the mare raced greenly throughout when wide without cover.

SUGAR RUSH (L Hemi) – Denied a run near the 300 metres so had to angle outwards to improve.

WON'T BACK DOWN – Raced greenly in the home straight.

LADY KARTEL (R Myers) – Bumped in the home straight.

Race 3	LA NUOVA APPARELMASTER 1200M

ROSE IMPERIAL (J Bayliss) – Held up approaching the 200 metres, ran out under pressure bumping with LA BELLA ROSA passing the 50 metres.

LADY PINOT (M McNab) – Was not persevered with over the final stages when out of contention. Rider could offer no excuse.

Race 4	NULOOK ALUMINIUM MAIDEN 1400

TAIMANU (J Riddell) – Raced three wide without cover throughout finishing well back. When questioned, J Riddell advised the gelding had raced greenly throughout. A subsequent veterinary inspection revealed no obvious abnormality

HERENGAWA (T Johnson) – Jumped inwards abruptly at the start heavily contacting LARIMA. Raced keenly in the early stages having to be restrained off heels when in restricted room approaching the 1200 metres.

KINGS VEE (J Parkes) – Lay in abruptly approaching the 200 metres briefly inconveniencing LARIMA.

LARIMA (M Tanaka) – Heavily contacted start, briefly inconvenienced approaching the 200 metres.

Race 5	GIRLS GO RACING MAIDEN 1400

POURALITA (R Myers) – Blundered at the start losing ground.

LOUANNE (M McNelis) – Awkwardly away.

CHOUX PLAY (L Hemi) – Began awkwardly bumping SACRED PARTY.

SACRED PARTY (J Bayliss) – Bumped at the start. Ran up on to heels near the 700 metres and had to be restrained. Had to change ground inwards early in the home straight to gain clear running, then raced in restricted room approaching the 100 metres.

TUFF GIRL (R Elliott) – Ran up on to heels having to be restrained passing the 1000 metres, then raced three wide without cover.

SUPAGILI (J Riddell) – Disappointed. When questioned, J Riddell stated the gelding raced keenly in the early stages but could offer no tangible excuse. A subsequent veterinary examination revealed no obvious abnormality.

Race 6	THE WATERFRONT HOTEL 1400M

MYLADY ACHIEVER (D Bradley) – Raced keenly in the early and middle stages.

SWISS ELLE (M McNelis) – Began awkwardly contacting ICHIBAN who settled back. Raced three wide without cover throughout and was not persevered with in the home straight when out of contention. M McNelis considered something amiss with the mare. A subsequent veterinary examination revealed no obvious abnormality.

ICHIBAN (R Elliot) – Contacted at the start settling back. Had to be checked off heels approaching the 400 metres and was inconvenienced again passing the 350 metres.

BACHATA (J Parkes) – Held up for some distance rounding the turn.

Race 7	ANTON MORA & SON PAINTERS MAIDEN 1800M

ROUGH CONDUCT (A Jones) – Raced three wide without cover throughout.

SILK (M McNab) – Jumped inwards abruptly at the start bumping COTTONEVA.

COTTONEVA (T Johnson) - Bumped at the start. Tightened near 1700 metres and when being corrected shifted out dictating SILK and JAZAMORE over extra ground.

NORTHERN DELIGHT (D Turner) – Began awkwardly settling back.

BLOOMSBURY (S Weatherley) – Tightened passing the 1700 metres when JAZAMORE (R Myers) shifted in dictating SILK inwards on to COTTONEVA which tightened BLOOMSBURY. Rider R Myers was advised to exercise care when shifting ground. Commenced to give ground rapidly approaching the home turn and finished some distance last. S Weatherley was of the opinion the mare failed to see out the distance. Underwent a veterinary examination which revealed a cough. Connections advised that BLOOMSBURY would undergo an endoscopic examination with results forwarded to the Stewards prior to its next start

SMILING ASSASSIN (R Elliot) – Held up passing the 300 metres having to be angled outwards early in the home straight to gain clear running.

CASHEL (M McNelis) – Had to take evasive action to avoid the rapidly tiring BLOOMSBURY approaching the home turn.

Race 8	REVITAL FERTIISERS 1800M
<p>BATTLE KAT (R Myers) – Was incorrectly listed in some publications as wearing visor blinkers which was incorrect.</p> <p>ROSSO CORSO (J Riddell) – Slow away.</p> <p>ALARMIST (S Weatherley) – Tightened at the start and got back.</p> <p>BEAU JEU (D Hirini) – Shifted out on jumping away bumping with BLUSHING MOSS and STELLACANTO.</p> <p>CAN YOU HEAR ME (J Nason) – Bumped at the start. Raced keenly in the early and middle stages.</p> <p>STELLACANTO (C O’Beirne) – Raced three wide on the pace without cover throughout. C O’Beirne was questioned into her ride and in particular her decision not to take a trail in the early part of the race, when the opportunity was available for her to do so. Miss O’Beirne advised that her riding instructions were to have the mare in a forward position but conceded she had erred in her judgment by not taking the available position in behind the leaders. Miss O’Beirne was advised that she is expected to exercise better judgment in future.</p> <p>LECTIO DIVINIA (A Shin) – Shifted in near the 250 metres hampering ROSSO CORSA. A Shin was shown footage of his ride and was reminded of his obligations when shifting ground.</p> <p>HUNGRY EYES (A Chan) – Had to be checked off the heels of the tiring STELLACANTO near the 250 metres.</p>
