## **RACE COMMENTS:**

Race 1	CMWO BREEDERS ASSN FIRST GIRL HOME MAIDEN (1200m)					
JIMINY CRICKET (S Wynne) – Began awkwardly and got back.						

HAND OF ACES (C Campbell) – Began awkwardly, raced greenly for a short distance passing the 500 metres.

**CHORISTER** (R Cuneen) – Restrained to the rear on jumping.

**ODALISQUE** (G Jogoo) – Raced keenly in the early stages, restrained and got its head up when eased off heels passing the 700 metres.

LANTAU ISLAND (K Mudhoo) – Made the bend near the 900 metres awkwardly and got its head up when being restrained when inside the heels of OPOURI (S Collett) which shifted in. Rider **S Collett** was issued with a warning under Rule 638(1)(d) for shifting ground when insufficiently clear.

CZECHOSLOVAKIA (A Morgan) – Raced wide throughout.

**SAMMI LOU** (R Elliot) – Steadied momentarily near the 150 metres when attempting a marginal run to the outside of LANTAU ISLAND.

Race 2 LAURIE HOWARD MEMORIAL & MCMILLAN EQUINE FEED MAIDEN (1200m)

**TACKTHEFLAG** (J Laking) – Slow to begin, inconvenienced momentarily when awkwardly placed on the heels of ANYTHINGCOULDHAPPN at the 250 metres.

**RUBYMOON** (S Collett) – Got its head up in the early stages when being restrained.

MIACOCA (K Williams) – Raced wide throughout.

**ANYTHINGCOULDHAPPN** (R Elliot) – Heavily restrained off heels passing the 800 metres.

DUTCH COURAGE (G Jogoo) – Shifted inwards passing the 150 metres.

**COUP DREAMWOOD** (M Tanaka) – Not afforded clear running over the concluding stages.

The track was upgraded to Dead (4) following this race.

Race 3 CANTERBURY LONG RUN ROOFING & ONCEUPONATIME HANDICAP (1200m)

**SUFFIRE** (J Morris) – Began awkwardly.

BARABAS (P Shaikh) - Began awkwardly, raced keenly in the early stages.

PIPPI REA (C Johnson) – Bumped and unbalanced passing the 200 metres.

**SACRED DESIRE** (R Elliot) – Denied a marginal run passing the 200 metres and held up for a short distance.

FLYTIME (K Mudhoo) – Bumped passing the 200 metres.

Race 4 J.BALLANTYNE & CO. & L.J. HOOKER GROUP DASH (1200m)

**GREENPARK GEM** (R Cuneen) – Began awkwardly and further hampered between runners losing ground, made contact with PINZANO near the 50 metres.

PINSHARP (A Morgan) – Over raced and had to be restrained passing the 1000 metres, raced wide throughout.

**BENEFICIAL** (K Kwo) – Commenced to over race passing the 1000 metres with the saddle shifting forward placing the rider at disadvantage for some distance.

STARMAKER (S Wynne) - Raced keenly for a distance passing the 1000 metres, lay outwards rounding the final bend.

**SARONIC MISS** – Rider C Johnson reported that the mare had been out paced in the early stages adding she had made ground late in the race. Unable to find clear racing room over concluding stages.

PINZANO (J Laking) – Wide early. Bumped near the 50 metres.

**MINERVA** (K Mudhoo) – Awkwardly placed on heels over the concluding stages and had to steady.

#### Race 5 NZB INSURANCE PEARL SERIES RACE (1600m)

KARAYAH (C Campbell) – Slow to begin and got its head up and lost ground when restrained.

PLACID PRINCESS (K Williams) – Slow to begin.

**RAVEN DARKHOLME** (S Wynne) – Made the bend awkwardly near the 1300 metres and got its head up on a number of occasions, lay in in the early stages of the home straight. Rider S Wynne reported that the filly may not have backed up from its previous race start. A post race veterinary inspection did not reveal any obvious abnormalities.

**LINDIS PASS** (T Jonker) – Raced wide throughout, rider unbalanced near the 50 metres when racing tight to the inside of PLACID PRINCESS. Rider T Jonker reported that the mare had lay out throughout.

**GLOSS** (C Johnson) – Steadied for a distance passing the 900 metres. When questioned regarding the improved performance, co-trainers M & M Pitman reported that the mare benefited from a step up in distance.

**SHARP ELLE** (R Firdhaus) – Got its head up when steadied after being awkwardly placed on heels passing 1200 metres.

## Race 6 DOMINATOR DOORS & CATERING SOUTH CANTERBURY MILE (1600m)

PATRICIA ROSE (L Callaway) – Slow to begin, made the bend awkwardly at the 1400 metres.

**PRODUCER** (BB Hong) – Slow to begin.

**RED RIVER ROCK** (R Cuneen) – Hampered between runners shortly after the start and got back.

**NAKURU** (J Laking) – Steadied shortly after the start, raced wide throughout, lay inwards in the early part of the home straight.

RUN FORREST RUN (K Williams) – Raced in tight quarters passing the 1500 metres.

COWBOYS DONT CRY (G Jogoo) - Raced in restricted room passing the 1500 metres and had to steady.

**LEULUAI** (T Jonker) – Shifted ground passing the 1500 metres with rider T Jonker reminded of her obligations.

PER FORM (S Wynne) – Steadied at the 1300 metres, awkwardly placed on heels near the 500 metres having to steady.

A Morgan (MACARIO) was reminded of her obligations regarding whip use prior to the 100 metres.

## Race 7 THE CRAIGMORE TIMARU CUP HANDICAP (1600m)

**SPIDER** (K Williams) – Raced wide in the early stages.Lay outwards rounding the turn.Lay outwards over the concluding stages.

**ASPEN LASS** (R Elliot) – Unable to obtain clear racing over the concluding stages going to the line without being fully tested by its rider.

**KOLONEL KEV** (M Tanaka) – Bumped with SON OF MAHER passing the 400 metres when attempting to shift outwards.

**SON OF MAHER** (C Johnson) – Raced keenly for a distance passing the 1200 metres.Jostled near the 400 metres on the point of the turn. Rider C Johnson spoken to for the manner he rode at this stage when attempting to hold his position. When questioned about the performance, C Johnson could offer no tangible excuse.

**J Lowry** (TOMMY TUCKER) admitted a breach of Rule 638(3)(b)(ii) for excessive use of the whip prior to the 100 metres with the Judicial Committee suspending his licence to ride at race meetings for 6 days effective 4 January to 11 January inclusive.

## Race 8 LASER ELECTRICAL, PORT FM & PLANTORAMA STAYERS (2100m)

**TRAVEL WISE** (S Wynne) – Steadied near the winning post on the first occasion. Raced keenly and wide from the 1600 metres.

**PRECIOUS PERCY** (K Kwo) –Held up and unable to obtain clear running throughout the home straight.

**NANCY** (T Jonker) – Inclined to lay inwards in the final straight and had to be straightened near the 100 metres.

VILLA ELBA (C Johnson) – When questioned about performance rider C Johnson could offer no tangible excuse.
