**SUPPLEMENTARY:****Wellington RC – Saturday 20 January 2018****Race 7 – J R & N Berkett Telegraph (Group 1)**

**J Waddell** - A charge of careless riding in that he angled his mount KAWI outwards when not sufficiently clear of ROCANTO which was checked near the 500 metres was found proven with the Judicial Committee imposing a suspension from the conclusion of racing on Wednesday 31<sup>st</sup> January 2018 until the conclusion of racing on Friday 16<sup>th</sup> February 2018, 11 national riding days.

**Wellington RC – Saturday 20 January 2018****Race 9 – Wallaceville Estate Castletown Wellington Cup (Group 3)**

**T Thornton** – Fined \$600 by the Judicial Committee after admitting a charge in that she used the whip excessively on her mount SAMPSON prior to the 100 metres.

**RACE COMMENTS:**

Race 1	LADIES DAY 10 <sup>TH</sup> FEBRUARY '18 (1200 METRES)
<p><b>LILLY THUNDER</b> (S McKay) - Commenced to lay out shortly after the start. Was crowded passing the 900 metres to the inside of HONESTY (C Johnson) which shifted in when not fully clear. Rider C Johnson was advised to exercise greater care in a similar circumstance. LILLY THUNDER then continued to hang out with the bit becoming displaced then ran wide rounding the bend and was not persevered with in the final straight. Trainer J Miller was advised that the filly would now be required to trial to the satisfaction of Stewards prior to racing next.</p>	
<p><b>BEAUDEN</b> (R Elliot) – Steadied passing the 350 metres when becoming awkwardly placed on the heels of MONACO which shifted out with BEAUDEN being held up for a short distance.</p>	
<p><b>KIRRAMISU</b> (S Collett) – Briefly bumped and unbalanced passing the 350 metres by SUPERA which shifted out to obtain clear running.</p>	
<p><b>SUPERA</b> (C Lammas) – Made brief contact when obtaining clear running near the 350 metres.</p>	
Race 2	GREENE BROTHERS (1200 METRES)
<p><b>GETALONGHOME CINDY</b> (A Schwerin) - Slow to begin after being fractious in the barrier.</p>	
<p><b>WINMOTION</b> (S Collett) - Slow to begin.</p>	
<p><b>T Wenn</b> (SABER) - Issued with a warning after allowing SABER to shift in passing the 1100 metres when not sufficiently clear of MEMORIES ONLY which was hampered.</p>	
<p><b>MEMORIES ONLY</b> (R Norvall) – Hampered approaching the 1100 metres. MEMORIES ONLY then commenced to over-race and was again crowded to the inside of FORTUNE PATCH which shifted in when insufficiently clear passing the 1000 metres. Apprentice Jockey T Yanagida was reprimanded by Stewards and advised he must be sufficiently clear when shifting ground. Raced wide without cover for the majority of the race. Briefly contacted by FORTUNE PATCH (T Yanagida) passing the 150 metres and then further dictated out by that runner over the final 75 metres. Apprentice Jockey T Yanagida was again reprimanded by Stewards and advised he must be sufficiently clear when shifting ground.</p>	
<p><b>FORTUNE PATCH</b> (T Yanagida) – Shifted out under pressure making contact 150 metres then continued to shift out.</p>	

<b>Race 3</b>	<b>FASTTRACK \$5K (1400 METRES)</b>
<p><b>BEAUTY'S ROSE</b> (T Yanagida) - Slow to begin. Lay out rounding the bend. Returned to the enclosure with blood present in the nasal area and after undergoing an endoscopic examination was found to have bled with BEAUTY'S ROSE now being stood down from racing for three months and training for two months with a veterinary certificate of fitness being required prior to either trialing or racing again.</p> <p><b>ELUSIVE METEOR</b> (T Thornton) - Began awkwardly.</p> <p><b>SCRUTINIZE</b> (O Bosson) – Shifted ground outwards approaching the 300 metres to obtain clear running.</p> <p><b>MISS HOROTIU</b> (M Coleman) - Inconvenienced passing the 200 metres when in restricted room.</p>	
<b>Race 4</b>	<b>STYLE COUNSEL (1600 METRES)</b>
<p><b>MING'S EMPEROR</b> (M Vance) - Crowded shortly after the start losing ground. When questioned regarding the improved performance co-trainer J. Douglas advised that the addition of blinkers today and a tongue tie had been beneficial.</p> <p><b>MADAM WOO</b> (M Du Plessis) - Crowded shortly after the start.</p> <p><b>ANICETA</b> (T Thornton) - Over-raced when being restrained in the early to middle stages and raced wide without cover. Raced in restricted room passing the 200 metres to the outside of JUSTAMAIZ which had shifted out and way from MADAM WOO.</p> <p><b>SAILING</b> (S Spratt) – Had to shift in after improving onto heels passing the 300 metres.</p> <p><b>VON ZIPP</b> (A Sims) – Became tailed off passing the 700 metres then collapsed when being pulled up by its rider. Was found to be deceased from natural causes after being attended by the veterinary surgeon who advised the horse had suffered a pulmonary haemorrhage. Apprentice Jockey A. Sims was uninjured.</p>	
<b>Race 5</b>	<b>THE EDGE 97.8 FM (1400 METRES)</b>
<p><b>GET SMART</b> (J Nason) - Raced three wide without cover throughout. Crowded passing the 300 metres to the inside of FLYING FEET (O Bosson) which commenced to lay in when placed under pressure. O Bosson was advised to exercise greater care.</p> <p><b>FLYING FEET</b> (O Bosson) – Slow to begin. Became awkwardly placed on heels when passing the 1000 metres. Commenced to lay in when placed under pressure in the final straight. Contacted approaching the 200 metres by HEAT SEEKER which shifted out when placed under pressure with FLYING FEET again making contact with HEAT SEEKER passing the 150 metres.</p> <p><b>BEL RAGAZZO</b> (S McKay) – Slow to begin then hampered shortly after having to be steadied.</p> <p><b>HOOF HEFNER</b> (M Hills) – Over-raced when being steadied off the heels of NOT USUAL PRINCE (M Cameron) which eased the pace approaching the 1000 metres.</p> <p><b>M Cameron</b> (NOT USUAL PRINCE) – Reprimanded by Stewards and advised that he must not steady the pace to a degree that places riders in difficulty behind him.</p> <p><b>ORIENTAL DRAGON</b> (S Collett) – Raced in restricted room passing the 1100 metres to the inside of HOOF HEFNER which commenced to over-race and was taken in slightly by LANGBEIN which had improved to the inside of GET SMART which shifted in. HEAT SEEKER which had commenced to race ungenerously then shifted out further crowding ORIENTAL DRAGON who was steadied losing ground.</p>	

**HEAT SEEKER** (B Morgenrood) – Raced ungenerously passing 1100 metres when in restricted room. Raced greenly when placed under pressure in the final straight making contact approaching the 200 metres and again near the 150 metres.

**B. Morgenrood** (HEAT SEEKER) – Reprimanded by Stewards after relaxing his ride over the final 50 metres and advised that he must ride his mounts out fully to the end of the race when circumstances permit him to do so.

**YOUVEBEENLITUP** (M Coleman) – Crowded shortly after the start losing ground.

**TAKE IT OUT** (M Vance) – Raced wide throughout.

**FIRENZE** (M McNab) – Commenced to give ground approaching the 700 metres and was not persevered with in the final straight. Underwent a subsequent veterinary examination which revealed a slower than normal recovery rate. Rider M McNab advised that the gelding had refused to hit out.

**DESERT STORM** (M Cameron) - When questioned rider M Cameron could offer no tangible excuses for the performance.

**SOUL SENSATION** (D Johnson) - When questioned rider D Johnson could offer no tangible excuses for the performance.

**TAMA AKARANA** (J Nason) – Apprentice Jockey J. Nason could offer no excuses for the performance.

<b>Race 7</b>	<b>SMILE INFLATABLES (1600 METRES)</b>

**GLENDALOUGH** (M Du Plessis) – Severely crowded soon after leaving the barriers losing considerable ground.

**GOLD SPICE** (D Prastiyu) – Began awkwardly making contact with STEVEN JAMES, then was crowded shortly after losing ground, improved onto heels on a number occasions in the middle stages, was unable to obtain clear running until passing the 200 metres.

**ELLE EYE ARE** (D Johnson) – Crowded soon after leaving the barriers and was steadied.

**STIMPLYTHEBEST** (A Jones) – Raced three wide without cover.

**STARRYBEEL** – Improved into a marginal passing the 300 metres making contact with the hindquarters of MASTER PAINTON which became briefly unbalanced with STARRYBEEL then being briefly steadied.

**MONGOLIAN MARSHALL** (M Cameron) – Suffered interference passing the 400 metres when bumped.

**MASTER PAINTON** (O Bosson) - Badly crowded shortly after leaving the barriers losing ground, suffered interference passing the 400 metres, unbalanced when received contact to hindquarters 300 metres.

**J Riddell** – Admitted a charge of careless riding in that he angled his mount STEVEN JAMES outwards when not sufficiently clear causing interference to MONGOLIAN MARSHALL and MASTER PAINTON passing the 400 metres with the Judicial Committee imposing a suspension from the conclusion of racing on Saturday 27 January until the conclusion of racing on Saturday 3 February, 5 National riding days.

**M Cameron** (MONGOLIAN MARSHALL) - Reminded of his obligations in that he must ride out fully to the end of the race when circumstances permit him to do so.

**C Lamm** (DIAMONDSANDBUBLES) – Reminded of his obligations in that he must ride out fully to the end of the race when circumstances permit him to do so.
