Race 1	MOUNT SHOP (2100m)
COBBLER JIM (A Schwerin) – Began awkwardly shifting in abruptly making firm contact with MADAM WOO. Over-raced in the early to middle stages and raced wide for the majority of the event.	

REDCAYENNE (J Bayliss) – Slow to begin. Shifted out under pressure concluding stages dictating MADAM WOO wider on the track.	
MADAM WOO (M Du Plessis) – Bumped at the start. Dictated wider concluding stages.	
Race 2	HAUNUI FARM SPRINT (1200m)
BEYOND DISPUTE (S Collett) – Began awkwardly losing ground.	
Race 3	CRC MEMBERS DRAW (1200m)
H Marzuki admitted a breach of [Rule 330(3)(c)] in that he failed to make the contract weight for THE BOK and was replaced with the JCA imposing fine of \$100 under the Minor Infringement Table.	
MORWEKA (M Coleman) - Blundered at the start.	
ARCTIC STORM (A Collett) - Inconvenienced when MORWEKA shifted out near the 300 metres.	
Race 4	CRC MEMBERS DRAW (1200m)
CONCLUSION (D Prastiyoun) – Began awkwardly.	
PUSHKA (R Scott) – Knuckled at the start.	
CHURCH ROAD (M De Plessis) – Began awkwardly shifting out and making firm contact with PRINCEVILLE.	
PRINCEVILLE (A Collett) – Bumped at the start.	
Race 5	MCMILLAN EQUINE (1400m)
GUNDOWN (O Bosson) – Crowded shortly after the start having to be steadied.	
SCINTILLA (S Collett) – Slow to begin.	
LE PATRON (T Allan) – Began awkwardly and shifted in.	
Race 6	SSANGYONG (1600m)
O Bosson admitted a breach of [Rule 330(3)(c)] in that he failed to make the contract weight for SWING NOTE and was replaced with the JCA imposing fine of \$100 under the Minor Infringement Table.	
SWING NOTE (A Collett) – Slow to begin.	
RED SKY AT NIGHT (M Cameron) – Slow to begin. Rider reported the mare had failed to handle today's track conditions.	
SAFFRON LADY (J Bayliss) – Over-raced in the early stages. Lay out on to the heels of the runner in front near the 150 metres and had to be steadied. When questioned rider reported the mare had only battled in today's heavy track conditions.	
Race 7	LONE STAR PUKEKOHE (1600m)
GOLD SPICE (M Coleman) – Began awkwardly and shifted in making firm contact with HOOF HEFNER with both runners losing ground.	
HOOF HEFNER (M Hills) – Bumped shortly after the start losing ground.	
FEEL THE BREEZE (T Thornton) – Raced keenly in the early stages then had to be firmly restrained near the 1250 metres when ONEZEROFIVE (A Collett) shifted out. Contributing was slight inward movement from LEARNING TO FLY. A Collett was advised to exercise care.	
ONEZEROFIVE (A Collett) – Stewards ordered a post-race veterinary examination of the filly which finished last and had been reported by its rider to have made abnormal breathing noises. The subsequent inspection revealed the filly to be suffering from a poor post-race recovery. The connections were advised a veterinary clearance would be required prior to	

racing next.

Race 8	FASTTRACK INSURANCE (1600m)

LEWIS ROAD (S Collett) – Crowded shortly after the start having to be steadied.

RUNNING SMOOTH (L Satherley) – Momentarily steadied when placed in restricted room passing the 1200 metres and was again placed in restricted room passing the 900 metres.

MONGOLIAN MARSHAL (O Bosson) – Shifted out when placed under pressure approaching the 100 metres making contact with AZABOY.

AZABOY (A Collett) – Bumped approaching the 100 metres.

KEEPER GIRL (J Riddell) – When offered the chance to comment on today's performance the rider could offer no tangible excuses.

J Fawcett (THE MATRIX) – Spoken to advisedly regarding her whip use prior to the 100 metres.
