RACE COMMENTS:

Race 1 RICCARTON PARK FUNCTION CENTRE MAIDEN (2000m)

ZANTE (C Johnson) – Raced keenly through the early stages when leading.

TACKTHEFLAG (K Gundowry) – Crowded and had to be steadied passing the 450 metres between FEROCIOUS (K Mudhoo) and JUSTRUSH (C Barnes) which both shifted ground. C Barnes and K Mudhoo were both advised to exercise greater care.

FEROCIOUS (K Mudhoo) – Lay in under pressure in the final straight.

SATIN FLAG (J Lowry) – Raced in restricted room for a short distance passing the 100 metres.

K Mudhoo (FEROCIOUS) admitted a charge of excessive use of the whip prior to the 100 metres with the Judicial Committee imposing a fine of \$400.

Race 2 HUGHES RACING STABLES RATING 85 (1400m)

T Jonker (BONAPARTE) defended a charge of careless riding in that she permitted her mount to shift inwards passing the 900 metres when steadying her mount and not clear of TOMM JONES which then had to be checked to avoid that runner's heels. After viewing films and hearing submissions the Judicial Committee dismissed the charge.

TOMM JONES (T Comignaghi) – Checked off heels 1000 metres, held up for a short distance passing the 400 metres.

G Jogoo (WHISPERING) admitted a charge of excessive use of the whip prior to the 100 metres with the Judicial Committee suspending his licence to ride at race meetings for 7 national days effective 18 February to 1 March inclusive.

Race 3 PUNTERS CHALLENGE APRIL 7 – ENTER NOW 2 & 3YO (1200m)

NON BLONDE (H Bennet) – Hampered leaving the barriers when DISRUPTION jumped outwards.

S Wynne (PIPIANA) was issued with a warning after permitting her mount to shift inwards when being restrained and not fully clear of DISRUPTION which then had to shift outwards across the heels of PIPIANA near the 1000 metres.

DISRUPTION (A Collett) – Crowded 1000 metres and steadied outwards across heels.

ACEKINGSUITED (K Mudhoo) – Eased down over the final 200 metres and returned to the birdcage with blood present in both nostrils being confirmed as a bleeder following a post-race veterinary inspection. ACEKINGSUITED is now stood down for the mandatory two month period from training and three month stand down from trialing or racing, with a veterinary clearance then required prior to trailing or racing again.

Race 4 SPEIGHT'S MAIDEN (1200m)

POPSICO (T Moseley) – Slow to begin, raced wide throughout.

CHORISTER (K Mudhoo) – Knuckled leaving the barriers.

SHE'S A RIPPER (S Wynne) – Bumped at the start, steadied when awkwardly placed on the heels of LIVE IN HOPE shortly after the start. Rider could offer no tangible excuse for the disappointing performance.

DUTCH COURAGE (G Jogoo) – Shifted outwards under pressure in the final straight with MISS BRAHMOS then being inclined to shift away from that runner. G Jogoo was advised he must exercise greater care when shifting ground and straighten his mounts sooner than he did on this occasion.

MISS BRAHMOS (A Collett) – Shifted outwards away from inside runner through final straight

Race 5 CLARE YARDLEY – BARRISTER RATING 75 (1200m)

B Wilson (ZAWHIP) was issued with a warning under Rule 616(4) for presenting that runner without notified side winkers.

ZAWHIP (J Laking) – Began awkwardly, checked passing the 50 metres. Rider J Laking viewed replays of this incident before electing not to proceed with a protest.

QUEEN SERENE (BB Hong) – Crowded at the start and lost ground, raced in restricted room for several strides passing the 50 metres.

K Mudhoo (FLYTIME) admitted a breach of careless riding in that he allowed his mount to shift outwards passing the 50 metres checking ZAWHIP, with the Judicial Committee suspending his licence for 10 national days effective 18 February to 7 March inclusive.

PIPPI REA (G Jogoo) – Rider lost the whip passing the 100 metres and could offer no tangible excuse for the disappointing performance.

MIA MAMMA (T Comignaghi) – Rider could offer no tangible excuse for the disappointing performance of this favoured runner.

Race 6 KORU CARE CHARITY DINNER MARCH 23 MAIDEN (1600m)

The start was delayed 9 minutes after the saddle on **TUSSOCK** broke at the barriers, with rider T Comignaghi having to return to the weighing area to reweigh with a replacement saddle.

HARPER JEAN (J Morris) – Slow to begin, raced greenly in the early stages.

LOUVRES (R Firdhaus) – Slow to begin.

JUST AFLUTTER (K Williams) – Raced ungenerously when being restrained in the early stages getting its head up. Raced greenly throughout.

FEDERER EXPRESS (A Collett) – Had to be steadied when crowded near the 1400 metres, raced three wide without cover.

J Laking (CARDRONA) was issued with a warning after permitting his mount to shift inwards when not sufficiently clear of FEDERER EXPRESS which had to be steadied near the 1400 metres.

LAKE CHALICE (S Collett) – Bumped approaching the 600 metres when BABAN (G Jogoo) shifted outwards to obtain clear running. G Jogoo was advised to exercise greater care. Checked and forced inwards 75 metres.

VIVIDREDSKY (L Callaway) – Held up near the 250 metres having to shift outwards off the heels of COUP DREAMWOOD, again being held up passing the 150 metres and hampered near the 50 metres.

T Comignaghi (TUSSOCK) was issued with a warning after permitting her mount to shift outwards in the final straight hampering TONY TWO CHIPS near the 150 metres.

TONY TWO CHIPS (C Barnes) – Hampered 150 metres, then further hampered near the 75 metres.

COUP DREAMWOOD (C Johnson) – Unable to obtain clear running over the final 150 metres.

J Laking (CARDRONA) admitted a breach of careless riding in that he allowed his mount to shift inwards when not sufficiently clear of LAKE CHALICE which was checked and taken inwards onto TONY TWO CHIPS which was steadied passing the 75 metres. The Judicial Committee suspended J Laking's licence to ride at race meetings for 7 national days effective 18 February to 1 March inclusive.

Race 7 CALOUNDRA CUP TOUR 2018 – BOOK NOW RATING 75 (1600m)

WAYLAY (C Campbell) – Raced wide in the early stages, bumped on two occasions over the concluding stages and was dictated wider on the track when FORGED shifted outwards under pressure throughout the run home.

Stewards lodged a protest alleging that 1st placed **FORGED** interfered with 2nd placed **WAYLAY** in the final straight. After viewing films and hearing submissions the Judicial Committee dismissed the protest.

K Mudhoo (FORGED) was issued with a warning for the manner in which he shifted ground in the final straight.

Race 8 CHRISTCHURCH CASINO RATING 65 (2000m)

RED RIVER ROCK (R Cuneen) – Slow to begin. Shifted in under pressure 325 metres.

SWEET INDULGENCE (S Wynne) – Began awkwardly hampering KEEP THE LOT and PICKUP, raced three wide without cover throughout. Checked when tiring passing 300 metres.

KEEP THE LOT (G Jogoo) – Hampered at the start.

PICKUP (C Johnson) – Hampered at the start.

KARAYAH (J Morris) – Jumped away awkwardly and then raced ungenerously when being restrained in the early stages.

C Campbell (SATIN GURU) admitted a breach of careless riding in that he allowed his mount to shift in checking SWEET INDULGENCE passing the 300 metres, with the Judicial Committee suspending his licence to ride at race meetings for 5 national days effective 18 February to 25 February inclusive.

R Cuneen (RED RIVER ROCK) admitted a breach of careless riding in that he allowed his mount to shift in crowding and forcing SATIN GURU across heels passing the 325 metres, with the Judicial Committee suspending his licence to ride at race meetings for 7 national days effective 18 February to 1 March inclusive.

SATIN GURU (C Campbell) - Crowded and had to steady when awkwardly placed on heels passing the 325 metres and then shifted inwards to find clear running.

PAPINA (T Comignaghi) – Rider reported that the mare had held its breath during the running.

TAXIHOME (J Laking) – When spoken to regarding the apparent improved performance, co-trainer R McKay advised that the gelding had been obliged to improve very wide rounding the final bend at its last start and today had been aided by an economical run and a senior rider.

Race 9 RACECOURSE HOTEL & MOTOR LODGE RATING 65 (1400m)

BRAVO SUPREMO who was fractious in the barriers reared and then became cast and once removed was declared a late scratching at 5.27 pm. A number of other runners became fractious as a result of this incident with **FIRE LILY, SARONIC MISS** and **KENYA** then also declared late scratching's at 5.28 pm on veterinary advice. Rider S Wynne was attended to by St John Paramedics and cleared of any injury. As a result of this incident all horses were removed from the barriers and this race ran 12 minutes late. The connections of **BRAVO SUPREMO** were advised that the gelding must barrier trial to the satisfaction of Stewards and produce a veterinary clearance prior to racing again.

HOOFBEAT (C Johnson) – Over raced in the middle stages having to be firmly restrained to avoid heels near the 800 metres.

SENSIBILITY (T Moseley) – Raced three wide without cover.

A post-race veterinary inspection of **FIRE LILY** revealed abrasions and lacerations to the left and right stifles and severe lameness in the left hind leg. A veterinary clearance is required prior to racing next.

A post-race veterinary inspection of **SARONIC MISS** revealed lacerations to the left and right stifles and large hematoma to the left forearm/radius. A veterinary clearance is required prior to racing next.

Stewards report as posted is provisional and subject to further review and amendment.
