Race 1 - C & C AUTOS 1100M

LADY HASS (J Bayliss) - Trainer T Pike advised that the mare underwent further veterinary examination on return to his stable which did not reveal any abnormality and further advised that it is his intention to trial LADY HASS prior to racing next.

Race 7 - ANTON MORA & SON PAINTERS MAIDEN 1800M

BLOOMSBURY (S Weatherley) – Trainer C Bothwell advised that an endoscopic examination did not reveal any abnormality.

Race 3 - ASHFORD LODGE 2YO STAKES (Listed) 1100 metres

AUTUMN WILD (J Bayliss) – Trainer A Scott advised that he was satisfied with the recovery of the filly and it is their intention to continue on with its current preparation.

Race 6 - LONE STAR PUKEKOHE 1600

COMIN'THROUGH (J Parkes) – Trainer C Gibbs advised that he was satisfied with the recovery of the gelding, adding it is their intention to add blinkers to its notifiable gear prior to racing next.

Race 3 - PTS LOGISTICS / BNZ PARTNERS MAIDEN (1300 metres)

SHEZ GONNA GETCHA (D Hirini) – Trainer D Hayes advised that the mare underwent blood tests following its performance in this race which showed it to be suffering from a virus with it now having received treatment.

Race 7 - COOLMORE AUSTRALIA 1600

SLICE OF CAKE (V Colgan) – Trainer T Pike advised that he was satisfied with the recovery of the gelding, adding it is his intention to freshen it prior to racing next.

RACE COMMENTS:

Race 1 AJC MEMBERS 2000

ROUSSEAU (D Johnson) – Jumped away awkwardly making contact with ARCTIC MISS which was forced onto PISTOL PETE with ARCTIC MISS losing ground.

D Johnson – Issued with a warning for her whip use on ROUSSEAU prior to the 100 metres.

ARCTIC MISS (S Weatherley) – Bumped and crowded start losing ground.

PISTOL PETE (A Jones) – Bumped start.

SHOCKWAVE (C Lammas) – Over-raced for a distance passing the winning post on the first occasion becoming awkwardly placed on heels near the 1700 metres shifting outwards making contact with the hindquarters of RAY'S LEGACY, briefly held up approaching the 400 metres.

RAY'S LEGACY (M Coleman) – Unbalanced when received contact to hindquarters 1700 metres, raced wide without cover until near the 1200 metres.

MEDINI (T Thornton) – Raced three wide cover for the majority of the race.

Race 2 AVONDALE SUNDAY MARKETS 1200

SOKITOME (T Thornton) – Jumped away awkwardly, raced fiercely when being steadied passing the 900 metres.

GIRL WITH A CURL (S Collett) – Raced ungenerously when being steadied going into the bend near the 900 metres.

LUCIANA (M McNab) – Raced wide without cover throughout.

POLZEATH (J Fawcett) – Shifted outwards to obtain clear running passing the 400 metres inconveniencing LUCIANA.

Race 3 SAM MALCOMSON 1200

AULYN DANCER (L Innes) – Began awkwardly losing ground.

LOS ANGELES (M Du Plessis) – Slow away, held up for a short distance early in the final straight then having to shift ground outwards passing the 250 metres to obtain clear running.

THE FAME GAME (M Hills) – Commenced to race ungenerously when being steadied making the bend near the 900 metres awkwardly.

PUSHKA (R Scott) – Hampered 350 metres when bumped by SCREAMING MIMI which lay in.

Following this race the track was upgraded to Dead (4).

Race 4 FRIENDS OF FOOTBALL 1200

CRUX (G Saejorhor) – Jumped away awkwardly.

ASTON PARK (T Thornton) – Over-raced in the early and middle stages when three wide without cover throughout and was inclined to hang outwards rounding the bend.

UNDER WRAPS (S Collett) – Commenced to over-race when being restrained making the 900 metre bend awkwardly, unable to obtain clear running until near the 150 metres then shifting in, placing BIGSIE in restricted room near the 75 metres before then laying out under pressure crowding ST REGIS onto SEDUTTORE and SCARLET PRINCESS just short of the finish.

SEDUTTORE (D Johnson) - Inconvenienced concluding stages.

SCARLET PRINCESS (M Du Plessis) - Inconvenienced concluding stages.

ST REGIS (R Elliot) – Lay out under pressure passing the 300 metres. Inconvenienced concluding stages.

BIGSIE (E Smith) – Placed in restricted room 75 metres.

Race 5 GCS LOGISTICS 1400

MISS FOXY GAL (S Weatherley) – Underwent a veterinary inspection after being kicked behind the barriers being passed fit to run. Crowded and steadied 800 metres.

CASSIO (T Thornton) – Over-raced in the early to middle stages, forced outwards 200 metres, hampered 50 metres.

SHOW ME YOUR PINS (C Lammas) - Over-raced in the early to middle stages and commenced to lay out making the bend awkwardly crowding MISS FOXY GAL which had to be steadied near the 800 metres.

MISSTUMUT (S McKay) – Raced ungenerously after making slight contact with VERBAL COMMAND near the 900 metres.

S Weatherley – Issued with a warning after permitting his mount MISS FOXY GAL to shift outwards near the 200 metres when not clear of CASSIO which was forced outwards with MISS FOXY GAL again shifting outwards near the 50 metres hampering VERSES and CASSIO.

VERSES (J Nason) – Hampered 50 metres.

Race 6 WEST BROOK WINES 1400

SUNBURST (M Coleman) – Severely crowded between MADURO and PONT ALMA leaving the barriers losing ground, unable to obtain clear running until approaching the 200 metres.

TOITOI (D Johnson) – Over-raced when being restrained in the early stages.

RAKAU WHERO (J Nason) – Raced three wide without cover throughout, hampered 800 metres.

THE ICE KNIGHT (M McNab) – Became awkwardly placed on the heels of IMPERIOUS which shifted outwards when overracing near the 800 metres with THE ICE KNIGHT then being forced wide on the track and RAKAU WHERO also being hampered as a result.

PONT ALMA (M Du Plessis) – Unable to obtain clear running throughout the final straight until the concluding stages.

IMPERIOUS (S Weatherley) – Shifted outwards to avoid heels when over-racing 800 metres, steadied when crowded near the 50 metres between JIMMY ROCKET and THE ICE KNIGHT which both shifted ground. V Colgan and M McNab were both advised to exercise greater care.

The track was downgraded to Dead (6) retrospective to Race 6 following a period of heavy rain.

Race 7 NANKANG TIRES 1400

CARRADINE (T Thornton) – Jumped away awkwardly making contact with UNFAZED losing ground.

UNFAZED (S Collett) – Bumped start.

MAJIC RULER (M Du Plessis) – Raced wide throughout, lay inwards when placed under pressure in the final straight and could not be ridden to full advantage.

CASCATA (H Marzuki) – Held up near the 300 metres and when shifting outwards to obtain clear running inconvenienced UNFAZED passing the 250 metres. H Marzuki was advised to exercise greater care.

SISTABEEL (L Innes) – When questioned regarding the performance rider was unable to offer any excuses, trainer L Noble advised that the filly is now likely to be spelled.

MASU (D Johnson) – When questioned regarding the performance rider advised that the gelding had not felt comfortable in the track conditions which she described as having become shifty.

Race 8 www.westbrook.co.nz 1600

DIAMONDSANDBUBBLES (C Lammas) – Slow to begin, raced in restricted room passing the 250 metres, became awkwardly placed over the final 50 metres being steadied.

EXPRESS CALL (R Elliot) – Over-raced when being restrained for a distance passing the 1000 metres then electing to improve forward to sit outside the leader near the 700 metres.

BOUNDARY (M Coleman) - Raced ungenerously for a distance passing the 1000 metres.

SINGLE MOMENT (L Satherley) – Had difficulty obtaining clear running until passing the 250 metres.

FLASH AS (M Hills) – Was unable to obtain clear running until inside the final 150 metres.

D Johnson – Issued with a warning after allowing her mount FORMIDABLE to shift outwards under pressure dictating MADAM WOO outwards onto NIGHTSONG which was inconvenienced approaching the 100 metres. FORMIDABLE continued to shift outwards placing MADAM WOO in restricted room over the concluding stages.

MADAM WOO (M Du Plessis) – Inconvenienced when dictated outwards approaching 100 metres, raced in restricted room over the concluding stages.

NIGHTSONG (S Collett) – Inconvenienced when bumped approaching 100 metres, following the race the rider of the second placed horse NIGHTSONG viewed Stewards film footage before electing not to proceed with a protest against the first placed horse FORMIDABLE.
