RACE COMMENTS:

Race 1 ROSSER UNDERWRITING & LOWE SCHOLLUM JONES MAIDEN 2060m

Trainer K Gray was issued with a warning under Rule 616 (2) in that he presented CANDY BELT with non-notified gear.

HARD BUT FAIR (A Shin) - awkwardly away settling back

CANDY BELT (C Waddell) - Tightened shortly after the start. Held up briefly approaching the 400 metres.

SHEZACRAFTSMAN (A Collett) - bumped LUCQUIDE approaching the 1,700 metres and near the winning post on the first occasion SHEZACRAFTSMAN was tightened when MARJOLET (M Singh) shifted in when not clear of LUCQUIDE which was dictated inwards tightening SHEZACRAFTSMAN. After questioning riders, M Singh was issued with a warning under 638 (1) (d). A short distance further LUCKY DREAMER made the bend awkwardly and when being steadied came back onto SHEZACRAFTSMAN which was checked. Also affected was CANDY BELT which had to steady when taking evasive action. Held up near the 500 metres. Shifted out under hard riding passing the 100 metres briefly inconveniencing CANDY BELT.

SKYPHYTA (J Parkes) - Held up for a distance passing the 600 metres behind the tiring UPMARKET.

JAZAMOUR (R Myers) – Held up for a distance passing the 500 metres.

MARJOLET (M Singh) – Held up approaching the 200 metres then raced in restricted room inside the final 100 metres.

MAUNA KEA (T Johnson) - Lay in early in the home straight having to be straightened near the 200 metres.

UPMARKET (S Collett) – When questioned into the performance S Collett reported the gelding pulled up in a normal post-race condition and was disappointing.

H Andrew (LUCQUIDE) - was spoken to advisedly regarding her whip use on a runner out of contention.

Race 2 WANGANUI STEELFORMERS 2060m

BEAUTIFUL MAN (A Jones) – Awkwardly away. Raced ungenerously getting its head in the air when being restrained in the middle stages. Layout passing the 400 metres contacting **XCESSORY**.

PERCY'S GEM (C Dell) – raced three-wide on the pace throughout

COMMANDING PRINCE (M Singh) – raced keenly in the early to middle stages

SO IT WAS (A Shin) - raced ungenerously passing the 1700 metres making the bend awkwardly

OWNED (S Collett) – Bumped near the 200 metres when **STAROSSA (J Fawcett)** was angled out in search of clear running.

After questioning riders and viewing footage it was considered **STAROSSA** shifted out further than the rider intended nevertheless J Fawcett was issued with a warning under Rule 638 (1) (d).

STAROSSA (J Fawcett) – Held up from the 600 metres having to be restrained off heels near the 200 metres, shifted outwards contacting OWNED.

WOTAMISSION (H Andrew) - raced in restricted room early in the home straight

HARE BAWL (A Collett) - Held up from the 600 metres having to be angled outwards across heels early in the home straight to obtain clear running.

A Jones the rider of **BEAUTIFUL MAN** was advised to exercise care in that near the 200 metres she angled her mount outwards when not fully clear tightening **XCESSORY** and **SO IT WAS**, and briefly inconveniencing **KATIEM MARIE**.

Race 3 RAY WHITE REAL ESTATE MAIDEN 1200m

BOBBY DAWN (T Johnson) – Late scratching on veterinary advice prior to the start after becoming fractious in the barriers. Connections were advised the filly must trial prior to next racing.

MISS VALENCIA (R Myers) - Underwent a pre-race veterinary inspection after rearing at the start and was cleared to race. Restrained off heels shortly after the start. Held up from the 600 metres having to be angled outwards to obtain clear running passing the 400 metres.

DANCING DELIGHT (D Hirini) – Connections were advised that a warning will be placed against the filly's barrier manners after being reluctant to load.

H Andrew (WHAT A SMASHER) - was issued with a warning under Rule 638 (4) after easing her mount on obtaining the lead shortly after the start placing **MISS VALENCIA** in some difficulty for a short distance.

Race 4 GUTHRIE BOWRON MAIDEN 1200m

WONDER NO MORE (T Allan) – Slow away after being fractious in the barrier. Connections were advised that a warning will be placed against the filly's barrier manners. When questioned into the run T Allan advised the filly had become very worked up prior to the start.

SHREK (C Waddell) – Awkwardly away settling back. Hung inwards in the home straight.

BOY SOLDIER (M Hills) - raced keenly in the early stages

DU'BLUES (M Tanaka) - raced keenly passing the 1,000 metres

GREAT NORTH ROAD (R Elliot) - raced wide without cover throughout

QUAFF (J Fawcett) - Raced three-wide on the pace throughout. Lay in early in the home straight.

IN SEGRETO (H Andrew) - held up approaching the 400 metres gaining clear running early in the home straight

Race 5 LOWE SCHOLLUM JONES 1200m

INCANTATION (S Collett) – Slow away. Raced keenly in the early stages.

EDWARDIAN LADY (A Jones) - When questioned into the performance rider advised the mare had been disappointing. A subsequent veterinary examination was clear.

BROTHER ONE (C Waddell) – lost the off-front plate during the running

Race 6 NZB INSURANCE PEARL SERIES RACE MAIDEN 1360m

RUMOUR HAS IT (A Collett) – Got its head up as the start was effected and was slow away. Finished last. When questioned into the performance rider could offer no excuse. A subsequent veterinary examination revealed no obvious abnormality.

WON'T BACK DOWN (M Singh) – Had to shift outwards near the 200 metres to improve and again passing the 100 metres.

Race 7 WANGANUI GREYHOUND CLUB RACING TONIGHT MAIDEN 1600m

CEAD MILE FAILTE (R Myers) - three-wide without cover throughout

WAISAKE (T Johnson) – Made the bend approaching the 1,400 metres very awkwardly when racing greenly, running wide on the track dictating **LINCOLN DREAMER** and **TELSETTE** outwards.

LINCOLN DREAMER (A Collett) – Slow away then dictated wider on the track approaching the 1,400 metres.

TELSETTE (H Andrew) – dictated wider on the track approaching the 1,400 metres

MIDDAGURD (S MacNab) – Slow away. Raced ungenerously in the middle stages.

SOLSAVON (J Parkes) – Held up from the 600 metres and had to be angled outwards to obtain clear running approaching the 200 metres.

Race 8 STEVO'S DISTRIBUTORS MAIDEN 1600m

SOIREE (C Dell) – Was awkwardly away and settled back. Hung outwards when racing in restricted room approaching the 1,400 metres.

JUST GEORGIE (C O'Beirne) – Raced keenly in the early to middle stages. Ran greenly in the home straight when under pressure. Shifted inwards near the 100 metres tightening **HANDYMAN** and also inconveniencing **ROCK RULZ** which had to be steadied. **C O'Beirne** was issued with a warning under Rule 638 (1) (d).

OFF WITH HER HEAD (A Shin) – Hung outwards making the bend awkwardly approaching the 1,400 metres.

KATHY'S LINCOLN (A Collett) – Raced ungenerously in the early stages and was heavily restrained when **JUST GEORGIE** (C O'Beirne) crossed going into the 1,400 metre bend. C O'Beirne was advised to exercise more care. Briefly held up near the 250 metres and again passing the 150 metres.
