<b>Race 1</b>	<b>RACE A HORSE WITH TE AKAU 1000</b>
<b>MISS SEQUOIA</b> (R Scott) – Slow away.	

**POPPIN' BUBBLES** (R Smyth) – Tightened at the start losing ground. Steadied when becoming awkwardly placed on heels near the 100 metres.

**LHOTSE** (S Spratt) – Began awkwardly.

**SNOWBELLE** (J Bayliss) – Lay in when placed under pressure in the final straight, shifted in and away from LA ROCETTA passing the 75 metres inconveniencing MIA MADRE despite the efforts of its rider and then continued to lay in for the remainder of the race.

**MIA MADRE** (A Collett) – Inconvenienced 75 metres.

**J Bayliss** (SNOWBELLE) - Was reminded of his obligations in that he must ride his mount out fully to the finish when circumstances permit him to do so.

**COMEBACK** (R Elliot) – Bumped shortly after the start.

**PIMMS 'N' PEARLS** (L Satherley) – Raced keenly in the early stages.

**MARIOTA** (J Fawcett) – Raced in restricted room passing the 1150 metres having to be steadied.

**ANICETA** (M McNab) - Began awkwardly.

**EPONA** (J Grob) – Tightened leaving the barriers having to be steadied.

**STEVIE'S SURPRISE** (A Sims) – Bumped leaving barriers.

**JAYBIRD** (L Satherley) – Inconvenienced passing the 700 metres by ANICETA which shifted out also inconvenienced as a result was SHOTGUN WILLIE.

**SHOTGUN WILLIE** (T Wenn) – Inconvenienced passing the 700 metres.

**M McNab** (ANICETA) – Issued with a warning for shifting his mount outwards when insufficiently clear passing the 700 metres inconveniencing JAYBIRD and SHOTGUN WILLIE.

**TOURMALINE** (C Lammas) – Slow to begin.

**HEEZNOT** (T Thornton) – Over raced in the early stages, steadied when placed in restricted room to the inside of AIGNE (T Allan) passing the 1600 metres. T Allan was advised to exercise greater care.

**KORAKONUI** (A Collett) – Had to be steadied passing the 1500 metres when awkwardly placed on heels.

**JOKING** (A Sims) – Raced three wide without cover throughout.

**DEMELZA** (D Johnson) – Returned to the enclosure with blood present in both nostrils and after undergoing a post race veterinary examination was determined to have bled. DEMELZA is now subject to a two month stand down from training and three month stand down from racing with a veterinary certificate of fitness required for DEMELZA before trialing or racing next. Connections advised that DEMELZA would no longer be persevered with as a racing proposition from their stable.

**T Allan** (AIGNE) – Was issued with a warning for his whip use prior to the 100 metres.

**TWO THIRTY** (M Edwards) – Jumped away awkwardly losing ground.

**THE CHASER** (M McNab) – Began awkwardly.

**LADY HASS** (S Collett) - Received veterinary treatment post race after showing signs of exertional rhabdomyolysis (tied up)

**JUST PUSH PLAY** (K Cowan) – Slow to begin.

**SWITCH PITCHER** (J Nason) – Raced wide without cover throughout.

**SHAHANA** (A Collett) – Began awkwardly.

**J Nason** – Admitted a breach in that he used his whip excessively prior to the 100 metres when riding SWITCH PITCHER with the Judicial Committee imposing a fine of \$300.

**GANGSTERS LASS** (T Collett) – Had to be steadied approaching the 250 metres when LIPS OF AN ANGEL shifted out.

**J Bayliss** - Issued with a warning after allowing LIPS OF AN ANGEL shift out approaching the 250 meters when insufficiently clear of GANGSTERS LASS which was briefly steadied.
