RACE COMMENTS:

Race 1	A1 DRY CLEANING MAIDEN

RED SOCKS (G Jogoo) slow to begin.

MAHIDUN (S Wynne) was hampered shortly after the start and placed in restricted racing room, made the final bend awkwardly laying outwards.

BLUSTEEL (Z Moki) slow to begin.

NIGHTTRONIC (S MacNab) proved difficult to load.

HAPPY SEA DRAGON (S Collett) Lay out passing the 650 metres and made the final bend awkwardly.

PINKO MOON (C O'Beirne) began awkwardly , steadied near the 800 metres when **WHERE ANGELS WALK** (Chris Johnson) shifted inwards. C Johnson was reminded of his obligations.

ITSTOLATE (J Bassett) steadied near the 400 metres when in restricted room to the outside of **WHERE ANGELS WALK** (Chris Johnson) which shifted outwards. C Johnson was warned for shifting ground.

BEFORE DAWN (R Myers) lay inwards in the early part of the home straight and took some time to clear heels obtaining clear running near the 100 metres.

B Lammas – was unable to make the contract weight for **NIGHTTRONIC** and was replaced by S MacNab .

Race 2

SPEGHTS 1000

JAZZMAN (J Bassett) placed in restricted room and steadied when hampered after jumping. Commenced to race fiercely at the 800 metres and had to be steadied off heels for some distance.

CELTIC CROSS (R Firdhaus) jumped inwards at the start tightening inside runners

TIEBREAKER (R Myers) blundered after jumping.

FULLY CHARGED (K Williams) hampered after the start when in restricted room, wide entering the home straight.

BISOU BISOU (S MacNab) placed in restricted room after the start.

MADAM BENTLEY (C Johnson) commenced to lay outwards passing the 500 metres and made the home bend awkwardly.

S MacNab admitted a breach of rule 638(3)(b)(ii) in that she used her whip excessively prior to the 100 metres. After hearing all relevant submissions the JCA suspended her licence to ride from April 30 up to and including 9 May (6 days).

Race 3

PUTAKE HONEY MAIDEN 1400

MAHANA (C Johnson) had to be restrained off heels at the 1200 metres, lay outwards rounding the final bend.

THREE SHOTS (R Firdhaus) jumped away awkwardly and was slow to begin, steadied near the 600 metres when awkwardly placed on heels.

STRADA ROCCIA (S Wynne) slow away.

BUFFALO ROSE (K Williams) faltered near the 600 metres and was pulled up. A post-race veterinary inspection revealed a left front swollen flexor tendon. Connections were advised that a full veterinary clearance would be required prior to racing next.

THE POORMANZABEEL (T Comignaghi) keen for a short distance passing the 1200 metres

QASHQAI (L Callaway) raced wide throughout.

B Lammas – was unable to make the contract weight for **WAR HERO** and was replaced by G Jogoo.

Following this event Judge **G Rowland** was warned with respect to making a wrong call where he placed **TOBY'S CHOICE** in the wrong finishing position.

Race 4	BRYANT EARTHWORKS 1400

SHOWPIN (K Williams) slow away.

BOYSWAY (Z Moki) slow away.

TORRE DEL GRECO (S MacNab) slow to begin and over raced shortly after the start until 1000 metres.

BRAVO SUPREMO (L Callaway) over raced from the 1200 metres to the 800 metres, raced wide entering the home straight, lay inwards and had to be straightened early in the home straight.

RICHIE ROX (G Jogoo) got its head up and over raced at the 800 metres for some distance.

HOOFBEAT (T Comignaghi) wide throughout.

SMOKEN HOT (T Johnson) lay outwards in the final straight and had to be straightened near the 150 metres.

WHY ME (C Johnson) placed in restricted room momentarily at the 150 metres.

T Johnson (SMOKEN HOT) was warned for the use of his whip prior to the 100 metres.

Race 5	KEVIN MYERS 1400

SNIPARINDA (T Comignaghi) was slow to begin giving ground and tailed the field throughout, not persevered with. Connections were advised the gelding must trial satisfactorily to stewards prior to racing next. Veterinary examination revealed the gelding to be lame in the left hind leg with a veterinary clearance needed prior to racing next.

ELUSIVE BOXERS (T Moseley) raced keenly through the early stages.

The rider of **HOT TEMPO** (S Wynne) reported the mare's saddle shifted backwards during the running.

Race 6	KAM TRANSPORT MAIDEN

BASTILE BABE (S MacNab) crowded at the start and got back.

BARE WITH (Z Moki) slow to begin. A post-race veterinary inspection revealed a bowed tendon in the left front leg. Connections were advised that a veterinary clearance would be required prior to racing next.

GALWAY LIL (C O'Beirne) raced wide in the early stages.

LIVE IN HOPE (J Bassett) raced wide throughout.

KEYBOARD WARRIOR (T Moseley) improved wide rounding the final bend.

HEEL BE JAKE (K Williams) raced keenly when in the lead.

PAMIR (S Wynne) improved wide from the 800 metres.

Zinjete Moki (BARE WITH) was warned for unnecessary use of the whip on a runner out of contention.

PAINTED ANGEL (Gosen Jogoo) bumped shortly after the start and commenced to race keenly for a short distance.

Race 7 | **PETER YEALANDS WINES CUP PRELUDE**

CHIC (C Johnson) raced keenly in the early to middle stages.

Race 8 | **DOMINION SALT 1950**

HIGHLY LIKELY (Z Moki) which was fractious in the barriers began awkwardly and got back.

DOWRY DUTY (K Williams) wide early.

DESERT STORM (S Collett) wide throughout.

CARNABY (C Johnson) over raced in the early stages and raced keenly through the middle stages.

EN SUITE (S MacNab) raced keenly for a distance passing the 800 metres.

CHALLENGE (C O'Beirne) made the bend awkwardly by the 1400 metres.

YIPSON (R Firdhaus) raced ungenerously for a distance passing the 1400 metres and had to be steadied when on heels near the 900 metres.

NEWSTEAD (T Johnson) had to steady when awkwardly placed on heels near the 400 metres.

During the running of this race it became apparent to the Stewards that the starting gates had not been moved from the starting point at the top of the straight. Declaration of dividends was delayed and on return to scale all riders were interviewed in relation to the gates still being on the track at this point, with only one rider reporting that it may have had a detrimental effect on their chances. Stewards were satisfied that this event was a race and placings were duly authorised.
