RACE COMMENTS:

Race 1	HEWITT MOTORCYCLES RATING 65 (2100 metres)
THE HUNTSMAN (S Fannin) - Jumped outwards at the start inconveniencing ZAC BROWN which settled back.	

BLAZING OPAL (W Gordon) – Inconvenienced, having to be restrained near the 350 metres when **MAGIC WONDER** (K Veenendaal) angled outwards when not sufficiently clear. Rider K Veenendaal admitted a breach of Rule 638(1)(d) and had her license to ride in races suspended by the JCA from the close of racing on Thursday, 17 May 2018 up to and including racing on Wednesday, 23 May 2018 (2 days).

MAY WE ALL (A Kuru) - When questioned into performance rider could offer no excuse. A subsequent veterinary inspection was clear.

BANG (D Jensen) - Made contact with and dislodged the rail near the 1600 metres.

DAL SIR TEE (T Johnson) - Lay out under pressure over the final stages bumping **NICOSHINE** before being straightened.

Track upgraded to Dead (4) retrospective to Race 1.

GUY FOX (S MacNab) – Slow away.

SEA KING (J Seivwright) – Raced keenly in the early stages.

GAGARIN (K Veenendaal) - Raced keenly in the early stages having to be restrained off the heels of **SEA KING** near the 1700 metres. **GARGARIN** continued to race keenly through the middle stages and when again being restrained off the heels of **SEA KING**, near the 1600 metres, shifted out inconveniencing **MESMERIZE**.

MESMERIZE (I Lupton) – Inconvenienced 1600 metres.

Race 3	PROPERTY BROKERS MAIDEN (2100 metres)

UNDER THE BRIDGE (L Hemi) – Slow away.

WINEHOUSE (J Parkes) - Raced three wide in the early stages so was allowed to roll forward to sit outside the leader near the 1300 metres.

POST GRADUATE (C-M Waddell) – Raced keenly when three wide without cover and when being restrained near the 900 metres shifted inwards making contact with **PLATINUM EDITION** forcing that runner inwards.

PLATINUM EDITION (J Riddell) – Contacted 900 metres, forced inwards.

STUNNING (R Hannam) - Held up having to check off the heels of the tiring **SOIREE** approaching the 400 metres, shifting inwards briefly inconveniencing **APEROL**.

APEROL (T Allan) – Briefly inconvenienced 400 metres.

SOIREE (C O'Beirne) - Spoken to regarding the use of her whip on a runner out of contention.

OUR JOCKO (S O'Malley) - Rider reported the gelding had got its tongue over the bit during the running.

ALLURE (C O'Beirne) - Raced three wide without cover throughout.

MAXIMILLIEN (M Singh) – Contacted **MAESTRO MAX** at start settling back.

MAESTRO MAX (T Newman) – Contacted at start settling back

KATE THE GREAT (R Hannam) – Slow away.

MYRTLE (D Bradley) – Raced greenly in the home straight. Lost plate during the running.

SOPHIA MAGIA (A Shin) – Briefly held up entering the home straight.

BELLISSIMO (M Tanaka) – Raced in restricted room rounding the turn bumping with GERARDASUN near the 350 metres. When questioned into performance rider advised the mare may appreciate more rain affected footing.

GERARDASUN (J Parkes) – Bumped near 350 metres.

HEINEKEN ROCKS (L Allpress) - Lay out under pressure in the home straight.

Race 5 | **ALLEN BRADLEY MEMORIAL MAIDEN (1400 metres)**

POROTENE MHIA (D Turner) – Slow away.

HE NO OPILIO (M Singh) - Raced three wide throughout. When questioned into performance rider advised the gelding had raced greenly throughout.

SMILING PROUD (J Riddell) – Held up for a short distance approaching the 400 metres. When questioned into the improved performance of the winner, SMILING PROUD, rider J Riddell being the spokesman for the stable, advised that the gelding had raced wide throughout at its previous start and was also better suited to the Dead (4) track conditions.

Race 6 | **THE HANLEY FORMULA AUTUMN SPRINT CHAMPIONSHIP QUALIFIER (1200 metres)**

CASAQUINMAN (D Turner) – Slow away. Rider D Turner was spoken to regarding his victory celebration prior to winning post.

RAM SAM SAM (T Johnson) – Began awkwardly contacting JUST YOU.

PERFECT HARMONEE (L Allpress) - Raced three wide without cover throughout. When questioned rider advised after racing three wide on the speed the gelding had little left at the finish.

STAROSSA (J Fawcett) – Restrained off heels passing the 600 metres. Lay in under pressure in the home straight.

JUST YOU (D Bradley) – Contacted at start. Briefly held up near the 350 metres having to be angled inwards to improve.

Race 7 | **LEO MUMFORD MEMORIAL MAIDEN (1600 metres)**

DAL KILCHOAN (T Johnson) - Late scratching at 12.50pm by veterinary staff after sustaining an eye injury in the tie-up area.

FEEL THE BREEZE (L Allpress) - Raced ungenerously for a short distance when three wide without cover passing the 1200 metres.

MAUNA KEA (J Parkes) – Tightened and unbalanced near the 350 metres when NOT USUAL PRINCE (J Riddell) shifted outwards when not clear. Prior to the authorization of dividends the rider of MAUNA KEA, J Parkes, which finished second, lodged an objection against the first placed NOT USUAL PRINCE alleging interference near the 350 metres. After consideration the JCA dismissed the protest and placings stood. J Riddell admitted a subsequent charge of

careless riding under Rule 638(1)(d) and had his license to ride in races suspended from the conclusion of racing on Sunday, 13 May up to and including Friday, 25 May (8 days).

LATER ON (L Hemi) – Bumped near 350 metres.
