<b>Race 1</b>	<b>SARGENTS MOTORCYCLES MAIDEN 1000 (1000 metres)</b>
<b>COSMETIC</b> – Late scratching at 8.20am on veterinary advice. Trainer advised that a veterinary clearance is required prior to COSMETIC racing next.	

**MAGICO** (S Collett) - Lay inwards near the 800 metres tightening DEUCE COUP for a short distance, briefly inconveniencing LINCOLN HONEY which had to take evasive action and was angled out to avoid the heels of MAGICO and when doing so, inconvenienced DEVINE LOVE.

**DEUCE COUP** (M Singh) – Tightened 800 metres.

**DEVINE LOVE** (L Allpress) – Inconvenienced 800 metres.

**LINCOLN HONEY** (J Parkes) – Inconvenienced 800 metres.

**OUTTHEGATE** (M Tanaka) – Briefly hampered when DEVINE LOVE (L Allpress) lay inwards under pressure, having to be angled outwards across heels to improve. After questioning riders L Allpress was advised to exercise more care when shifting ground.

**GATES TO RIO** (C-M Waddell) - Raced in restricted room over the final stages.

**R Hannam** (LINCOLN'S SUCCESS) - Spoken to regarding the use of his whip on a runner out of contention.

**R STAM** (SWISS ELLE) – Admitted a breach of Rule 330(3)(c) in that he was unable to make the contracted weight for SWISS ELLE and was fined \$100. R Stam was replaced by J Fawcett on race morning.

**CHESTER CARLSON** (D Turner) - Awkwardly away settling back.

**DREAMS OF PLATINUM** (R Hannam) – Reared as the start was made.

**EXCEPTIONAL** (R Myers) - Raced wide without cover throughout.

**CENTRE ATTENTION** (D Hirini) - Lay outwards rounding the final turn and continued to lay out in the home straight.

**MAHIDUN** (Z Moki) – Held up for a short distance from the 500 metres.

**PICKNGO** (L Allpress) – When questioned rider could offer no excuse. A post-race veterinary inspection was clear.

**ELECTRODE** (J Parkes) - Following the race the filly was observed to be lame on entering the swab box. A subsequent veterinary inspection revealed lameness to the left hind leg and a follow-up examination was recommended.

<b>Race 3</b>	<b>FRESH CHOICE GREYTOWN MAIDEN 3YO 1400 (1400 metres)</b>

**CHOSEN PEAK** (R Myers) - Tightened at the start when ROCK ISLAND LINE jumped inwards.

**ELSTON** (T Johnson) – Slow away

**MARTINELLI** (S Collett) - Awkwardly away settling back.

**GRAND MAYSON** (L Allpress) – Rider reported the gelding was making a respiratory noise during the running. A subsequent veterinary inspection revealed a slow recovery rate.

**M Tanaka** (UNBROKEN) – Defended a breach of Rule 636(1)(d) in that he stopped riding his mount out over the final three strides. In explanation M Tanaka advised the Judicial Committee he was aware of the winner slowing and eased his mount to avoid running up on to its heels. After hearing evidence, the JCA found that the actions of Mr Tanaka were not unreasonable and the charge was dismissed.

<b>Race 4</b>	<b>WAGGS ALL NEW ZB COMMODORE MAIDEN 1400 (1400 metres)</b>
<p><b>CHARLIE HORSE</b> (D Turner) – Began awkwardly settling back.</p> <p><b>KINI MARIE</b> (D Hirini) - Held up approaching the 600 metres gaining clear running passing the 400 metres. Lay out under pressure for the remainder and had to be continuously straightened.</p> <p><b>LIMBO STREET</b> (S McKay) - Lay inwards under pressure early in the home straight.</p>	
<b>Race 5</b>	<b>SUPERVALUE FEATHERSTON MAIDEN HIGHWEIGHT 2050 (2050 metres)</b>
<p><b>HER SON</b> (L Douglas) – Slow away. Gave ground quickly approaching the 800 metres and was not persevered with over the final stages. Rider advised the gelding had been outpaced throughout. A subsequent veterinary inspection was clear.</p> <p><b>OUR JACKSON</b> (I Lupton) – Raced keenly in the early to middle stages making the bend awkwardly near the 1700 metres.</p> <p><b>BASTILLE BABE</b> (S MacNab) – Raced in restricted room entering the home straight, bumping with PLATINUM EDITION when attempting a narrow run between runners near the 200 metres.</p> <p><b>PLATINUM EDITION</b> (D Turner) - Bumped near 200 metres.</p> <p><b>BELLA MARGARITA</b> (T Johnson) – Lay in entering the home straight having to be straightened.</p>	
<b>Race 6</b>	<b>POWER RELATED SERVICES R75 2050 (2050 metres)</b>
<p><b>CHIC</b> (S MacNab) – Slow away. Had to be restrained off heels when the pace eased near the 1700 metres and when doing so shifted outwards tightening I SUGGEST which then raced ungenerously for a short distance.</p> <p><b>I SUGGEST</b> (S MacNab) - Tightened then raced ungenerously near the 1700 metres.</p> <p><b>ZANYETTA</b> (J Parkes) - Lay inwards early in the home straight having to be straightened.</p> <p><b>JOHNNY LINCOLN</b> (R Hannam) – When questioned into performance rider could offer no excuse. A subsequent veterinary inspection revealed no obvious abnormality.</p>	
<b>Race 7</b>	<b>FRESH CHOICE GREYTOWN BUTCHERY MAIDEN HIGHWEIGHT 1600 (1600 metres)</b>
<p><b>SNUFFLEUPAGUS</b> (H Bognuda) – Slow away.</p> <p><b>NORTHERN DELIGHT</b> (I Lupton) - Raced keenly having to be restrained off heels near the 1000 metres.</p> <p><b>THE PUKETAPU LAD</b> (S MacNab) - Lay inwards bumping MISS HOI POLLOI approaching the 200 metres before being straightened.</p> <p><b>MISS HOI POLLOI</b> (B Lammas) – Bumped approaching the 200 metres.</p> <p><b>RAWHIDE</b> (T Johnson) – Checked near the 500 metres when in restricted room. T Johnson advised that his mount had commenced to roll in when weakening and had over-reacted when making contact with OUR CHARLI’S ANGEL.</p> <p><b>HAVATASTE</b> (E Farr) – Rider dismounted on pulling up. A veterinary inspection revealed lameness in the left forelimb and right hindlimb. Connections were advised a veterinary clearance is required.</p>	

<b>Race 8</b>	<b>PETE'S JOINERY AND BUILDING LIMITED R65 1600 (1600 metres)</b>
<p><b>O'CEIRINS CHOICE</b> (S Collett) – Slow away. Held up approaching the 800 metres and then angled inwards near the 600 metres to improve.</p> <p><b>PRINCESS PAMME</b> (S MacNab) and <b>WORLDCLASS</b> (R Hannam) bumped at start.</p> <p><b>WOTAMISSION</b> (S McKay) - Lay inwards near the 1000 metres contacting FRANCESCANA.</p> <p><b>FRANCESCANA</b> (J Parkes) – Contacted near 1000 metres. When questioned into performance rider had no excuse.</p>
