RACE COMMENTS:

Race 1	CHIPPERFIELD ALL ROUND EQUINE EDUCATION 1400
BELLA ROCCIA (J Fawcett) - Began awkwardly losing ground.	

LUCK OF MASTER (S Collett) – Crowded leaving the barriers. Held up rounding the final bend having to shift out passing the 200 metres to obtain clear running.

SERIOUS PATCH (A Calder) – Crowded leaving the barriers. Steadied and checked near the 1200 metres losing ground.

VAN DIAMOND (S McKay) - Began awkwardly.

AULYN DANCER (J Nason) – Began awkwardly losing ground.

T Thornton - Admitted a beach of careless riding in that she allowed TUNZAGUTZ to shift in approaching the 1200 metres when insufficiently clear of **SERIOUS PATCH** which was checked losing ground. After hearing submissions, the Judicial Committee suspended T Thornton's license to ride in races from the conclusion of racing on Saturday 23rd June up to and including Friday 29th June 2018, 4 National days.

IRENE VIVIAN (T Newman) - Late scratched at 1.06pm after refusing to enter the barrier. **IRENE VIVIAN** is required to barrier trial to the satisfaction of Stewards prior to racing next.

SECRET ANGEL (K Cowan) – Slow to begin. Raced ungenerously in the early to middle stages.

TAIMANU (J Riddell) – Became awkwardly placed on heels for a distance approaching the 400 metres.

KIPLING (D Danis) - Began awkwardly losing ground.

BABOONSKI (C Dell) – Held up for a distance approaching the 300 metres.

SHOW ME TIZ (R Elliot) - Commenced to give ground passing the 600 metres and was not preserved with over the final 300 metres. A post-race veterinary examination revealed no abnormality.

BARB DWYER (D Danis) - Raced wide in the early to middle stages.

DANCILLA (J Riddell) - Slow to begin. Raced in restricted room passing the 1600 metres to the outside of **MASTER GENIE** which shifted out when racing ungenerously. A post-race veterinary examination revealed no abnormality.

STAGEHAND (C Dell) – Slow to begin (3L).

SAKHEE'S STAR (K Cowan) - Began awkwardly.

HEAVENLY GOLD (A Sims) - Steadied passing the 1500 metres when in restricted room.

<p>HOT SAKI (E McCall) – Began awkwardly then hampered losing ground.</p> <p>IVY’S COURT (A Jones) - Began awkwardly making contact.</p> <p>YORKSHIRE DALES (J Nason) - Began awkwardly.</p> <p>CRAFTY JESS (J Riddell) – Began awkwardly.</p> <p>R Elliot - Issued with a warning after allowing STACCATO to shift in when insufficiently clear of YORKSHIRE DALES which was placed in restricted room and steadied.</p> <p>ARTISTE (M Coleman) - Rider M Coleman was unable to offer any reason for the mare’s performance. A post-race veterinary examination revealed no abnormality.</p>	
Race 8	LIVINGSTONE BUILDING NZ LTD
<p>P Coutts – Issued with a warning after presenting LOTUS LAUD to race in gear which had not been notified.</p> <p>CAMEAHOTFRIDY (A Jones) – Slow to begin. Hampered 850 metres.</p> <p>GUMBOOTS (J Fawcett) – Knuckled leaving the barrier.</p> <p>REPEAT (M Coleman) – Heavily contacted soon after leaving the barrier.</p> <p>LOTUS LAUD (E McCall) – Crowded after leaving the barrier.</p> <p>SHOWTENAIRE (K Cowan) – Began awkwardly.</p> <p>SUN GENES (V Colgan) – Unable to offer any reason for the geldings performance a post-race veterinary examination revealed no abnormality.</p> <p>CRAFTYEVA (M Cameron) - Crowded and checked near the 850 metres shifting in abruptly, making contact with CAMEAHOTFIRDAY.</p> <p>K Cowan - Admitted a beach of careless riding in that she allowed SHOWTENAIRE to shift in near the 850 metres when insufficiently clear of CRAFTYEVA which was checked. After viewing films and hearing submissions the Judicial Committee suspended K Cowan’s licence to ride at race meetings from the conclusion of racing on Wednesday 4th July until the conclusion of racing on Thursday 19th July 2018, 7 National Days.</p> <p>MILLY MOO (D Hirini) – Was found to be very unsteady when pulling up. A post-race veterinary examination revealed a very elevated heart rate. Trainer S Manning was advised that a veterinary clearance would be required prior to racing again.</p>
